EXPLANATORY NOTES

Introduction

This publication is issued each month as a supplement to the annual Catalogue of Publications and Products, Australia (1101.0) of the Australian Bureau of Statistics, which lists current ABS publications and gives brief descriptions (abstracts) of their contents. In addition, a Publications Advice (1105.0) is issued each Tuesday and Friday listing publications released on the day of issue and expected releases on the following five days (national publications) or two days (State/Territory publications).

2. A brief description of the contents of new publications, changes to existing publications and other information of interest appears at the back of this publication.

Publication prices

3. Prices include postage both within Australia and overseas (economy air).

Mailing service

- 4. Clients who wish to receive publications on a regular basis may use the ABS Publications Subscription Service.
- 5. Clients who already use this service and who wish to change their requirements should quote their client identification number when contacting ABS. The number is shown at the top left hand corner of the address label used to despatch publications to clients.

6. Renewal notices are sent to all subscribers annually in respect of the subscription year commencing on 1 January. Payment for priced publications is required in advance and should accompany renewal notices returned to ABS.

Statistical information service

- Each ABS office has an Information Consultancy service to assist clients by providing a first point of entry to the ABS. Information consultants will assist where possible or, where appropriate, refer the enquiry to a contact officer. The Information Consultancy area offers a limited free service providing information from published statistics both over the telephone and over the counter at ABS bookshops. The area also offers a fee for service information consultancy for detailed queries or provision of information from the ABS's vast unpublished data holdings. Unpublished statistics cover a variety of topics such as small area population information, imports and exports. building, tourism and detailed Consumer Price Index information, to name just a few. The area offers various dissemination options from paper reports to floppy disks and magnetic tape.
- 8. In cases where a considerable volume of data has to be specially extracted or where a regular statistical service is required, a charge will be made.

ABS PUBLISHING NEWS

New Publications Released During December 1993

1285.0 Standards for Statistics on Age and Sex, 1993

Specifies ABS standards for the collection, processing, storage and dissemination of statistics on age and sex. Topics covered include the ABS recommended definitions of concepts, classification criteria, code structures, questionnaire modules and output categories. Issues related to these standards are also discussed. This publication is intended to aid the interpretation of ABS data on age and sex and to provide advice to agencies wishing to produce data which is comparable with that of the ABS.

Working Papers in Econometrics and Applied Statistics, (93/2), XII Time Series Decomposition and Sampling Errors, December 1993

This paper demonstrates an approximate model for XII and shows how such a model can be used to analyse the effect of sample design on time series decomposition. This provides a tool to allow extensive analysis of sample design and characteristics of decomposition. The paper shows that given a model of the covariance matrix of the sample design, and making certain assumptions, standard errors can be computed on components such as trend, seasonal and residual at all time points, and the proportion of variance due to sampling error can be estimated.

Presents a brief outline of the general concepts and practices involved in the Australian balance of payments. It is a useful guide for those who require a basic explanation of the data sources, methods and uses of balance of payments statistics. Highly recommended for those in secondary and tertiary education and others including business managers.
