- Projects the number of households and families in Australia by State and capital city / balance of State for period 1996–2051. Describes the method and assumptions used to produce these projections.

- Presents data for the following mining operations variables in Australia: number of management units and establishments; employment at end of June; income and expenditure; value of turnover; trading profit; operating profit before tax; industry value added; assets and liabilities and net capital expenditure.

- Contains detailed information on Optometry and Optical Dispensing businesses in Australia.
