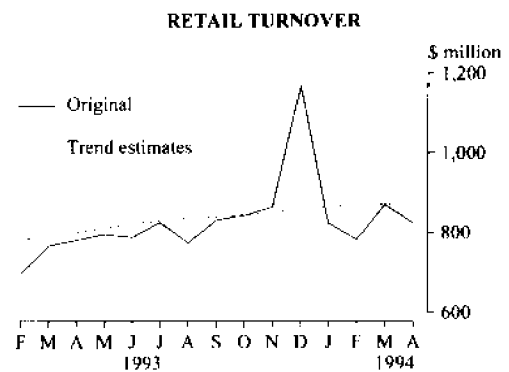

Retail (page 16)

Estimated turnover of Western Australian retail establishments during April 1994 was \$824.6 million (at current prices), a decrease of 5.4 per cent from the previous month. The trend estimates show no change from the previous month.

The trend estimates indicate a national annual growth rate of 5.7 per cent from April 1993 to April 1994. The annual growth rate for Western Australia for the same period was 9.0 percent.

The national trend estimates show increases of 0.6, 0.5 and 0.3 per cent for the months of February, March and April 1994. For the same three months Western Australia recorded increases of 0.5, 0.2 and 0.0 per cent.

Seasonally adjusted and trend estimates

Seasonal adjustment is a means of removing the estimated effects of normal seasonal variation from the series so that the effects of other influences can be more easily recognised.

In the seasonal adjustment of the turnover estimates, account has been taken of both normal seasonal factors and "trading day" effects (arising from the varying length of each month and the varying numbers of Sundays, Mondays, Tuesdays, etc. in the month). Seasonal adjustment does not remove from the series the effect of irregular influences (e.g. abnormal weather, industrial disputes) and the seasonally adjusted estimates still reflect the sampling and non-sampling errors to which the original estimates are subject.

The smoothing of seasonally adjusted series to create trend estimates is a means of reducing the impact of the irregular component of the series. The trend estimates are derived by applying a 13-term Henderson-weighted moving average to the respective seasonally adjusted series. These trend series are used to analyse the underlying behaviour of the series over time.

While the smoothing technique enables estimates of trend to be produced for the latest month, it does result in revisions to the estimates for the most recent months as data for subsequent months become available. Generally subsequent revisions become smaller and after 3 months have a negligible impact on the series.
