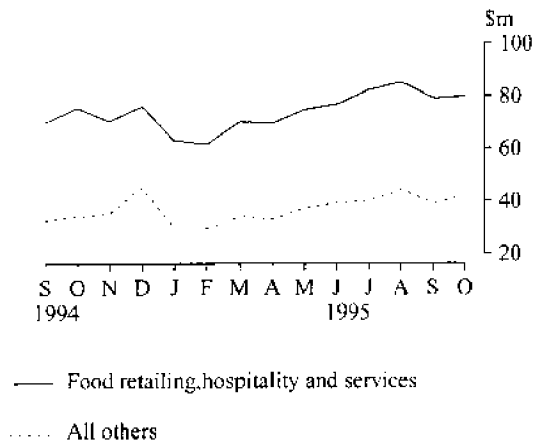

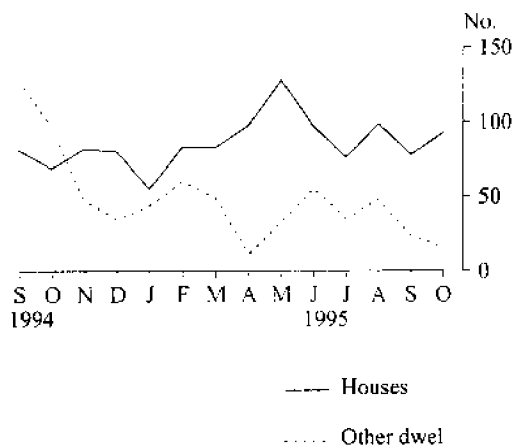
TURNOVER OF RETAIL ESTABLISHMENTS



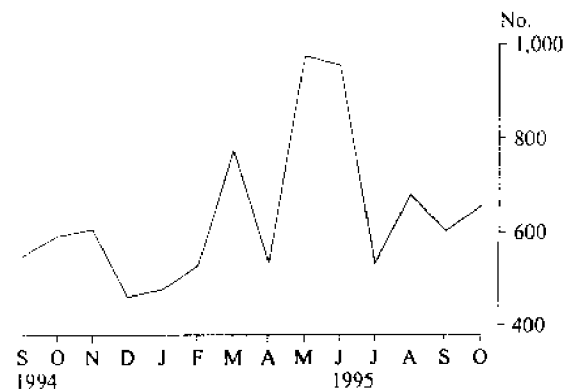
LABOUR FORCE
