1. Introduction

The Australian Bureau of Statistics (ABS) liaised extensively with major users of census data during the planning of the 1986 Census output program. As a result, the majority of requests for census data should be satisfied by the extensive range of planned standard census output products contained in statistical publications, and on microfiche and magnetic tape. Information on these products can be found in the information papers:

- *Census 86—Data Release Plans* (2173.0)
- *Catalogue of 1986 Census Tables* (2175.0)
- *Census 86—Standard Tables on Magnetic Tape* (2186.0)

Users are strongly advised to obtain a copy of *The 1986 Census Dictionary* (2174.0), which explains many census concepts and brings out points which may not be readily apparent in other information papers.

For users whose needs are not satisfied by standard output products, the ABS offers a range of special data services:

- cross-classified tabulation service;
- small area inquiry service; and
- advice on services offered by commercial organisations.

2. ABS resources

The ABS has limited resources to operate the special data service; requests for these services therefore require strong justification. In particular, users who are entitled to free services from the ABS need to have requests approved and justified on a cost basis by a senior executive in their organisation.

3. Price of special data services

Information on the current cost of a particular service can be obtained from the nearest ABS office (see Appendix E for addresses and telephone numbers).

4. Confidentiality

The extent of detail in ABS statistical output is constrained by the need to avoid the release of identifiable information. The level and detail of variables provided in a tabulation are dependent on the population of the geographic areas. Therefore, the smaller the population of an area, the less detail is available.

Application of small random adjustments to cells containing small data counts is another method used to preserve confidentiality of census data. Users should not rely on data cells containing counts of 3 or less.

5. Order forms

Order forms for special data services are included at Appendix G of this publication. These order forms, or copies of them, should be used when requesting special data services. Additional forms can be obtained from any ABS office (see Appendix E for addresses and telephone numbers).

6. Cross-classified tabulation service

Cross-classified tables are produced from the census final unit record file (FURF). They contain two or more related variables in tabular form. The geographic areas are usually large areas such as statistical regions (SRs) or States. Limited detail, however, can be provided for smaller areas such as legal local government areas (LGAs) or statistical local areas (SLAs).

An extensive range of standard cross-classified tables is available. A listing of these tables is provided in the *Catalogue of 1986 Census Tables* (2175.0). Please ensure you check this catalogue before requesting special tabulations. Note that reference to the catalogue is necessary when completing order forms PC86/9 (Specification form for a cross-classified table) or PC86/10 (Reclassification request).

The ABS releases census unit record sample files which are most useful for producing a wide range of cross-classified tabulations for large geographic areas. You should consider using these files to produce your own tables. For more information on census unit record sample files see *Census 86—Sample Files on Magnetic Tape* (2184.0).

Requests for State specific tabulations are handled by the relevant ABS State office or the Northern Territory office. All other inquiries should be directed to ABS Central Office, Canberra.

Output for cross-classified tables is generally available on microfiche or magnetic tape. Computer printout is available for small tables of less than approximately 100 pages.

All orders are queued and will be dealt with in order of receipt, unless very strong justification is provided for urgent requests. Servicing time for an individual order will depend on available ABS resources, the length of the queue, the nature of the request, and the geographic area involved.

Due to the tailored nature of this service, costs of meeting requests may vary considerably. Users are advised to contact the ABS for a quote regarding their order. Users entitled to free services from the ABS should still obtain a quote in order that cost justification can be provided to the ABS.

7. Small area inquiry service

A vast amount of data are available from the small area data bases held by the ABS. Data are available for standard geographic areas (see Appendix A) on microfiche, magnetic tape and in printed form.

Users with access to a computer and requiring data for non-standard areas, such as planning regions, school or business catchment areas, or television viewing areas, can produce their own tables from one of the small area summary files available from the ABS. For more information on small area summary files see *Census 86—Standard Tables on Magnetic Tape* (2186.0). Alternatively, information from the small area data bases can be requested from the ABS, or one of the many commercial secondary distributors of census data can be contacted.

Servicing time for the small area inquiry service may be anything from a few hours to several weeks, depending on the nature of the inquiry and the number of requests in the queue.

The small area data are stored in tabular form on two data bases according to the two conceptual bases of census counts:

- census count at place of enumeration (C)
- census count at place of usual residence (U)

(a) Collection District Summary Data Base (CDSDB)

Counts from this data base are based on the census count at place of enumeration (C). Each record on the data base contains 70 tables for each *collection district* (CD). These tables are described as the 21 page (CSD) format (see Appendix C).

CD records from this data base can be aggregated to form non-standard areas. The non-standard areas must be able to be defined by two or more CDs, or combinations of other standard ABS areas, such as SLAs.

Reference to census field maps or CD outline maps will be necessary to define non-standard areas. These are available at all ABS offices. For more information refer to *Census 86—Maps* (2183.0).

Output based on the census count at place of enumeration can be requested in four different formats:

Provided that confidentiality rules are followed, users can request any format for the total area, and the same, or a different format for each component CD. For example, the 21 page CSD format may be requested for the total area and the 1 page CSA format may be requested for the component CDs. If the user provides a name for the total area, this name will appear in the table title.

Additionally, users can request only certain pages of a particular format. For example, if the only data required were for details on labour force characteristics, pages 11 to 16 of the 21 page CSD format would be all that is required.

Output can be provided on computer printout and microfiche. The CSC and CSD formats are also available on magnetic tape. (Floppy disks are not yet available from the ABS.) Choropleth maps (see Section 8) are also available.

A particular feature of the small area inquiry service is the production of radial distance counts. For example, a user may request data for whole CDs which lie within any given radius from the geographic centre (centroid) of a CD, or any other geographic point.

(b) Usual Residence Summary Data Base (URSDB)

Counts on this data base are based on place of usual residence (U). Each record contains 37 tables for each *statistical local area* (SLA) as described in the 12 page USH format (see Appendix C).

Facilities available from this data base are similar to those for the CDSDB except that:

- component areas are SLAs, therefore the area of interest must be able to be defined by aggregating SLAs; and
- no household or family data are available on a usual residence basis.

Outputs may be requested in four different formats:

Output will be available on computer printout and microfiche. The USG and USH formats are also available on magnetic tape.

8. Choropleth maps

Choropleth maps can be produced by the small area inquiry system. A choropleth map provides a graphic representation of data for selected geographic areas. A map can only show one variable for a given population. This variable can be a simple count of persons or dwellings with particular characteristics, or a percentage, or other derivation. The variable is presented by displaying

the various class intervals (i.e. data ranges) using different colours or cross-hatching patterns. For example, the percentage of people aged 60 years and over, enumerated in a particular LGA, could be mapped for each CD in the LGA. Each CD would be filled with a particular pattern or colour; red may indicate the class interval 0-25% of the population aged 60 years and over, green 26-50%, yellow 51-75%, and blue 76-100%.

Any of the data cells on the 21 page (CSD) or 12 page (USF) formats (see Appendix C), aggregations of these cells, or percentages, etc. can be mapped.

The maps may be produced in high quality black and white, medium quality colour or black and white prints, at different prices. An example of each map is provided in Appendix B.

Choropleth maps may be ordered through any office of the ABS (see Appendix E for addresses and telephone numbers). Instructions and information to assist you in ordering these maps are provided on the order form (PC86/12) in Appendix F.

9. Previous census data

Data are available for all censuses since 1911, and statistics can be clerically extracted on request. No order forms are provided for this service.

Special cross-classified tables can be produced on magnetic tape and microfiche for the 1976 and 1981 Censuses (or computer printout if less than approximately 100 pages). For the 1981 Census only, tables can be produced on either the basis of place of enumeration or place of usual residence.

Small area inquiries, including choropleth maps, can be serviced only for the 1981 Census. Note that no usual residence based data are available, and output formats differ from those for the 1986 Census.

A range of printed publications from all censuses is held by the ABS. While it is unlikely that copies of very early census publications will be available for purchase, the publications may be viewed on request.

Orders for data from previous censuses will be placed in a queue, but processing priority will usually be given to requests for 1986 Census data.

10. Commercial data services

The ABS maintains a list of commercial organisations (secondary distributors) who collectively offer an extensive range of statistical and computing services using census data.

Services include data analysis, graphic and mapping facilities, computer programming, provision of software, and data on floppy disks.

The ABS can provide a list of such organisations free of charge, but inquiries regarding details of services must be directed to the organisations concerned.

For further information concerning commercial organisations, please contact the Information Services Section of the ABS (see Appendix E for addresses and telephone numbers).

11. Floppy disks

The ABS is planning to release census data on floppy disk at some stage in the future. In the meantime, some commercial organisations do provide this service (see Section 10).

12. VIATEL (Teletext)

VIATEL is a public videotext system set up by Telecom. This system is a means of alerting users to the range of outputs and services provided by the ABS. It will provide VIATEL users with information on the release of census output products, and will also include some basic tables of census statistics.

13. AUSSTATS

This is a time series data base management system, which also has facilities for storing non-time series data. The Commonwealth Scientific and Industrial Research Organisation has installed AUSSTATS on its national computer network, CSIRONET. The ABS is utilising this development to store statistics for ready access by users. Currently, however, no census data are stored.

15. Related publications

APPENDIX A

CENSUS GEOGRAPHIC AREAS—DEFINITIONS

A. Australian Standard Geographical Classification (ASGC)

The *Australian Standard Geographical Classification* (1216.0) is a new geographic classification used for the dissemination of 1986 Census data. It incorporates a number of hierarchic structures of geographic areas (also referred to as 'spatial units') and defines the individual structures and the area types of which each structure is composed. Each geographic area in the classification is identified by a unique numeric code.

The ASGC has been adopted as the standard geographic classification for ABS output. This will ensure greater comparability of statistics within the ABS and a standardisation of terminology.

Abbreviated definitions of the ASGC geographic areas which are used in 1986 Census output follow below. More detailed definitions can be found in *The 1986 Census Dictionary* (2174.0) or *Census 86-Australian Standard Geographical Classification: Geographic Code List* (2188.0).

Census collection districts (CDs)

These are the smallest type of geographic area in the ASGC and are the building blocks of which all other ASGC geographic areas are composed. They have been designed for use in population censuses and, in aggregate, cover the whole of Australia without gaps or overlaps.

Statistical local areas (SLAs)

These consist of one or more CDs and are local government area (i.e. legal LGA) based or equivalent geographic areas. They cover, in aggregate, the whole of Australia without gaps or overlaps.

Statistical subdivisions (SSDs)

These consist of one or more SLAs and cover, in aggregate, the whole of Australia without gaps or overlaps. They are used as an intermediate level, general purpose regional type geographic area.

Statistical divisions (SDs)

These consist of one or more SSDs and cover, in aggregate, the whole of Australia without gaps or overlaps. They are used as a large, general purpose regional type geographic area.

States and Territories (S/Ts)

These consist of two or more SDs and cover the whole of Australia (as defined for statistical purposes) without gaps or overlaps. They encompass the geographic areas of the six Australian States and two mainland Territories.

Statistical districts (S DISTs)

These consist of one or more SSDs and represent large urban areas of Australia outside State capital city SDs. Because of their nature they can and, in some cases, do straddle SD and S/T boundaries. An example is the Gold Coast-Tweed Statistical District which encompasses an urban area which lies partly in the State of Queensland and partly in the State of New South Wales.

Legal local government areas (legal LGAs)

These consist of one or more SLAs and are the geographical areas of incorporated local government councils, such as towns and shires. In aggregate, these cover only part of Australia. (The major areas of Australia not governed by incorporated local government councils include the northern parts of South Australia, most of the Northern Territory and all of the Australian Capital Territory.) Legal LGAs can and, sometimes, do straddle SSD, S DIST and SD boundaries. An example is Tweed Shire in New South Wales. The predominantly urban part of this Shire is treated as an SLA as well as an SSD in its own right and constitutes the New South Wales part of the Gold Coast-Tweed Statistical District. The predominantly rural remainder of this Shire constitutes a separate SLA outside the Gold Coast-Tweed Statistical District and lies within a different SSD.

Statistical regions (SRs)

These consist of one or more SLAs and cover, in aggregate, the whole of Australia without gaps or overlaps. They were designed primarily as geographic areas containing sufficient population to be suitable for the presentation of both population census and labour force statistics within the frameworks for standard statistical outputs from these collections. The smallest region, in terms of population, is the Northern Territory which is expected to have a population of around 147,000 at the time of the 1986 Census.

Major statistical regions (MSRs)

These consist of one or more SRs and cover, in aggregate, the whole of Australia without gaps or overlaps. They do not cross State or Territory boundaries and serve the same purpose as SRs, though at a broader geographic (i.e. Capital City SD versus Balance of State) level. (However, even this dissection could not, due to population size limitations, be implemented in the case of Tasmania, the Northern Territory and the Australian Capital Territory, each of which equates with an MSR.)

Urban centres and (rural) localities (UC/Ls)

These consist of one or more adjoining whole CDs with urban characteristics and represents, in the case of rural localities, population clusters of between 200 and 999 people and, in the case of urban centres, population clusters of 1,000 or more people (including known holiday resorts of smaller size). Because of their nature they can and, sometimes, do straddle SLA, legal LGA, SSD and other ASGC geographic area boundaries.

Section of State

Within a State or Territory, each section of State represents an aggregation of non-contiguous geographic areas of a particular urban type, with the rural balance constituting another section of State. The sections of State within each State and Territory are the following:

- Major Urban—all urban centres with a population of 100,000 and over;
- Other Urban—all urban centres with a population of 1,000 to 99,999 and known holiday resorts of less population if they contain 250 or more dwellings of which at least 100 are occupied on census night;
- Locality—all population clusters of 200 to 999 persons; and
- Rural Balance—the remainder of the State/Territory.

The above section of State categories can be used in conjunction with other CD-based ASGC geographic areas to show section of State components within, say, statistical subdivisions or statistical divisions.

In addition to the above section of State categories, persons who were enumerated on off-shore oil rigs, drilling platforms and the like, aboard ship in Australian waters, or on an overnight journey by train or bus were included in an additional category, Off-Shore Areas and Migratory. There is one such category for each State and the Northern Territory.

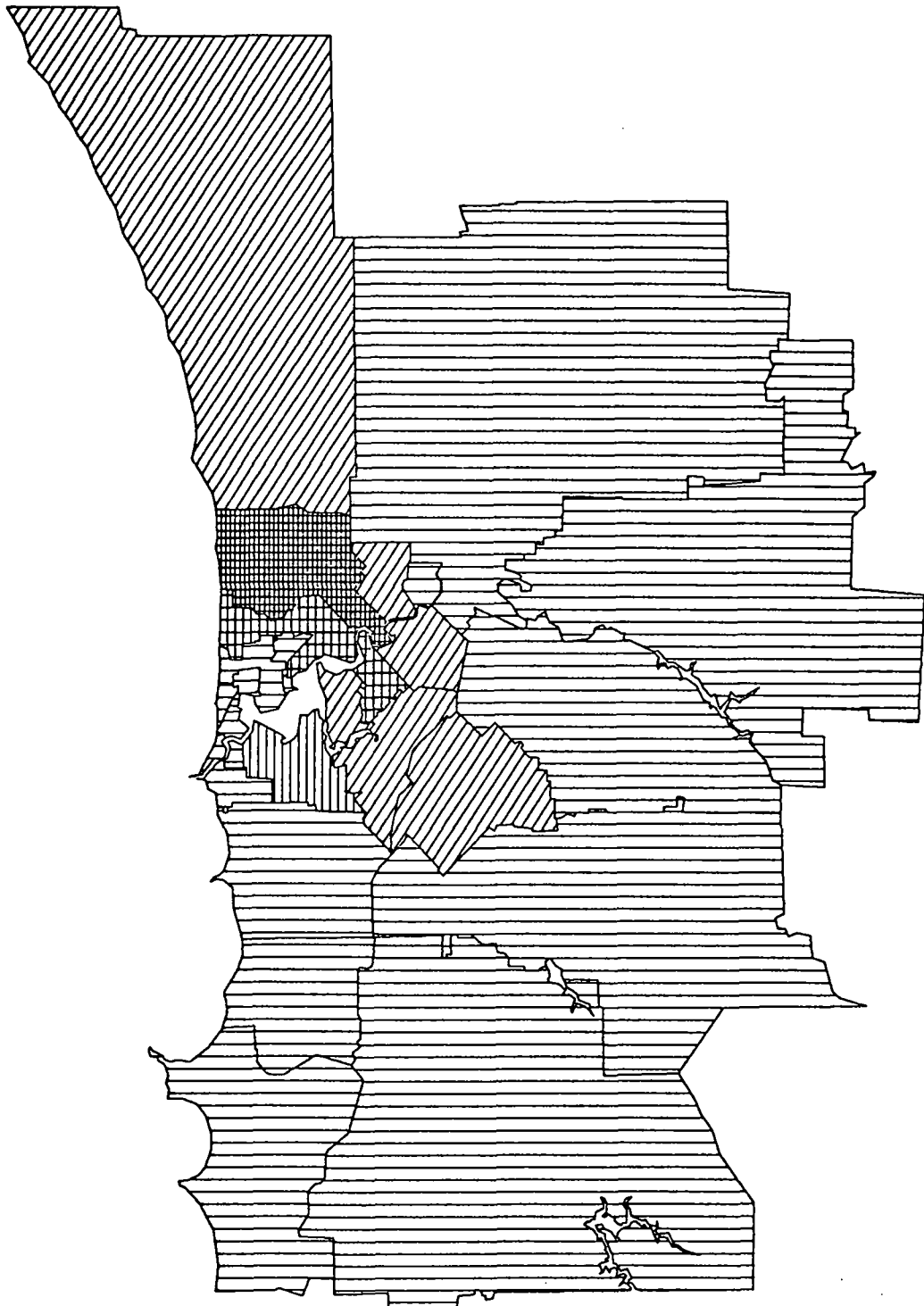
B. Other Non-ASGC Areas

Census data are also available for Commonwealth and State electoral divisions and postcode areas.

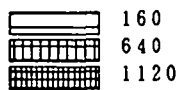

LEGEND: MIDPOINT

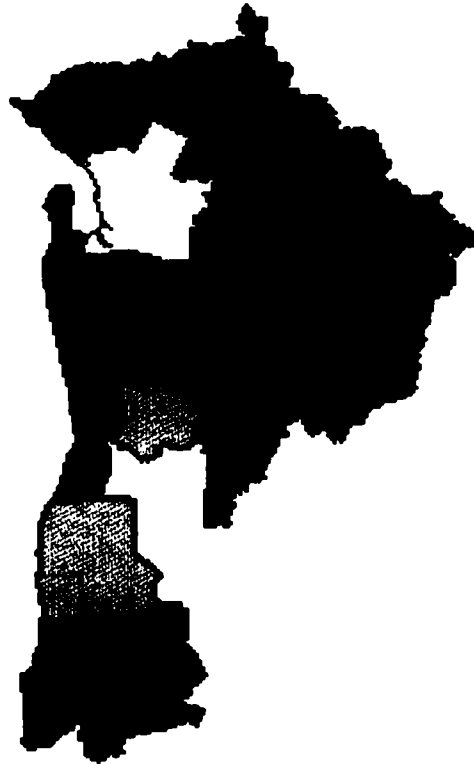


THIS MAP SHOWS THE NUMBER OF PERSONS WITH DOCTORATES

POPULATION



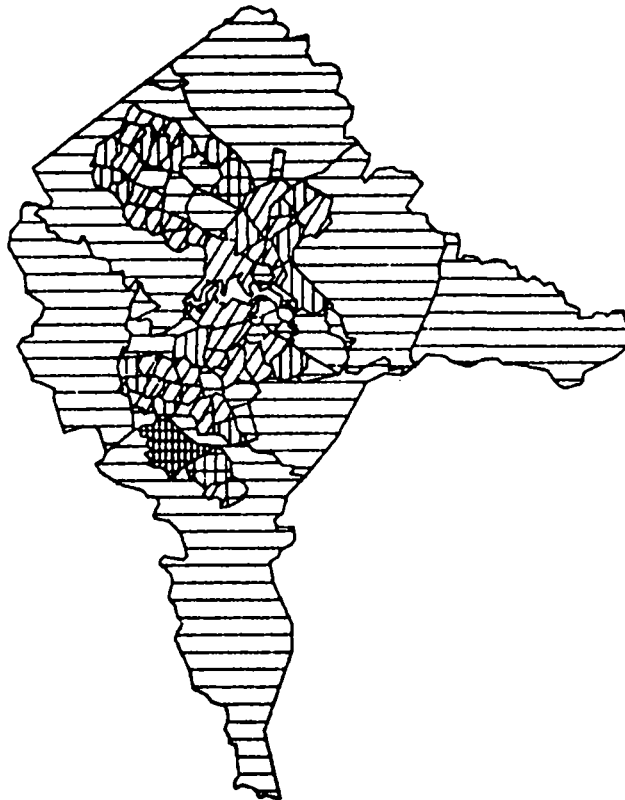

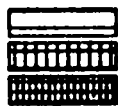

APPENDIX D

MAGNETIC TAPE VOLUME AND DATA SET LABELS

Section A — FACOM Standard Labels (same as IBM)

Each label is one 80-byte record containing various attributes of the data set or reel. EBCDIC code is used.

There are five kinds of labels, as shown in Figure A.1.

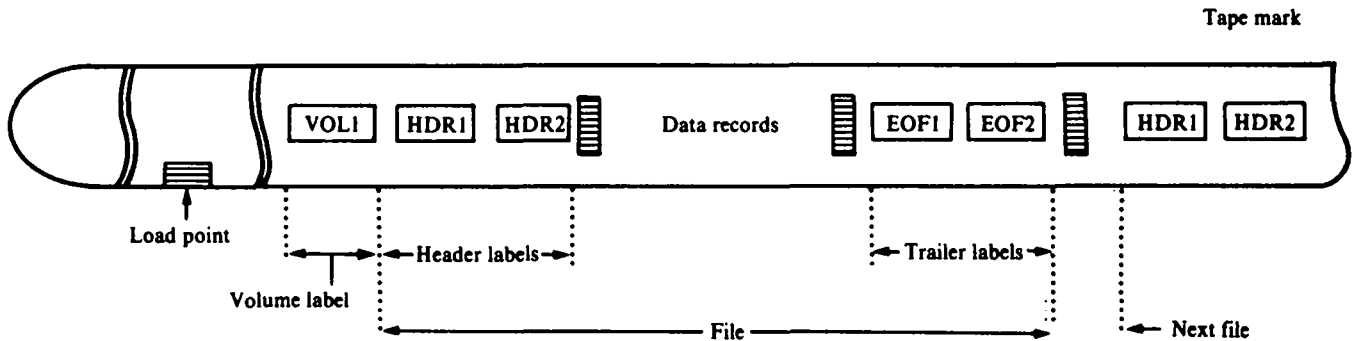


Figure A.1 FACOM standard labels (same as IBM)

Volume label—

One volume label exists as the first block on each reel. This label contains the volume serial number (VSN), owner name, and other data pertinent to this reel. A volume label is characterised by its first four characters: VOL1.

Header labels—

Two header labels are written at the front of each file: header label 1 (HDR1) and (HDR2). The former contains an identification of this file, the latter contains various attributes.

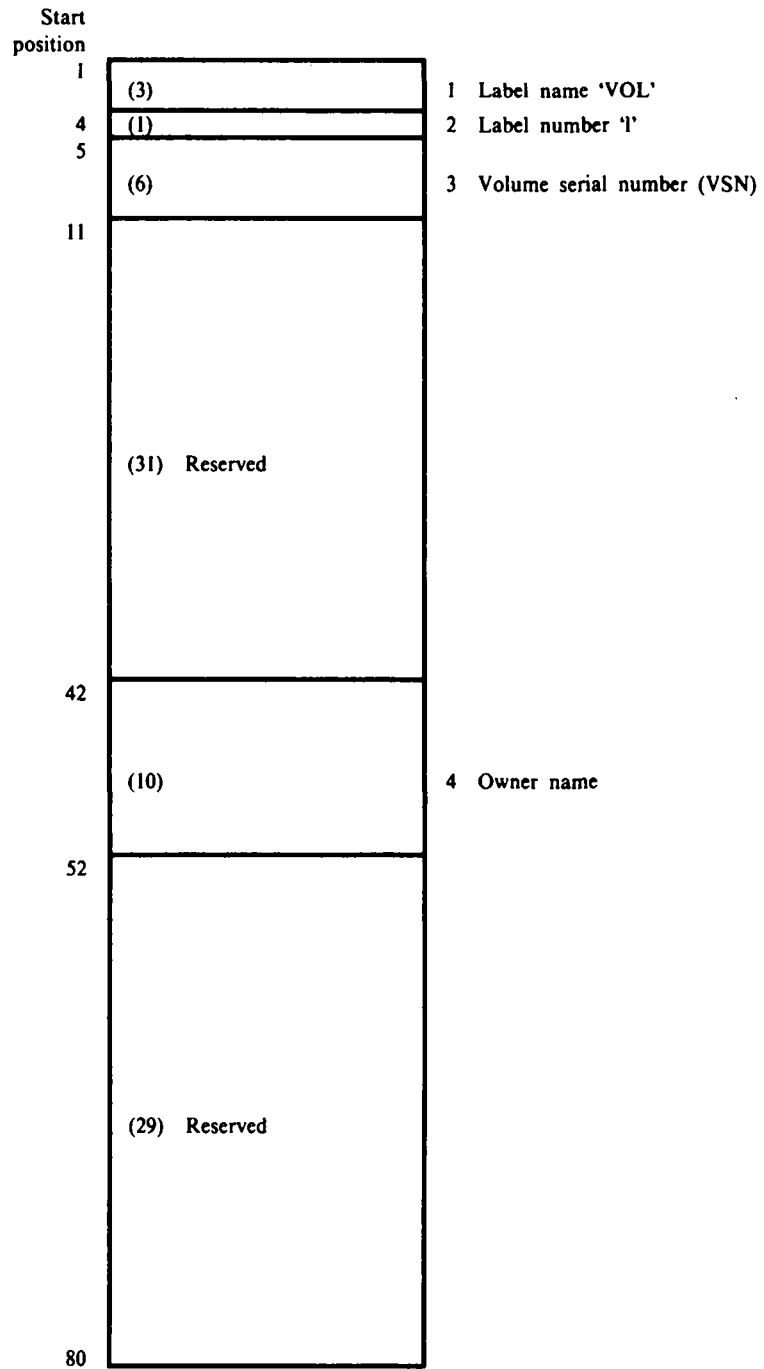
Trailer labels—

Two trailer labels are written at the end of each file: trailer label 1 (EOF1) and trailer label 2 (EOF2). As can be seen from Figure A.1, header and trailer labels are paired for each file on the volume. Trailer labels are quite similar to header labels since reel processing does not always start from the front of a file, for example when reading backwards.

Standard volume label format:

Refer to Figure A.2

1. *Label name:* Indicates that the label is a volume label: always 'VOL'.
2. *Label number:* This is the sequence number of the volume label. There is only one volume label for a standard label reel: hence, its sequence number is always '1'.
3. *Volume serial number (VSN):* One to six EBCDIC characters. Used to cite a specific volume. Externally readable label on the reel should agree with this serial number for operating convenience.
4. *Owner name:* Arbitrary identifier of up to ten EBCDIC characters.

1. *Label name:* There are the following two kinds of label names:

- 'HDR' Header label
- 'EOF' Trailer label (end of data set).

2. *Label number:* Sequence number of this label; always '1' in this case.

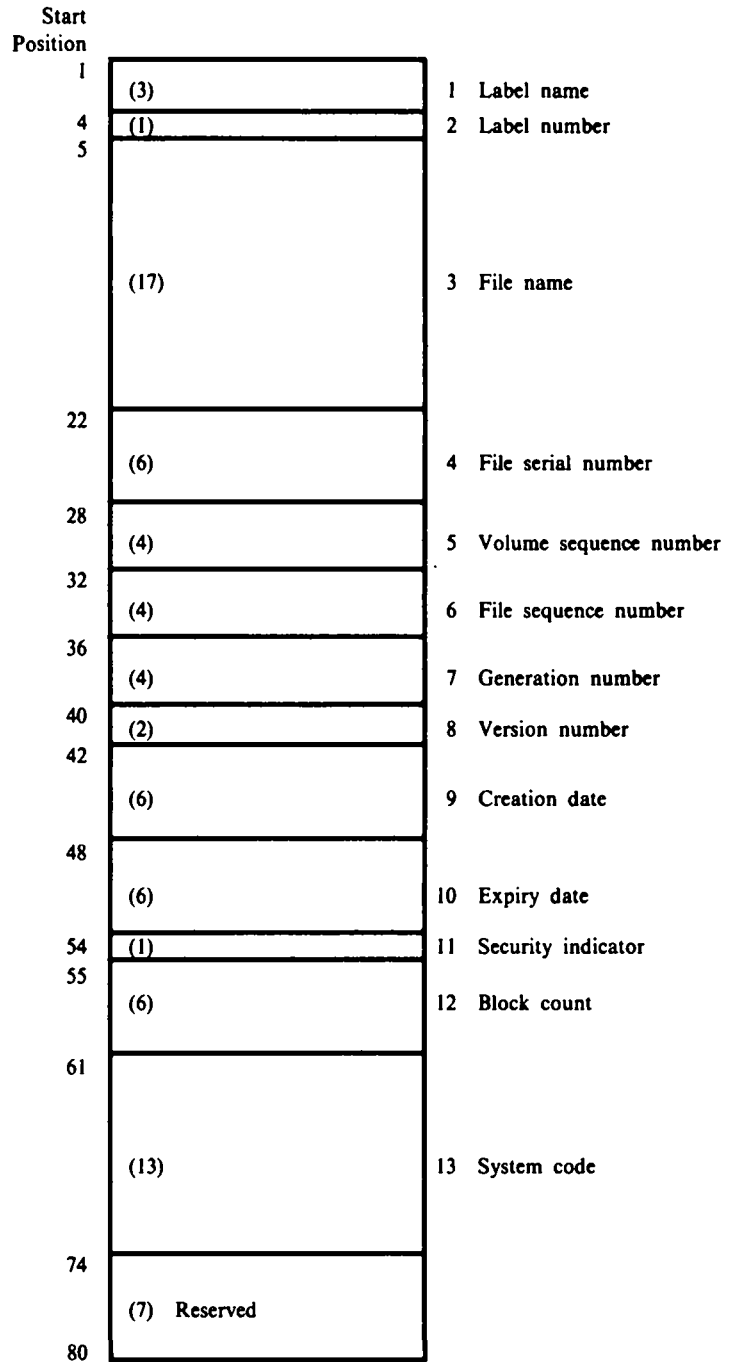


Figure A.3 First standard header or trailer label for a file

3. *File name*: Seventeen character left justified data set name. When less than seventeen characters, padded on right with blanks.
4. *File serial number*: Serial number of first volume on which this data exists.
5. *Volume sequence number*: Sequence number for a data set on one or more volumes. Volume sequence number is always '0001' for a single volume.
6. *File sequence number*: Relative position of each data set on the volume ranges through (0001-9999). This is relative to the first volume.
7. *Generation number*: Blank.
8. *Version number*: Blank.
9. *Creation date*: Indicates year and day the data set was created:

byydd	b	Blank
	yy	Last two digits of the calendar year (00-99)
	ddd	Day in the year (001-366)
10. *Expiry date*: Indicates year and date until which the data set is protected from deletion. Same format as the creation date. Field is character '0' if not specified, and the protection interval is null.
11. *Security indicator*: Set to '0' (unprotected).
12. *Block count*: Total number of data blocks in the data set. Stored in the trailer label (EOF1 or EOVI); always '0' in the header label (HDR1).
13. *System code*: Identifier for system that created the data set. Always 'FACOM OSIV/F4' (13 bytes) for reels created on this operating system.

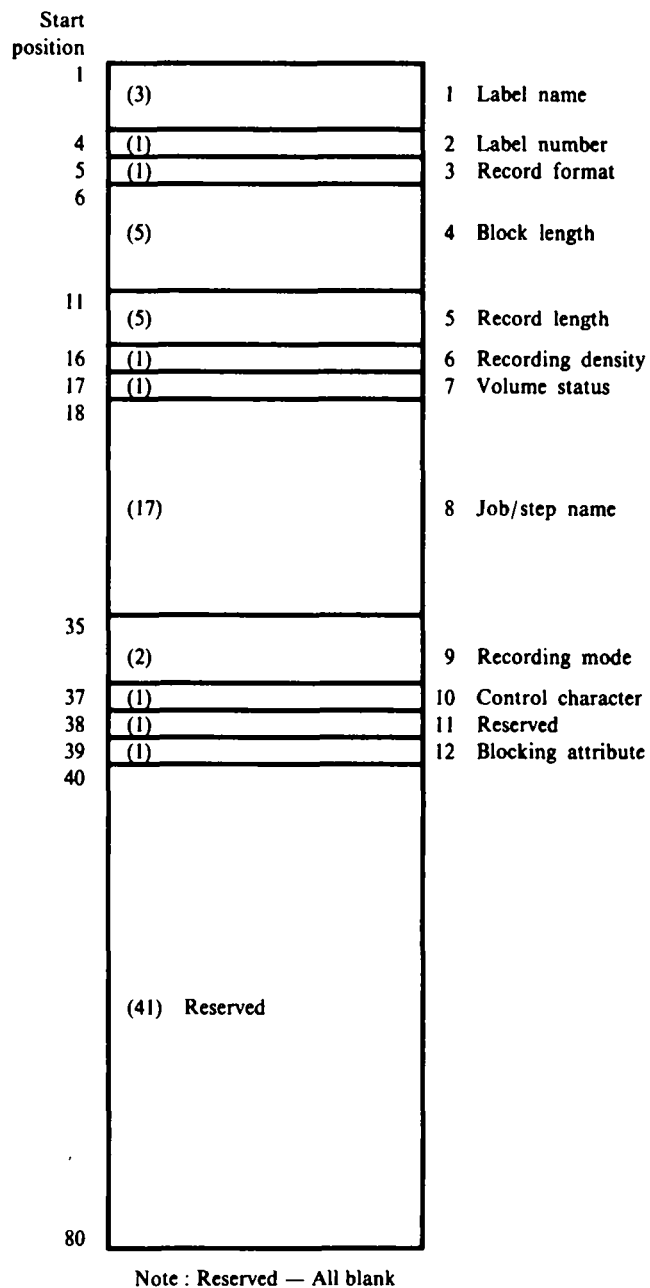


Figure A.4 Second standard header or trailer label for a file

8. *Job and step names:* Job name (eight characters) and step name (eight characters) delimited by '/' when the data set was created.

9. *Recording mode:* Blank.

10. *Control character:*

11. *Unused field (blanks)*

12. *Blocking attribute:*

- B Blocked records
- S Spanned records
- R Blocked spanned records

Section B — Australian Standard Labels (ANSI)

ANSI labels have basically the same format as FACOM standard labels. There are some differences in positions of fields in VOL1 and HDR1. HDR3 and subsequent header labels are not used. All ANSI labels and data are recorded in ASCII code at a recording density of 63 RPmm (1600 BPI) or 246 RPmm (6250 BPI).

ANSI volume label format:

Refer to Figure A.5

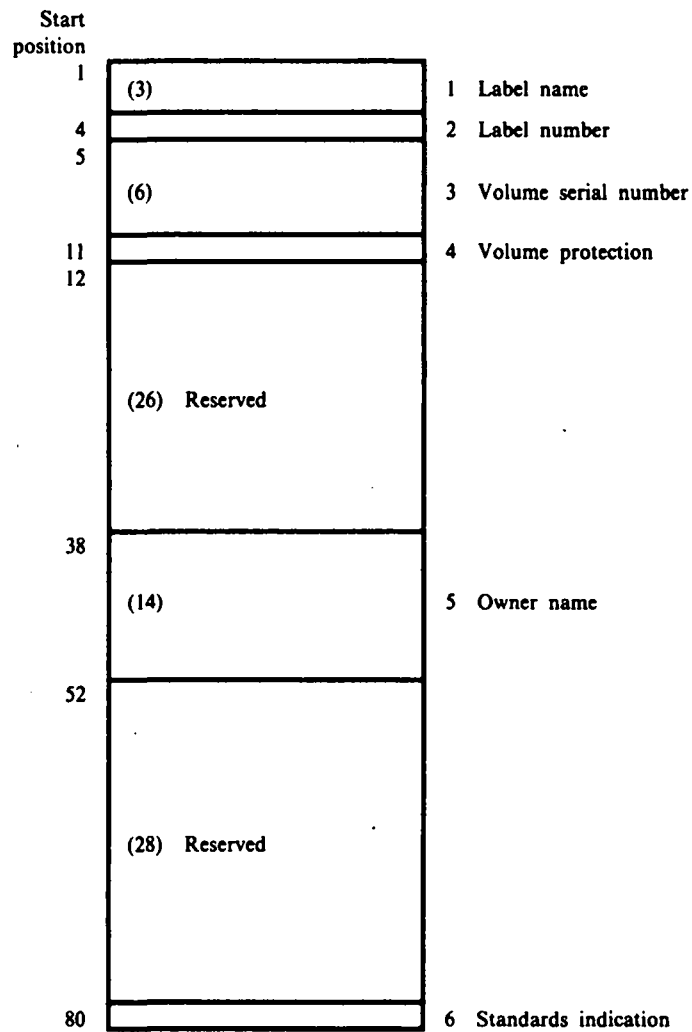


Figure A.5 ANSI volume label

1. ***Label name:*** Indicates that the label is a volume label. Always 'VOL'.
2. ***Label number:*** Sequence number of the volume label. There is only one volume label for an ANSI standard-label reel; hence, its sequence number is always '1'.
3. ***Volume serial number:*** One to six ANSI characters. Used to cite a specific volume.
4. ***Volume protection:*** This field is an ANSI 'space' character.
5. ***Owner name:*** Arbitrary name of at most 14 ANSI characters. This field is left blank if no owner name was specified when the file was created.
6. ***Standards indication:*** This field is set to '1'.

ANSI format for the first header and trailer labels for a file:

Refer to Figure A.6. The contents of the fields (1)-(13) in figure A.6 are the same as those of the FACOM standard label (Figure A.3) except for field (11), 'Security indicator'.

APPENDIX F

**Instructions and examples for completing
order forms for special data services**

Example of a completed specification form for a cross-classified table

A table is required which shows occupation, birthplace, age and sex of the employed population usually residing in statistical regions in New South Wales. Totals are also required for the Sydney Statistical Division and the rest of the State.

5. Confidentiality is an issue to be considered when designing a table. A check at a broad level can be done by performing the following calculation:

- (a) Multiply all the figures in column 3 in Section 4, above:

$$10 \times 4 \times 5 \times 3 = \underline{600} \text{ (x)}$$

- (b) Take the average population size of the smallest geographic area = 150,000 (y)

(c) $(y) \div (x) = \frac{(y) \ 150,000}{(x) \ 600} = \underline{250} \text{ (z)}$

The table is acceptable because the average cell size (z) is 250.

Instructions for completing a reclassification request (order form PC86/10)

This form is to be completed *only* when the grouping of items you require for a particular characteristic is not listed in Section 5 of the *Catalogue of 1986 Census Tables* (2175.0). The specifications of grouping for the new classification should include all the original classification codes to avoid ambiguity. If necessary, include a 'not applicable' item which contains all the codes not wanted in the tabulation.

Example of a completed reclassification request

A grouping of the classification birthplace (BPL) is required as follows: Australia, Italy, Other, Total. A check of Section 5 of edition 1 of the catalogue shows this grouping is not already available.

Mnemonic: BPL* (This should also have been entered in the Mnemonic column of form PC86/9.)

Instructions for requesting information from the small area data base (order form PC86/11)

The section numbers shown below correspond with section numbers on the order form. (See example of completed form below; a blank order form is included in Appendix G.)

1,2. The first step is to specify the geographic area of interest. This would usually be a non-standard ABS area (because there are plenty of data available for standard areas). Examples of these areas are:

- a circular area of a certain radius from a given point, such as a school catchment area, TV viewing area, etc;
- part of a legal LGA; and
- a group of four postcodes.

Reference to census maps would usually be necessary to define the area. Maps are available from any ABS office (see Appendix E for addresses and telephone numbers).

Enter a suitable name for the area of interest in Section 1 of the form. This will appear as a heading on the first page of the output for the total area. Enter a definition of the area, in terms of CDs, SLAs, postcodes etc, in Section 2 of the form.

3. The next step is to decide on which basis the data are to be provided: place of enumeration, or place of usual residence.

Place of enumeration

The smallest area available on this basis is the CD. More precise non-standard areas can therefore be defined, but they must contain whole CDs. By default, they *can* contain whole SLAs or whole postcodes as well. An area of interest may include, for example, a whole SLA, two postcode areas, and four CDs; it could be defined this way, or by identifying and listing all the CDs in the area.

Place of usual residence

The smallest geographic level available on this basis is the SLA. Therefore, any non-standard area for which data on this basis are required must be defined in terms of SLAs. Parts of SLAs cannot be included or excluded. The radial distance option cannot be used with this basis.

4. You should then consider whether you want the data shown in map form (see order form PC86/12) or tabular output. If tabular output is required then selecting the output medium is quite simple. Small outputs (say, less than 100 pages) can quite reasonably be requested on computer printout. For larger outputs, microfiche, or even magnetic tape should be considered for reasons of both convenience and cost. Note that a single microfiche can contain the equivalent of 269 pages of computer printout.

5. Before looking at what output formats are required it is necessary to decide the following:

- (i) Is information required for the total geographic area of interest? (Normally yes.)

- (ii) Is information required for each of the component CDs (or SLAs if on the basis of place of usual residence)? Care should be taken here, as very large amounts of output can be generated using this option.
- (iii) Are subtotals for standard areas within the total area required? For example, for an area defined by CDs, you may want totals for SLAs or postcodes. Note that if part of such an SLA or postcode lies outside the total area defined, only that component within the defined area is supplied.

Mnemonics of geographic areas for subtotals (Section 5 above) and sort order (Section 7 below) of the component areas on the order form are:

SLA	Statistical local area
SSD	Statistical subdivision
SD	Statistical division
S/T	State/Territory
LGA	Legal local government area
SR	Statistical region
MSR	Major statistical region
UC/L	Urban centre/(rural) locality
CED	Commonwealth electoral division
SED	State electoral division
POC	Postcode

6. Next, you need to choose suitable tabular formats for up to three different selected geographic levels (covered in Section 5 above). Normally, you would select a detailed format for the total areas and subtotals, and a less detailed format for the component areas.

All the available formats are in Appendix C. You will notice that formats for data on the basis of *place of enumeration* are called CSA, CSB, CSC and CSD. Formats for data on the basis of *place of usual residence* are called USE, USF, USG and USH. The 'C' and 'U' formats cannot be mixed in one inquiry.

A paper saving option here is that you may select only certain pages of a particular format. For example you may only require the labour force tables of format CSC, so you would specify only page 5 rather than all seven pages.

7. The sort order is only relevant if you have asked for component CDs (or SLAs) and for subtotals. CDs will appear in the specified order. If subtotals are requested, the sort order must be such that CDs (or SLAs) are placed in an appropriate order for correct subtotalling. You would not, for example, request subtotals for postcodes, and specify a sort order of SLA as the resulting totals would be meaningless.

For most inquiries enter the mnemonic of the largest geographic level first (e.g. STE), followed by the second largest level (e.g. STD), etc. (See section 5 above for a list of mnemonics.) Mnemonics can be entered in any order if necessary.

The default sort order for CDs is the CD field code order (State, *census* division, *census* subdivision, collection district); SLAs are sorted by SLA code (alphabetical order).

Three examples of completed forms requesting information from the small area data base

Example 1: Inquiry for the area which encompasses all collection districts within a 10km radius of Smithville School is required on computer printout, based on the census count at place of enumeration. No subtotals or component CDs are required. The 21 page CSD format is required.

The order form PC86/11 would be completed as follows:

- Name of geographic area of interest (used as a page heading):

Line 2:	Catchment Area

Note: If the latitude and longitude of the school was not known, then the actual CD which contains the school could have been nominated, in which case the geographic centre (centroid) of the CD would have been used as the radial centre. Latitude and longitude for relatively small areas should (when used) be expressed to at least 3 places of decimals (roughly 100 m) if possible.

- OR*
- census count at place of usual residence

Instructions for completing order form for choropleth map (order form PC86/12)

A separate form should be completed for each choropleth map required.

1. A summary of exactly what is required should be given.
2. Select an appropriate title for the map. It is best to keep the first line fairly short as it takes up space at the expense of the map size.

3. Select the basis of presentation of data.

Place of enumeration

Persons are counted at their place of enumeration on census night. The smallest area available on this basis is the CD.

Place of usual residence

Persons are counted at their place of usual residence on census night. The smallest geographic level available on this basis is the SLA. Therefore, any non-standard area for which data on this basis are required must be defined in terms of SLAs or aggregates thereof. CDs, postcodes and electoral divisions cannot be used.

4. Decide upon the total area to appear on the map. The standard areas for which choropleth maps can be produced are:

- Australia
- State
- Statistical division
- Statistical subdivision
- Statistical region
- Postcode
- Commonwealth electoral division
- State electoral division
- Statistical local area
- Legal local government area
- Collection district

Non-standard areas include areas such as all CDs within a certain radius of a given point, or all CDs in a school's enrolment area.

5. Next, decide on the component geographic areas to be shown on the map. For example, for a map which shows all of New South Wales, legal LGAs would be suitable component geographic areas. Note, however, that Sydney itself would be represented by only a very small area on such a map and many legal LGAs in Sydney would be difficult or impossible to distinguish. In such a case, two separate maps which would be produced on different scales would be more appropriate: one for the Sydney Statistical Division showing legal LGAs; and another for legal LGAs for the remainder of New South Wales.

6. There are three basic units for constructing map populations: dwellings; families; and persons. For a map based on census count at place of usual residence, populations of family or dwelling units are not available. Examples of populations are:

Dwellings: households with one family only; rented dwellings; households with persons aged 60 years and over.

Families: couples with no dependent children; families with dependent children.

Persons: all persons; the employed labour force; persons aged 65 and over.

7. Describe the map population (see above for examples). Each map can portray only one variable. For example, a map *cannot* be produced which shows persons aged 60 years and over by sex. For such a request two maps must be specified: one for males aged 60 years and over; another for females aged 60 years and over. Alternatively, a single map showing *persons* aged 60 years and over could be requested.

8. To complete this part of the order form, you need to consider the best way to show the data. If the areas being mapped have similar sized populations, then percentages may suit your requirements. If the population sizes vary greatly however, simple counts may be preferred.

9. To select a class, you need to consider the map population. For example, if the map is to show children aged 0-5 years, suitable classes may be 0-10%, 11-20%, 21-30% and 31-40% of the total population of the area. If the map is to show population density, suitable classes might be 0-2,000, 2,001-4,000, 4,001-6,000, 6,001-8,000, 8,001-10,000, 10,001-12,000, and >12,000 persons per square kilometre. You may select up to seven classes. If there are no areas corresponding to one or more of the selected classes, the mapping system will omit these classes. For the above example, if there are no areas with a population density of, say, 2,001-4,000, the mapping system will show six classes. Generally speaking, however, it is best to let the ABS mapping system choose the most appropriate classes, unless you need the map to show some specific information. When classes are chosen by the mapping system they are denoted by, say, 200, 400, 600 which are the midpoints of each range, i.e. 100-299, 300-499, 500-699.

10. A footnote providing additional description may be requested. It can contain up to 4 lines of up to 50 characters per line. However, the footnote will take up space on the page which would otherwise be used by the map itself.

Note: State Offices are at present only able to provide medium quality colour maps produced by an ink jet plotter. Requests for maps produced on the other equipment available need to be directed to Central Office.
