FOREWORD

General

This publication provides estimates of the components of gross national product and expenditure and supporting tables for March quarter 1972, together with comparable estimates for the nine previous quarters and the four years 1967-68 to 1970-71.

For quarters prior to those shown in this bulletin, consistent estimates of the main components of gross national product and expenditure will be found in the recently published supplement (Reference No. 7.10) to bulletin No. 46.

Definitions and concepts

The definitions and concepts applied in this publication are those used in the forthcoming issue of "Australian National Accounts, 1970-71" (Reference No. 7.1) and, with the exception of the replacement of the term "public authorities" by the term "general government", are consistent with those used in the Parliamentary White Paper "National Income and Expenditure, 1970-71" issued with the Budget in August 1971.

Items in this bulletin are briefly described in the appendix to "Quarterly Estimates of National Income and Expenditure No. 46, December quarter 1971".

Interpretation of quarterly estimates

Estimating for a period of less than one year presents special problems in that it is often difficult to adhere strictly to the definitions of concepts used in annual estimates. The measurement of income for a period is particularly difficult since it is not always possible to match the value of production for a quarter with the costs incurred in that production. This problem occurs, for example, in estimating the income of farm unincorporated enterprises in each quarter, and results in considerable variation of the estimates for this series, and for gross farm product, from quarter to quarter. Difficulties are also experienced in obtaining detailed data for short periods and in preparing consistent estimates from various sources where different accounting procedures and periods are used.

These problems inevitably affect the consistency and reliability of the current-price estimates, and similarly affect the constant-price estimates based on the current-price estimates. Accordingly these factors as well as the approximations and assumptions necessarily made in the revaluation of flows at constant prices should be borne in mind when interpreting or using the estimates, for example in attempting to draw precise quantitative inferences relating to quarter-to-quarter changes in gross national product or its components, or in productivity. It is also difficult to draw valid inferences as to quarter-to-quarter changes in prices from the price relationships implied by dividing estimates at current prices for successive quarters by estimates at 1966-67 prices. Such measures of implied price change have current, not fixed, weights and are therefore affected by changes in the physical composition of the aggregates in question as well as by price changes.

Analysis of trends therefore requires allowance for these uncertainties in estimation. The effects are in some measure indicated by the change in the statistical discrepancy for corresponding periods. Uncertainty in trends arises also from the likelihood of revisions as more information becomes available and from the irregularity of short-term movements. The inclusion of the statistical discrepancy on the expenditure side of the accounts implies nothing in regard to the relative accuracy of the estimates of gross national product and expenditure. As personal and other private savings are also estimated as balancing items in their respective accounts care should be exercised in their interpretation.

Most figures should be regarded as subject to revision as more complete and more accurate information becomes available. The revisions generally will be of three main types - (1) those made to the most recent quarters as firmer quarterly or monthly data comes to hand, (2) those which are a consequence of revisions to annual totals and which are distributed to the quarters approximately in accordance with existing quarterly patterns, and (3) those made to the balancing items following revisions to other estimates. In tables of original estimates the items most subject to substantial revisions of the second type are indicated by the fact that the annual totals (only) appear in brackets while, apart from the statistical discrepancy, items subject to substantial revisions of the third type are indicated by the use of brackets for both annual and quarterly figures.

Seasonal adjustment

As most series are affected to some extent by seasonal factors, allowance should be made for normal seasonal variation. In Tables 3, 4, 7, 8 and 13 "seasonally adjusted" values are presented for selected series. Series which show substantial irregularities in the original or adjusted series should be treated with some reserve. As different methods of seasonal adjustment tend to produce different results, it is necessary to bear in mind the methods by which they have been derived and the limitations to which the methods used are subject.

The general methods used in the Bureau for making seasonal adjustments are described in "Seasonally Adjusted Indicators 1971" (Reference No. 1.10) issued by the Bureau on 2 July 1971. However, special methods have been used to adjust some of the components of gross farm product which were not amenable to seasonal adjustment by the usual methods. In the seasonally adjusted estimates, the estimated value of production of wheat, other grain and sugar cane and the quantity of wool production, for any financial year, are distributed equally over the four quarters of the year ended June. One effect of these methods is that changes in the annual production of these commodities first enter into the seasonally adjusted figures in the September quarter. As far as possible the constant-price estimates have been adjusted using methods similar to those for the corresponding current-price estimates.

Rounding of figures

The procedures used in preparing this bulletin may occasionally result in rounding differences between figures in this bulletin and corresponding figures in other publications.

Discrepancies between totals and sums of components in the tables are due to rounding.

CURRENT TRENDS IN MAIN AGGREGATESMARCH QUARTER 1972

Except where otherwise stated estimates and percentage changes in these notes refer to seasonally adjusted estimates. Individual quarterly changes should not be interpreted without reference to the changes in past periods, and attention is drawn to remarks made in the foreword.

PRODUCT

Gross national product at current prices (seasonally adjusted) is estimated to have risen about $2\frac{1}{2}$ per cent in March quarter 1972 and was about $8\frac{1}{2}$ per cent above the estimate for the corresponding quarter of 1971.

At average 1966-67 prices, gross national product in the March quarter fell by about $1\frac{1}{2}$ per cent on the preceding quarter, but was $1\frac{1}{2}$ per cent higher than the estimate for March quarter 1971. As mentioned in the foreword, price changes apparently implied in the relationship between constant and current price estimates may in fact include the effect of changes in the physical composition of the aggregates as well as price changes, so that the above percentages do not imply that prices rose 4 per cent in the March quarter. A large part of the difference in movement in the current and constant price estimates in the March quarter is related to changes in stocks. The value of physical changes in stocks in March quarter 1972 was much lower than in the corresponding quarter of recent years.

Gross non-farm product increased by 2 per cent (fell 2 per cent at constant prices) in March quarter 1972. On present estimates, gross farm product rose in the March quarter by 14 per cent (6 per cent at constant prices).

Comparing the three quarters to March 1972 with the three quarters to March 1971, gross national product was $10\frac{1}{2}$ per cent higher at current prices and 3 per cent higher at constant prices, gross non-farm product was 11 per cent higher at current prices and 3 per cent higher at constant prices, and gross farm product was 2 per cent higher at current prices and $4\frac{1}{2}$ per cent higher at constant prices.

INCOME MOVEMENTS

(NOTE. Income series can be expressed only at current prices)

Wages, salaries and supplements rose by $2\frac{1}{2}$ per cent in the March quarter, which is higher than the rises recorded in the three preceding quarters. Gross operating surplus of companies fell by $3\frac{1}{2}$ per cent in the March quarter, the movement between March quarter 1971 and March quarter 1972 being an increase of 3 per cent. The gross

operating surplus of all other trading enterprises (including farm and non-farm unincorporated enterprises, public enterprises and dwellings owned by persons) increased by 4½ per cent in the latest March quarter, while gross operating surplus of all non-farm enterprises remained at much the same level as that recorded in the December quarter.

Tables 11 and 24 show the derivation of personal income and personal disposable income from wages, salaries and supplements and income of unincorporated enterprises, together with rent, interest and dividends and other income transfers received. Seasonally adjusted estimates for these items are not available. Personal income was 10 per cent higher than in March quarter 1971. The estimate of income tax payable was 18 per cent greater than in the previous March quarter and includes the effects of higher incomes, the progressive tax scale and an increase in tax rates in the last budget as modified by the effect on 1971-72 annual tax rates of the reduction announced in April. Estimates of tax payable for the September and December quarters have been revised downwards as a consequence of the April announcement and other revisions. Compared with March quarter 1971, personal disposable income was 8½ per cent higher.

On present estimates consumers devoted approximately the same proportion of personal disposable income to consumption in the latest March quarter (86 per cent) as in the corresponding quarter of 1971 (85½ per cent). Personal saving, which is estimated only as a balancing item in the personal current account (Table 11), increased marginally (by 2½ per cent) between the two March quarters. However, this estimate is subject to substantial adjustments as a result of revisions to personal income or expenditure items.

CURRENT EXPENDITURE

Personal Consumption

Expenditure by persons on goods and services rose by 2½ per cent in the March quarter. The constant-price estimate rose by 1½ per cent after a fall in the preceding quarter.

General Government

As can be seen from the table on the opposite page, net current expenditure by general government increased by 7 per cent in the latest quarter after little change in the December quarter. At constant prices, the estimate rose by 3½ per cent in the latest quarter. Details of the components of the current-price estimate are shown in unadjusted form in Table 21 of this bulletin. Compared with March quarter 1971, the unadjusted estimates for all major categories increased.

CAPITAL EXPENDITURE

Total gross fixed capital expenditure fell by 4 per cent (5½ per cent at constant prices) in the latest quarter.

The fall in total capital expenditure may be attributed in large part to the private sector, where the latest estimates indicate a fall of 6½ per cent at current prices and 8 per cent after allowance is made for price level changes.


OVERSEAS TRANSACTIONS





Other overseas transactions are not seasonally adjusted. Comparing unadjusted figures for March quarter 1972 with those for the same quarter of 1971, the deficit on current account decreased by \$194 million. This reduction was mainly caused by an improvement of \$179 million in the balance of trade surplus. Net apparent capital inflow of \$413 million during March quarter 1972 was \$83 million lower than the inflow in the corresponding quarter of 1971. The details of this capital inflow and the monetary movements associated with it are shown in the publication "Balance of Payments : Quarterly Summary, March Quarter 1972" (Reference No. 8.2).


