PREFACE.

The first Labour Report issued by this Bureau was published in 1912. This Report is the forty-sixth of the series and deals chiefly with 1958, in addition to providing comparisons for previous years.

The Report follows in the main the lines of its immediate predecessors in scope and arrangement. The subject-matter has been divided into five chapters, namely, Retail Prices and Price Indexes; Wholesale Prices and Price Indexes; Wages and Hours; Employment and Unemployment (including Industrial Disputes); and Labour Organizations. The index at the end of the volume will considerably facilitate reference.

A brief summary of the International Labour Office Conventions which have been ratified by Australia is included in this Report (see page 156).

In tabulating the results of investigations as to rates of wage, labour organizations, industrial disputes, etc., the following grouping has been adopted in this Report:—
