

### KEY POINTS

#### **KEY POINTS**

- The total number of exporters of goods and services in 2006-07 was 44,310, a 5% increase on 2005-06.
- In 2006-07, less than 1% of goods exporters had aggregate exports of \$100m or more, but these exporters contributed 79% by value to total goods exports.
- 1% of services exporters had aggregate exports of \$100m or more and contributed 21% by value to total services exports.
- A large majority of exporters had aggregate exports of less than \$1m. 90% of goods exporters had exports of less than \$1m and contributed 2% to total goods exports. 63% of services exporters had exports of less than \$1m and contributed 1% to total services exports.
- 28% of all goods exporters were in the Wholesale trade industry.
- 79% of mining commodities were exported by businesses in the Mining industry.
- Only 9% of agriculture, forestry and fishing commodities were exported by businesses in the Agriculture, forestry and fishing industry in 2006-07.

### NOTES

ABOUT THIS ISSUE

This publication presents an analysis of the characteristics and international trading activities of Australian exporters in 2006–07. The information is compiled as a by-product of producing regular monthly and quarterly statistics on Australia's merchandise trade and international trade in services. The first table presents an overview covering exporters of both goods and services. Tables 2 to 9 present more detailed information on goods exporters and table 10 presents additional information on services exporters.

The Explanatory Notes provide important information relating to the methodology used and the limitations in the resulting data. In particular, it is important to note that a business that considers itself part of an export market may not necessarily be included as an exporter in this article. For example, many agricultural products are exported by wholesalers rather than the producers of the good. If the wholesaler owns the goods at the time of export, the wholesaler is included as the exporter.

CHANGES IN THIS ISSUE

Business characteristics obtained from the Australian Business Register (ABR), such as business location, industry and number of employees are used in the compilation of this publication. These characteristics have been updated from the ABR for exporters in 2006-07 but characteristics have not been revised for exporters in 2005-06. As a result, characteristics for the same business may differ between the two years. For example, the size category allocated to an exporting business may have changed due to an increase or decrease in the business' annual GST turnover.

The value of exports for 2005-06 in tables 1, 3 and 10 and spreadsheets 12 to 14 (available from the Details tab of this publication) include revised merchandise trade and services data.

Table 6 presents information on the state of origin of exported commodities (obtained from Customs declarations) and the state of location(s) of the exporter (obtained from the ABR). The table has been modified from the previous issue to show if the main location of the exporter is in the same state as the origin of the exported goods; the main location of the exporter is not the same as the state of origin of the exported goods but the exporter has a location in that state; or, the exporter does not have a location in the state of origin of the exported goods.

FUTURE RELEASES

The ABS is developing a business longitudinal database which should provide a better basis for analysing information about the characteristics of businesses including exporters. Due to the caveats applied to this publication, the ABS plans to undertake a review to determine the best strategy for providing information on exporters and their characteristics. The results of this review should be announced in mid to late 2008.

Subject to the above review, it is planned to release the next *Number and Characteristics of Australian Exporters*, 2007–08 (cat.no.5368.0.55.006) in March 2009. This will ensure final merchandise trade data for 2007-08 are incorporated and will provide time to implement any changes resulting from the review.

### ANALYSIS AND COMMENTS

OVERVIEW

There were 44,310 Australian exporters in 2006-07. This is an increase from 2005-06 of 5%. Of the Australian exporters, 42,645 were exporters of merchandise goods, and 2,638 were exporters of services.

Of the businesses engaged in exporting services an estimated 973 (37%) were also exporters of merchandise goods.

The total count of all actively trading Australian businesses (whether exporting or not) can be obtained from *Counts of Australian Businesses, including Entries and Exits* (cat. no. 8165.0) scheduled for release in mid December 2007.

In 2006-07 there were 231 goods exporters with aggregate exports of '\$100m or more' (an increase of 7% from 2005-06 to 2006-07). Although these businesses were less than 1% of the total goods exporter population they contributed 79% by value to total goods exports. This is an increase of 13% on the 2005-06 value for exporters with exports of '\$100m or more'.

In contrast, 28,830 (68%) of goods exporters contributed less than 1% of value of total goods exports in 2006-07. Businesses exporting goods valued at '\$10,000 and less than \$100,000' represented 38% of goods exporters with businesses exporting goods valued at 'less than \$10,000' representing 29% of goods exporters.

The number of services exporters in 2006-07 increased by 125 (5%) to 2,638, when compared to 2005-06. The increase in the number of exporters was most evident for businesses with services exports of '\$1m and less than \$100m', where the number of services exporters increased by 100 (12%) to 938.

The value of services exported in 2006-07 increased by \$4,396m (11%) to \$46,245m, when compared to 2005-06. The increase in the value of services exports was most evident for businesses with services exports of '100m or more' which increased by \$1,051m (12%) from 2005-06 to 2006-07, to \$9,614m. During the same period services exports in the category '1m and less than 100m' rose by 60m (9%) to \$8,361m.

EXPORT ACTIVITY
(Table 2)

During 2006-07, 19,755 (46%) of goods exporters lodged 1 or 2 export transactions. The majority of these exporters (11,524) were businesses with aggregate exports of 'less than \$10,000'. 31,214 (73%) of businesses exported on 10 or fewer occasions in 2006-07.

4,206 (10%) of goods exporters had 51 or more export transactions in 2006-07. In value terms, 172 of these exporters each recorded exports transactions of '\$100m or more', totalling \$116,669m. This represented 69% of the total value of goods exports in 2006-07.

Exporting businesses in the Mining (39%), Manufacturing (30%) and Wholesale trade (17%) industries were the most significant contributors to the total value of goods exports in 2006-07. These three industries accounted for \$145b (86%) of the value of goods exports in 2006-07 compared to \$136b (89%) in 2005-06.

The industries with the highest number of goods exporters in 2006-07 were Wholesale trade (11,877 or 28%) and Manufacturing (10,282 or 24%).

### ANALYSIS AND COMMENTS continued

(Tables 3 and 4) continued

The largest growth in the number of exporters between 2005-06 and 2006-07 was in the Property and business services industry with an increase of 68 exporters. The Manufacturing industry had the largest decrease in the number of exporters (76) but increased the value of goods exported by 10% over this period.

The average value of exports per business in 2006-07 was \$3.9m compared to \$3.7m in 2005-06. In 2006-07, the Mining industry had the highest average value of aggregate exports (\$134.4m per exporter), followed by the Manufacturing industry (\$5.0m per exporter), Finance and insurance industry (\$4.7m per exporter) and Wholesale trade industry (\$2.5m per exporter). The lowest average value of aggregate exports per exporter occurred in the Health and community services and Cultural and recreational services industries, with \$0.2m and \$0.1m per business, respectively.

Comparing 2005-06 to 2006-07, the highest growth industry based on average value of exports per business was the Mining industry, with average exports increasing by \$10.4m. The Finance and insurance industry increased average exports per exporter by \$1.8m and Property and business services increased by \$1.0m from 2005-06 to 2006-07.

Mining had the highest correlation (79%) between the industry that produced the commodity and the industry which exported the final product. In contrast, only 9% of Australia's agriculture, forestry and fishing commodity exports were exported by the Agriculture, forestry and fishing industry.

Exports of goods originating from the Manufacturing industry were worth \$94b in 2006-07, of which \$48.9b (52%) were exported by the Manufacturing industry, \$28.3b (30%) by 'Other' industries and \$15.1b (16%) by the Mining industry.

BUSINESS SIZE
(Table 5)

There were 4,425 large goods exporting businesses in 2006-07 representing 10% of all goods exporting businesses with \$155.9b of goods exports (or 93% of the value of total goods exports). The industries with the most large goods exporters were Manufacturing (1,380) and Wholesale trade (1,041). In terms of exports value, the Mining (\$64.8b), Manufacturing (\$46.9b) and Wholesale trade (\$24.7b) industries were the most significant contributors to the large business category.

There were 21,665 medium goods exporting businesses in 2006-07 representing 51% of all goods exporting businesses with \$11b (7%) of the value of total goods exports. The number of medium exporters increased by 29% from 2005-06, while the value contribution remained relatively unchanged. The industries with the most medium goods exporting businesses were Wholesale trade (6,930) and Manufacturing (5,930).

There were 16,555 small goods exporters in 2006-07 representing 39% of total goods exporters. In 2005-06 they represented 49% of total goods exporters. In 2006-07 they contributed \$1.1b (1%) to the value of total goods exports.

The number of businesses in the small exporter category decreased by 3,343 (17%) from 2005-06 to 2006-07. This may have been impacted by two factors. First, the same sizing criteria has been applied to 2005-06 and 2006-07 (refer to paragraphs 22 to 24 in the Explanatory Notes), ie it has not been adjusted to reflect the impact of any increase in the price of exported goods. Second, as mentioned in Changes In This Issue, business characteristics obtained from the ABR have been updated for exporters in 2006-07.

### ANALYSIS AND COMMENTS continued

STATE DATA

(Tables 6, 7, 8 and 9)

From 2005-06 to 2006-07, Victoria had the largest increase in number of exporters, increasing by 567 to 11,229, followed by New South Wales which increased exporters by 340 to 14,271, and South Australia by 176 to 2,385. However, in percentage terms, Tasmania (10%) had the highest growth in the number of exporters, followed by South Australia (8%) and Victoria (5%).

Over half the businesses exporting goods originating in either the Northern Territory or Tasmania had no presence in that state. By contrast, 75% or more of the businesses exporting goods originating in New South Wales, Victoria and Western Australia had a business location in that particular state.

36% of Australia's total value of goods exports in 2006-07 came from Western Australia, followed by Queensland (21%), New South Wales (17%) and Victoria (12%).

Western Australia (\$32.8b) and Queensland (\$18.9b) have combined mining exports of \$51.7b, representing 79% of total exports by the exporters in the Mining industry in 2006-07.

Western Australia (\$13.6b) and New South Wales (\$13.4b) have combined Manufacturing industry exports of \$27b, contributing 53% of total exports by exporters in the Manufacturing industry.

Of the small goods exporting businesses with an ABN, 37% had their main state of business operations in New South Wales, 27% in Victoria, 18% in Queensland, 10% in Western Australia, 6% in South Australia and 1% in Tasmania.

The industry with the highest number of small goods exporters in 2006-07 was Wholesale trade with 3,906 (down by 1,283 from 2005-06).

In relation to the number of small goods exporters, New South Wales had the largest decrease between 2005-06 and 2006-07, declining by 1,321, followed by Victoria (923) and Queensland (781).

SERVICES EXPORTERS
(Table 10)

The number of businesses exporting Other business services increased by 311 (18%) and the number of businesses exporting Communications services increased by 277 (58%) when compared to 2005-06. The number of businesses exporting Personal, cultural and recreational services fell by 263 (38%), Construction services fell by 119 (46%) and Transportation services fell by 11 (13%) during the same period.

The value of Other business services and Computer and information services exported increased during the year by \$1,049m (22%) and \$282m (24%), respectively. The value of Personal, cultural and recreational services exported decreased by \$46m (7%).

#### **EXPLANATORY NOTES**

INTRODUCTION

- **1** This publication provides an analysis of the characteristics and international trading activities of Australian exporters in 2006-07. Although the ABS has released a series of articles on the number and characteristics of Australian exporters covering the 2001-02, 2002-03 and 2003-04 reference periods care should be exercised when comparing these earlier estimates with 2005-06 and 2006-07 data. The reasons for this break in series are outlined in paragraphs 2 and 3.
- **2** Estimates relating to exporters of merchandise goods are compiled from data sourced from the Australian Customs Service (Customs) and from the Australian Taxation Office (ATO) Australian Business Register (ABR). The methodology used to derive numbers of goods exporters was changed in 2006, and estimates for 2005-06 and 2006-07 cannot be compared to previous years. More details about this revised methodology are contained in the feature article *New Methodology for Deriving Counts of Australian Exporters* (cat. no. 5368.3) issued on 7 April 2006.
- **3** Estimates relating to exporters of services are derived from the *ABS Survey of International Trade in Services* (SITS). The coverage of SITS was improved during 2005-06 with the identified population of businesses exporting and/or importing services increasing from 3,299 to 4,615. For more information about these changes please refer to *Changes to International Trade in Services Statistics, August 2006* released with the August 2006 issue of *International Trade in Goods and Services* (cat. no. 5368.0).

WHAT IS AN EXPORTER?

- **4** An exporter is defined as the owner of the exported good or the provider of the exported service. Using balance of payments principles, if an export takes place, it must involve a resident selling something to a non-resident (i.e. it involves a change of ownership from an Australian resident to a non-resident). International trade in services statistics are compiled on balance of payments principles and only cover transactions between Australian residents and non-residents.
- 5 Information on exporters of goods is compiled from merchandise trade statistics and is usually, but not always, consistent with balance of payments principles. In a small number of cases a non-resident may own the goods at the time of departure. As there would usually have been a transaction between an Australian resident and a non-resident prior to the goods physically leaving Australia, it is assumed, for the purpose of these statistics, that all owners of goods at the time of their export are Australian residents and are therefore included in the counts of exporters.
- **6** There are a number of situations that impact on the interpretation of the count and characteristics of exporters including:
  - Exports of goods excludes export consignments with a value of less than \$2,000.
     Prior to July 2002 exports of goods excluded individual transaction lines (within an export consignment) with a value of less than \$500
  - Australian businesses that sell goods or services to other Australian businesses which undertake the exporting function are excluded, for example:
    - Many agricultural products are exported from Australia by wholesalers (such as commodity marketing boards) rather than by the producer;
    - A principal consultant may export a consultancy service which comprises the work of a number of Australian sub-consultants;
    - A business may export a product which is assembled from components made by a number of Australian businesses
  - Some analysts include the individual businesses providing commodities, components, other goods or services for export in their definition of 'exporters' or at least consider them to be involved in export-related activity. However, unless the businesses actually own the goods or provide the service at the time of export, they are not included in the ABS count of exporters

WHAT IS AN EXPORTER? continued

- Service exporters include businesses which provide services from their Australian base to consumers offshore, i.e. supply modes 1 and 4 in the classification used by the World Trade Organisation. However, smaller and/or occasional exporters are unlikely to come to ABS notice and are therefore not included in the estimates. The number of excluded businesses may be significant, but the value of their exports is not thought to be appreciable in the totality of service exports. The ABS continues to try to identify these businesses and incorporate them into its estimates
- Service exporters exclude businesses that only supply goods or services to foreign tourists or students in Australia (supply mode 2), such as hotels, restaurants, retail, tourist facilities, transport, theatres, educational institutions, etc. In concept these businesses should be included in counts of exporters. However, estimates of these services are compiled from information obtained from the consumers of these services rather than from the businesses providing the services
- Goods and services exporters exclude Australian-owned businesses located overseas supplying goods or services in or from the country in which they are located (supply mode 3 and usually called foreign affiliates trade), because their trade does not directly contribute to Australia's exports of goods and services.
- **7** Apart from the exclusions mentioned above, businesses which export goods or services in a particular year are counted as exporters regardless of the value or frequency of their exports. Table 1 and table 2 in this publication present the number of exporters by a range of export values, and table 2 presents counts of goods exporters by the frequency of export transactions. This information could be analysed when considering issues such as the identification of businesses with an export focus.

CHARACTERISTICS OBTAINED FROM THE ABR

- **8** To help readers interpret data on the number and characteristics of exporters, the Australian Business Number (ABN) is used to obtain selected information on businesses from the ABR.
- **9** The information obtained from the ABR includes:
- Industry of the business based on the Australian and New Zealand Standard Industry Classification (ANZSIC)
- Main state of business location, based on main business address
- States in which the business is located
- Number of payees and Goods and Services Tax (GST) turnover range. These indicators are used in determining the size of the business.
- **10** The following issues should be considered when interpreting information from the ABR about exporters:
  - The latest available information was obtained from the ABR for businesses exporting in 2006–07. This means that the location, industry and size information for some businesses may differ between 2005–06 and 2006–07. For example the size category allocated to exporting businesses may be impacted by an increase in GST turnover
  - A business may have more than one ABN and the ABN quoted on export documentation may be the ABN of a part of the business not actually producing the exports. As a result, characteristics obtained from the ABR (eg. the main state or the industry of the business) could relate to a corporate head office
  - A business located in a state may export goods produced in different states.
- **11** The characteristics listed above can not be obtained for exporting businesses without an ABN.
- **12** The ABS is developing a business longitudinal database which should provide a better basis for analysing information about the characteristics of businesses including exporters. Due to the caveats applied to this publication, the ABS plans to undertake a review to determine the best strategy for providing information on exporters and their characteristics. The results of this review should be announced in mid to late 2008.

CHARACTERISTICS OBTAINED FROM THE ACS

- **13** The following information can be obtained or derived from export documentation for all goods exporters including those without an ABN:
  - Value of exports
  - State of origin of the commodity
  - Industry of origin of the commodity.
- **14** The state of origin of the commodity recorded on export documentation can be used to identify the state from which the exported goods were sourced. State of origin is the state, in which the final stage of production or manufacture occurs. Determining a single state of origin is difficult when there may be several stages in the manufacturing process, each of which may take place in a different state. For example, fruit may be grown in one state, canned in another, and exported from another.
- 15 The industry of origin of the commodity is derived by linking each statistical code in the Australian Harmonised Export Commodity Classification (AHECC) to an ANZSIC industry based on the primary activities of the industries with which they are most commonly associated. These are the industries most likely to have produced the exported goods. Industry of origin of the commodity is a different concept from the industry of businesses recorded on the ABR. While each AHECC statistical code is allocated to one primary industry of origin, commodities can be produced and/or exported by businesses classified to a number of industries.

STATE INFORMATION

- **16** Two different concepts are used to measure the state distribution of goods exporters in this article.
- 17 The first measure is a count of the number of businesses which export goods that were produced in a given state based on information supplied to Customs with export documentation. The second measure is a count of the number of businesses engaged in exporting activities within a given state based on state of business location data as supplied to the ATO when the business initially registered with the ABR or subsequently underwent a change in business structure.
- **18** An exporter is defined as having locations within the state of origin of the exported commodity if
  - The postcode of the exporter is in the same state as the state of origin of the export, or
  - The exporter has multi-state locations, one of which matches the state of origin of the export.
- **19** Table 6 shows the comparison of the two different concepts, State of origin of commodities and State of location on the ABR. The State of location is then broken down by 'main location in the state' and 'location in state not main location'. The sum of the location numbers in this table exceeds number of total goods exporters because an exporter may export goods which originate from more than one state.
- **20** Table 8 shows the distribution of goods exporting businesses by industry of exporter and the exporter's main state of business location as listed on the ABR (please see Explanatory Notes paragraphs 8-11).

**21** In addition to industry of origin of the commodity, a number of tables show industry of the exporter. This is based on ANZSIC industry of the exporting business as registered on the ABR. The exporting business as defined in this analysis is the owner of the good at the time of export and not necessarily the producer of the exported

commodity.

BUSINESS SIZE

- 22 Exporter counts are presented by business size. The ABS discussed the size classification to be used for counts of businesses in the information paper, *A Statistical View of Counts of Businesses in Australia, 2005* (cat. no. 8161.0). The size classification recommended in that information paper only used number of payees. Despite this, additional criteria have been added for the purpose of the exporter data, to cover businesses with large value domestic and/or export sales but relatively few employees. This non-standard definition has been retained to maintain consistency with previous articles and because it caters for exporters that do not have an ABN or have more complex structures, e.g. the ABN reported on the export documentation may not be the same as the ABN used for employment purposes.
- **23** For the purposes of this analysis, the size of the business has been determined in terms of three variables its employment and estimated annual turnover (both derived from the ABR) and the value of exports (reported to Customs).
- **24** The criteria are:
- Small exporters having fewer than 20 payees and estimated annual GST turnover range less than \$1m and exports of less than \$1m during the reference period
- Large exporters having 200 or more payees or estimated annual GST turnover range of \$20m or more or exports of \$20m or more during the reference period
- Medium exporters all businesses other than those defined as small or large.
- 25 Data cube 11 shows country data by the number of goods exporters, number of transactions and the value of exports. Exporter counts are suppressed for those countries with fewer than five exporters to preserve exporter confidentiality. In these instances the number of exporters cell is annotated "less than five" and the corresponding number of export transactions cell is not available and is annotated "na".
- **26** All countries with total exports under \$1 million have "less than \$1m" recorded in the value of exports cell. This diverges from the usual ABS practice of "rounding" values of \$500,000 or more up to \$1 million and "rounding" values of \$499,999 or less down to zero. Total exports for all countries includes the actual value of exports for Australia's less significant export partners.
- **27** Although in regular published statistics such as the international merchandise exports by commodity tables released each month in *International Trade in Goods and Services, Australia* (cat. no. 5368.0) the value of exports for some commodities is suppressed to preserve exporter confidentiality, total exports by country can be released for the majority of countries.
- 28 However, for some countries exports of alumina comprise almost all of the confidential commodities item and it is necessary to apply a secondary embargo on the country of final export destination in addition to the commodity restriction. The countries affected by this secondary embargo in 2006-07 are Bahrain, Egypt and Iceland. As a consequence, the number of exporters, number of export transactions and the total value of exports for all alumina for these countries are excluded from each of these countries and combined in 'Country confidential'.
- **29** Where figures have been rounded, discrepancies may occur between sums of the component items and totals. Percentage movements are calculated from data at the level of precision presented in this publication (i.e. \$m).
