## TREND ESTIMATES

- The provisional trend estimate of the balance on goods and services was a deficit of $\$ 1,023 \mathrm{~m}$ in May 2007, a decrease of $\$ 19 \mathrm{~m}$ on the revised deficit in April.
- Goods and services credits rose $\$ 102 \mathrm{~m}(1 \%)$ to $\$ 18,402 \mathrm{~m}$. Goods and services debits rose $\$ 83 \mathrm{~m}$ to $\$ 19,425 \mathrm{~m}$.


## SEASONALLY ADJUSTED ESTIMATES

- In seasonally adjusted terms, the balance on goods and services was a deficit of $\$ 807 \mathrm{~m}$ in May, a decrease of $\$ 109 \mathrm{~m}$ on the revised deficit in April.
- Goods and services credits rose $\$ 545 \mathrm{~m}(3 \%)$ to $\$ 18,727 \mathrm{~m}$. Non-rural and other goods rose $\$ 502 \mathrm{~m}(4 \%)$ and rural goods rose $\$ 1 \mathrm{~m}$. Services credits rose $\$ 43 \mathrm{~m}(1 \%)$.
- Goods and services debits rose $\$ 437 \mathrm{~m}(2 \%)$ to $\$ 19,534 \mathrm{~m}$. Capital goods rose $\$ 417 \mathrm{~m}$ (13\%) and intermediate and other goods rose $\$ 80 \mathrm{~m}$ (1\%) while consumption goods fell $\$ 73 \mathrm{~m}(2 \%)$. Services debits rose $\$ 13 \mathrm{~m}$.


## ORIGINAL ESTIMATES

- In original terms, the May 2007 balance on goods and services was a deficit of $\$ 654 \mathrm{~m}$, an increase of $\$ 135 \mathrm{~m}$ on the revised deficit in April. Goods and services credits rose $\$ 864 \mathrm{~m}$ (5\%) and goods and services debits rose $\$ 999 \mathrm{~m}$ (5\%).
- In the eleven months to May, exports of non-rural and other goods were up $\$ 15.7 b(14 \%)$ and rural goods were up $\$ 0.1 \mathrm{~b}$ on the corresponding period in 2005-06.

Revisions were made to incorporate the latest available data relating to merchandise trade and administrative data relating to the international trade in services. In original terms, these revisions have:

- increased the deficit on goods and services for April 2007 by $\$ 130 \mathrm{~m}$
- decreased the deficit on good and services for the 10 months to April 2007 by $\$ 61 \mathrm{~m}$.

The trend breaks applying to coal, coke and briquettes for April 2004 and April 2005 have been revised in this issue with consequential revisions to the seasonal factors and seasonally adjusted series. The trend break for April 2004 has been revised from $\$ 300 \mathrm{~m}$ to $\$ 430 \mathrm{~m}$ and the trend break for April 2005 from $\$ 600 \mathrm{~m}$ to $\$ 819 \mathrm{~m}$. These trend breaks relate to the irregular price increases that were identified in April 2004 and 2005 following contractual price increases at those times. The initial trend breaks were estimated by the ABS based on the expected increases but from recent reanalysis combined with the availability of additional monthly original data, these trend break corrections have been improved.

Corresponding trend break revisions to the quarterly coal, coke and briquettes series will be applied to data released in the June quarter 2007 issue of Balance of Payments and International Investment Position, Australia (cat. no. 5302.0) to be released on 30 August 2007.

Commencing with the June issue, goods debits (imports) on a balance of payments basis will use the Customs values (CV) from the merchandise trade data rather than Free on Board values (f.o.b.). The CV is similar to the f.o.b. value except that it includes the revaluation of goods imports by Customs to more closely reflect the market value. Market value measures are the standard required for both Balance of Payments and the System of National Accounts. To align with the National Accounts revision policy, revisions to the balance of payments goods debits data will only be made back to July 2006. These are all upward revisions and range in total from $\$ 13 \mathrm{~m}$ to $\$ 19 \mathrm{~m}$ per month across a number of commodity groups. These revisions will also be applied to data released in the June quarter 2007 issue of Balance of Payments and International Investment Position, Australia (cat. no. 5302.0).

## ANALYSIS AND COMMENTS

BALANCE ON GOODS AND SERVICES

The trend estimate of the balance on goods and services in May 2007 was a deficit of $\$ 1,023 \mathrm{~m}$, a decrease of $\$ 19 \mathrm{~m}$ on the deficit in April.

In seasonally adjusted terms, the balance on goods and services in May 2007 was a deficit of $\$ 807 \mathrm{~m}$, a decrease of $\$ 109 \mathrm{~m}$ on the deficit in April.

EXPORTS OF GOODS AND SERVICES

The trend estimate of goods and services credits rose $\$ 102 \mathrm{~m}(1 \%)$ between April and May to $\$ 18,402 \mathrm{~m}$

In seasonally adjusted terms, goods and services credits rose $\$ 545 \mathrm{~m}(3 \%)$ to $\$ 18,727 \mathrm{~m}$. Non-rural goods rose $\$ 348 \mathrm{~m}$ (3\%), other goods rose $\$ 155 \mathrm{~m}(15 \%)$ and rural goods rose $\$ 1 \mathrm{~m}$. Services credits rose $\$ 43 \mathrm{~m}$ (1\%)

GOODS CREDITS


RURAL GOODS
The trend estimate of rural goods exports fell $\$ 22 \mathrm{~m}(1 \%)$ to $\$ 1,980 \mathrm{~m}$.
In seasonally adjusted terms, exports of rural goods rose $\$ 1 \mathrm{~m}$ to $\$ 1,983 \mathrm{~m}$.

The components contributing to the rise in the seasonally adjusted series were:

- other rural, up \$17m (2\%)
- wool and sheepskins, up $\$ 6 \mathrm{~m}(2 \%)$
- cereal grains and cereal preparations, up \$4m (1\%).

Offsetting these effects was the meat and meat preparations component, down \$26m (5\%).

In original terms, exports of rural goods rose $\$ 183 \mathrm{~m}(9 \%)$ to $\$ 2,110 \mathrm{~m}$.

NON-RURAL GOODS
The trend estimate of non-rural goods exports rose $\$ 65 \mathrm{~m}(1 \%)$ to $\$ 11,294 \mathrm{~m}$.

In seasonally adjusted terms, exports of non-rural goods rose $\$ 348 \mathrm{~m}(3 \%)$ to $\$ 11,524 \mathrm{~m}$.
The main components contributing to the rise in the seasonally adjusted series were:

- coal, coke and briquettes, up $\$ 138 \mathrm{~m}$ ( $8 \%$ )
- other manufactures, up $\$ 137 \mathrm{~m}$ (11\%)
- metal ores and minerals, up \$81m (3\%)
- transport equipment, up $\$ 51 \mathrm{~m}$ (13\%).

Partly offsetting these effects was the other mineral fuels component, down \$143m (10\%).

## Exports of goods continued

 NON-RURAL GOODS continuedIn original terms, exports of non-rural goods rose $\$ 711 \mathrm{~m}(7 \%)$ to $\$ 11,612 \mathrm{~m}$.

## OTHER GOODS

The trend estimate of other goods exports rose $\$ 37 \mathrm{~m}(3 \%)$ to $\$ 1,136 \mathrm{~m}$.

In seasonally adjusted terms, exports of other goods rose $\$ 155 \mathrm{~m}$ (15\%) to $\$ 1,215 \mathrm{~m}$.

The components contributing to the rise in the seasonally adjusted series were:

- non-monetary gold, up \$113m (12\%)
- goods for processing, up $\$ 46 \mathrm{~m}$.

In original terms, exports of other goods rose $\$ 165 \mathrm{~m}(16 \%)$ to $\$ 1,216 \mathrm{~m}$.

## Exports of services

IMPORTS OF GOODS AND SERVICES

SERVICES CREDITS


In trend terms, services credits rose $\$ 22 \mathrm{~m}(1 \%)$ to $\$ 3,992 \mathrm{~m}$.
Seasonally adjusted, services credits rose $\$ 43 \mathrm{~m}(1 \%)$ to $\$ 4,006 \mathrm{~m}$.

All components contributed to the rise in the seasonally adjusted estimates with:

- travel services, up \$23m (1\%)
- transportation services, up $\$ 17 \mathrm{~m}$ (2\%)
- other services, up $\$ 3 \mathrm{~m}$.

Seasonally adjusted, tourism related services credits rose $\$ 18 \mathrm{~m}(1 \%)$ to $\$ 2,569 \mathrm{~m}$. This series is seasonally adjusted independently to the series that comprise services credits.

The trend estimate of goods and services debits rose $\$ 83 \mathrm{~m}$ between April and May to $\$ 19,425 \mathrm{~m}$.

In seasonally adjusted terms, goods and services debits rose $\$ 437 \mathrm{~m}(2 \%)$ to $\$ 19,534 \mathrm{~m}$. Capital goods rose $\$ 417 \mathrm{~m}(13 \%)$ and intermediate and other merchandise goods rose $\$ 125 \mathrm{~m}(2 \%)$ while consumption goods fell $\$ 73 \mathrm{~m}(2 \%)$ and other goods fell $\$ 45 \mathrm{~m}(7 \%)$. Services debits rose $\$ 13 \mathrm{~m}$.

## Imports of goods

GOODS DEBITS


CONSUMPTION GOODS
The trend estimate of imports of consumption goods fell $\$ 20 \mathrm{~m}$ to $\$ 4,663 \mathrm{~m}$.
In seasonally adjusted terms, imports of consumption goods fell $\$ 73 \mathrm{~m}(2 \%)$ to $\$ 4,586 \mathrm{~m}$.

The main component contributing to the fall in the seasonally adjusted estimates was non-industrial transport equipment, down \$195m (14\%).

Partly offsetting this effect were:

- consumption goods n.e.s., up $\$ 75 \mathrm{~m}$ (5\%)
- household electrical items, up $\$ 40 \mathrm{~m}$ (11\%).

In original terms, imports of consumption goods rose $\$ 90 \mathrm{~m}(2 \%)$ to $\$ 4,417 \mathrm{~m}$.

## CAPITAL GOODS

The trend estimate of imports of capital goods rose $\$ 15 \mathrm{~m}$ to $\$ 3,556 \mathrm{~m}$.

In seasonally adjusted terms, imports of capital goods rose $\$ 417 \mathrm{~m}(13 \%)$ to $\$ 3,735 \mathrm{~m}$.
The main components contributing to the rise in the seasonally adjusted estimates were:

- civil aircraft, up $\$ 375 \mathrm{~m}$
- industrial transport equipment n.e.s., up $\$ 92 \mathrm{~m}$ (18\%).

Partly offsetting these effects was the machinery and industrial equipment component, down $\$ 89 \mathrm{~m}$ (7\%).

In original terms, imports of capital goods rose $\$ 598 \mathrm{~m}(19 \%)$ to $\$ 3,814 \mathrm{~m}$.

INTERMEDIATE AND OTHER MERCHANDISE GOODS
The trend estimate of imports of intermediate and other merchandise goods rose $\$ 65 \mathrm{~m}$ (1\%) to $\$ 6,893 \mathrm{~m}$.

In seasonally adjusted terms, imports of intermediate and other merchandise goods rose $\$ 125 \mathrm{~m}$ (2\%) to $\$ 6,915 \mathrm{~m}$.

The main component contributing to the rise in the seasonally adjusted estimates was fuels and lubricants, up $\$ 318$ m (18\%), with volumes of crude oil imports up $16 \%$ and prices up 1\%.

Partly offsetting this effect were:

- processed industrial supplies, down $\$ 70 \mathrm{~m}$ (4\%)
- primary industrial supplies n.e.s., down $\$ 65 \mathrm{~m}$ (41\%)

INTERMEDIATE AND OTHER MERCHANDISE GOODS continued

- iron and steel, down \$31m (9\%).

In original terms, intermediate and other merchandise goods rose $\$ 416 \mathrm{~m}(6 \%)$ to $\$ 7,045 \mathrm{~m}$.

OTHER GOODS
The trend estimate of imports of other goods rose $\$ 15 \mathrm{~m}(3 \%)$ to $\$ 595 \mathrm{~m}$.
In both original and seasonally adjusted terms, other goods debits fell $\$ 45 \mathrm{~m}$ (7\%) to $\$ 559 \mathrm{~m}$ 。

The main component contributing to the fall in these estimates was non-monetary gold, down $\$ 47 \mathrm{~m}$ (10\%)

Imports of services
SERVICES DEBITS


In trend terms, services debits rose $\$ 8 \mathrm{~m}$ to $\$ 3,718 \mathrm{~m}$.

Seasonally adjusted, services debits rose $\$ 13 \mathrm{~m}$ to $\$ 3,739 \mathrm{~m}$.

All components contributed to the rise in the seasonally adjusted estimates with:

- travel services, up $\$ 8 \mathrm{~m}(1 \%)$
- transportation services, up $\$ 3 \mathrm{~m}$
- other services, up $\$ 2 \mathrm{~m}$.

Seasonally adjusted, tourism related services debits fell $\$ 17 \mathrm{~m}(1 \%)$ to $\$ 1,948 \mathrm{~m}$. This series is seasonally adjusted independently to the series that comprise services debits.

1 This publication presents preliminary estimates of Australia's international trade in goods and services on a balance of payments basis and merchandise import and export statistics on a recorded trade basis.

2 Merchandise trade statistics on a recorded trade basis are compiled from information submitted by exporters and importers or their agents to the Australian Customs Service (ACS). Adjustments for coverage, timing and valuation are made to recorded trade data to convert them to a balance of payments basis. The main source for services data is the quarterly Survey of International Trade in Services.

3 More comprehensive quarterly estimates of Australia's trade in goods and services, together with comprehensive details of Australia's balance of payments are included in the quarterly publication, Balance of Payments and International Investment Position, Australia (cat. no. 5302.0). Detailed monthly statistics on merchandise trade are available on Time Series Spreadsheets or by subscription to tailored services.

4 The conceptual framework used in compiling Australia's merchandise trade statistics can be found in International Merchandise Trade, Australia: Concepts, Sources and Methods, 2001 (cat. no. 5489.0).

5 The conceptual framework used in compiling Australia's balance of payments statistics is based on the Fifth Edition of the International Monetary Fund's Balance of Payments Manual (BPM5,1993). Descriptions of the underlying concepts and structure of the balance of payments and the sources, methods and terms used in compiling the estimates are presented in Balance of Payments and International Investment Position, Australia: Concepts, Sources and Methods, 1998 (cat. no. 5331.0). To bring merchandise trade statistics on a recorded trade basis to a balance of payments basis, timing adjustments are made to ensure that the transaction is recorded in the period in which ownership changed, rather than in the period in which the transaction was recorded by ACS. Adjustments are also made to imports to take account of distortions which arise when significant changes occur in the volume of import entries lodged but not yet processed by ACS in a given month. Chapter 6 of cat. no. 5331.0 provides more detail on the relationship between statistics on international merchandise trade on a recorded trade basis and on a balance of payments basis.

6 Both of the Concepts, Sources and Methods publications are available to download for free from the ABS website. Select Methods, Classifications, Concepts $\&$ Standards, then choose ABS concepts, classifications and statistical standards and then the catalogue numbers as above.

7 Monthly original estimates are volatile, being subject to calendar-related and large irregular influences. Seasonally adjusted estimates are derived by estimating and removing systematic calendar related effects, such as seasonal and trading day influences, from the original series. Trading day effects are removed from the original estimates prior to the seasonal adjustment process. Seasonal adjustment does not aim to remove the irregular or non-seasonal influences which may be present in any particular month. These irregular influences may reflect both random economic events and difficulties of statistical recording. The estimates of international trade in goods and services on a balance of payments basis are seasonally adjusted. The merchandise exports and imports statistics on a recorded trade basis are not.

8 The seasonally adjusted statistics in this publication use the concurrent seasonal adjustment technique to estimate factors for the current and previous months. Under this method, the estimates of seasonal factors are fine tuned as new original estimates become available each period. The seasonally adjusted estimates are subject to revisions at each reference month as the estimates of seasonal factors are improved.

9 The month-to-month movements of the seasonally adjusted estimates may not be reliable indicators of trend behaviour because they include irregular or non-seasonal movements. Trend estimates are derived by applying a 13 -term Henderson moving average to the seasonally adjusted series. The use of a 13 -term Henderson average can result in revisions to the estimates for the most recent six months as additional observations become available. Revisions can also occur because of changes in the original data and as a result of the re-estimation of the seasonal factors.

10 In keeping with balance of payments conventions, where statistics are on a balance of payments basis, credit entries (exports) are shown without sign and debit items (imports) are shown as negative entries. For statistics on a recorded trade basis, both imports and exports are shown without sign. The calculation of percentage changes on balance of payments debit items are made without regard to sign. References to balance of payments debit items in Key Figures, Key Points, and Analysis and Comments are also made without regard to sign.

11 For details of the classification used for goods exports on a balance of payments basis (credits), see table 6.6 in Balance of Payments and International Investment Position, Australia: Concepts, Sources and Methods, 1998 (cat. no. 5331.0),

12 Details of the classification of goods imports on a balance of payments basis (debits) are provided in table 6.7 in cat. no. 5331.0. Goods debits sub groups at a more detailed level than shown in Table 4 are available from the Time series spreadsheets.

13 The recorded trade statistics shown in tables 12 and 13 are classified by the Standard International Trade Classification (SITC). The first section of tables 12 and 13 show the most significant commodities (by value) at the SITC 3 digit level.

14 The quarterly detailed services data published in table 11 are consistent with the monthly aggregates shown in table 9 .

15 Monthly indicators for many of the services components that are only surveyed quarterly are not available. In particular, the Freight and Other transportation components of Total services credits are not available for publication on a monthly basis. The estimates for these items shown in table 9 are therefore derived by dividing the quarterly estimate by three. Where quarterly survey data are not available, freight debits are derived directly from imports data for the reference month as a difference between total merchandise cost, insurance and freight (CIFE) and free on board (FOB), adjusted to reflect timing and processing adjustments. For freight credits and other transportation credits and debits, estimates are derived by extrapolating the last month's data by an average of movements for the same month over the three previous years.

16 The tourism related services memorandum items provide timely indicators of the movements in tourism related activities, not an absolute measure of the level of these activities. These series are not complied on a balance of payments conceptual basis. However, they do provide a reasonable approximation of world tourism related activities.

17 The memorandum items have been derived by re-aggregating relevant components of the international trade in services series of the balance of payments accounts. The tourism related indicator has been derived by combining total travel services (business, education-related and other personal travel), passenger fares, and the air transport component of other transportation services which relates to agency fees and commission receipts.

18 Annual services data by state and by partner country are released twice yearly. Calendar year data are usually released with the March issue of this publication and financial year data are released with the September issue. Refer to Time Series Data for details.

19 Services credits are classified by the state of provision, while services debits are classified by the state of consumption. The state allocations for transportation, travel and communication services are based on a number of indicators including merchandise trade statistics by state, overseas passenger arrivals and departures by state of clearance and data provided by the Department of Education, Science and Training. The allocation for other services (about $25 \%$ of all trade in services) is primarily based on the location of the business reporting the information, which serves as a proxy for the state of provision/consumption of that service. The data should be used with care but are considered suitable for analysis over time.

20 A comprehensive explanation of the data sources used and the methodology applied in the compilation of partner country statistics is provided in Chapter 17 of Balance of Payments and International Investment Position, Australia - Concepts, Sources and Methods (cat. no. 5331.0). Approximately 7\% of total services credits and 5\% of total services debits for 2005-06 are either confidential, or unable to be allocated to individual countries.

21 More detailed balance of payments and recorded merchandise trade data, including forward seasonal factors are available as time series spreadsheets or data cubes from the ABS website.

22 More detailed merchandise trade data by commodity, country and state, and statistics included in this and related publications are available on request. Inquiries should be made to the National Information and Referral Service as shown on the back of this publication.

25 The tables in this publication are presented on two bases. Tables 1-11 contain estimates of Australia's international trade in goods and services which have been adjusted for coverage, valuation and timing to a balance of payments basis. Tables 12-15 contain estimates of merchandise exports and imports based on Australian Customs Service records. Paragraph 5 of the Explanatory Notes provides an explanation of the difference between these bases.

26 Where figures have been rounded, discrepancies may occur between sums of the component items and totals. Percentage movements are calculated from data at the level of precision presented in this publication (i.e. $\$ \mathrm{~m}$ ) except for international merchandise trade tables.
