## KEY POINTS

## TREND ESTIMATES

- The provisional trend estimate of the balance on goods and services was a deficit of $\$ 741 \mathrm{~m}$ in October 2006, an increase of $\$ 54 \mathrm{~m}$ on the revised deficit in September.
- Goods and services credits rose $\$ 4 \mathrm{~m}$ to $\$ 17,971 \mathrm{~m}$. Goods and services debits rose $\$ 58 \mathrm{~m}$ to $\$ 18,712 \mathrm{~m}$.


## SEASONALLY ADJUSTED ESTIMATES

- In seasonally adjusted terms, the balance on goods and services was a deficit of $\$ 1,263 \mathrm{~m}$ in October, an increase of $\$ 535 \mathrm{~m}$ on the revised deficit in September.
- Goods and services credits rose $\$ 371 \mathrm{~m}(2 \%)$ to $\$ 18,047 \mathrm{~m}$. Non-rural and other goods rose $\$ 345 \mathrm{~m}(3 \%)$ and rural goods rose $\$ 8 \mathrm{~m}$. Services credits rose $\$ 18 \mathrm{~m}$.
- Goods and services debits rose $\$ 906 \mathrm{~m}(5 \%)$ to $\$ 19,310 \mathrm{~m}$. Intermediate and other goods rose $\$ 459 \mathrm{~m}$ (6\%), consumption goods rose $\$ 240 \mathrm{~m}$ (5\%) and capital goods rose $\$ 161 \mathrm{~m}$ (5\%). Services debits rose $\$ 46 \mathrm{~m}(1 \%)$.


## ORIGINAL ESTIMATES

- In original terms, the October balance on goods and services was a deficit of $\$ 1,749 \mathrm{~m}$, an increase of $\$ 475 \mathrm{~m}$ on the revised deficit in September. Goods and services credits rose $\$ 791 \mathrm{~m}(4 \%)$ and goods and services debits rose $\$ 1,266 \mathrm{~m}(7 \%)$.
- In the four months to October, exports of non-rural and other goods were up $\$ 8.2 \mathrm{~b}$ (20\%) and rural goods were up $\$ 0.7 \mathrm{~b}$ (9\%) on the corresponding period in 2005-06.

Revisions were made to the merchandise trade series to incorporate the latest data available. In the balance of payments series, minor revisions were made to original total goods debits in April ( $+\$ 3 \mathrm{~m}$ ) and May ( $-\$ 3 \mathrm{~m}$ ) 2006.

There are no changes to this issue.

The trade in services data cubes by partner country on a financial year basis, listed under Time Series Data on page 4, have been updated on the ABS web site to incorporate the historical revisions detailed in the August issue of this publication.

The calendar year data, which are normally updated with the March issue of this publication, will be updated to reflect these historical revisions with the November issue.

Statistical codes in the Australian Harmonized Export Commodity Classification (AHECC) and the Customs Tariff will be revised from 1 January 2007. The changes result from the implementation of an update to the international Harmonized Commodity Description and Coding System. The changes will not impact on the presentation of statistics in this publication but will impact on detailed import and export statistics provided via ABS Client Services.

More information about these changes is available from the ABS web site Information Paper: Changes on 1 January 2007 to Statistical Codes in the AHECC and the Customs Tariff, 2007 (cat. no. 1233.0.55.001). Included with the information paper are correspondences between the codes of the current and the updated versions of the AHECC and the Customs Tariff, and correspondences between the updated versions of the AHECC and the Customs Tariff, and related classifications. The correspondences can be used by clients to understand the impact on the detailed import and export statistics.

## ANALYSIS AND COMMENTS

BALANCE ON GOODS AND SERVICES

The trend estimate of the balance on goods and services in October 2006 was a deficit of $\$ 741 \mathrm{~m}$, an increase of $\$ 54 \mathrm{~m}$ on the deficit in September.

In seasonally adjusted terms, the balance on goods and services in October 2006 was a deficit of $\$ 1,263 \mathrm{~m}$, an increase of $\$ 535 \mathrm{~m}$ on the deficit in September.

EXPORTS OF GOODS AND The trend estimate of goods and services credits rose $\$ 4 \mathrm{~m}$ between September and

SERVICES October to $\$ 17,971 \mathrm{~m}$.

In seasonally adjusted terms, goods and services credits rose $\$ 371 \mathrm{~m}(2 \%)$ to $\$ 18,047 \mathrm{~m}$. Non-rural goods rose $\$ 270 \mathrm{~m}$ (3\%), other goods rose $\$ 75 \mathrm{~m}$ ( $8 \%$ ) and rural goods rose $\$ 8 \mathrm{~m}$. Services credits rose $\$ 18 \mathrm{~m}$.

GOODS CREDITS

(a) Trend breaks of $\$ 300 \mathrm{~m}$ to April 2004, $\$ 600 \mathrm{~m}$ to April 2005 and $\$ 150 \mathrm{~m}$ to April 2006 have been applied

RURAL GOODS
The trend estimate of rural goods exports rose $\$ 17 \mathrm{~m}(1 \%)$ to $\$ 2,250 \mathrm{~m}$.

In seasonally adjusted terms, exports of rural goods rose $\$ 8 \mathrm{~m}$ to $\$ 2,236 \mathrm{~m}$.
The components contributing to the rise in the seasonally adjusted estimates were:

- other rural, up $\$ 56 \mathrm{~m}$ ( $6 \%$ )
- meat and meat preparations, up $\$ 23 \mathrm{~m}$ (4\%).

Largely offsetting these effects was cereal grains and cereal preparations, down \$65m (13\%).

In original terms, exports of rural goods rose $\$ 13 \mathrm{~m}(1 \%)$ to $\$ 2,296 \mathrm{~m}$.

NON-RURAL GOODS
The trend estimate of non-rural goods exports rose $\$ 26 \mathrm{~m}$ to $\$ 10,956 \mathrm{~m}$.
In seasonally adjusted terms, exports of non-rural goods rose $\$ 270 \mathrm{~m}(3 \%)$ to $\$ 10,979 \mathrm{~m}$.

The components contributing to the rise in the seasonally adjusted estimates were:

- metal ores and minerals, up $\$ 168 \mathrm{~m}$ (6\%), with the largest increases, in original terms, occurring in iron ore and alumina, both largely on increased volumes
- other mineral fuels, up $\$ 110 \mathrm{~m}$ (9\%)
- metals (excl. gold), up $\$ 106 \mathrm{~m}$ (9\%)
- transport equipment, up $\$ 97 \mathrm{~m}$ (27\%).

Exports of goods continued NON-RURAL GOODS continued

Partly offsetting these effects were:

- other non-rural, down $\$ 119 \mathrm{~m}$ (10\%)
- coal, coke and briquettes, down $\$ 68 \mathrm{~m}$ (4\%).

In original terms, exports of non-rural goods rose $\$ 413 \mathrm{~m}(4 \%)$ to $\$ 11,459 \mathrm{~m}$.

OTHER GOODS
The trend estimate of other goods exports fell $\$ 61 \mathrm{~m}(6 \%)$ to $\$ 986 \mathrm{~m}$.
In seasonally adjusted terms, exports of other goods rose $\$ 75 \mathrm{~m}$ (8\%) to $\$ 1,042 \mathrm{~m}$.

The component contributing to the rise in the seasonally adjusted series was non-monetary gold, up $\$ 130 \mathrm{~m}$ (16\%).

Partly offsetting this effect were:

- goods for processing, down \$31m (86\%)
- goods procured in ports by carriers, down $\$ 24 \mathrm{~m}$ (20\%).

In original terms, exports of other goods rose $\$ 73 \mathrm{~m}(7 \%)$ to $\$ 1,050 \mathrm{~m}$.

Exports of services
SERVICES CREDITS


In trend terms, services credits rose $\$ 22 \mathrm{~m}$ (1\%) to $\$ 3,779 \mathrm{~m}$.

Seasonally adjusted, services credits rose $\$ 18 \mathrm{~m}$ to $\$ 3,790 \mathrm{~m}$.
All components contributed to the rise in the seasonally adjusted series with:

- other services, up $\$ 12 \mathrm{~m}$ (1\%)
- transportation services, up $\$ 5 \mathrm{~m}$ (1\%)
- travel services, up $\$ 1 \mathrm{~m}$.

Seasonally adjusted, tourism related services credits rose $\$ 3 \mathrm{~m}$ to $\$ 2,410 \mathrm{~m}$.

IMPORTS OF GOODS AND SERVICES

The trend estimate of goods and services debits rose $\$ 58 \mathrm{~m}$ between September and October to $\$ 18,712 \mathrm{~m}$.

In seasonally adjusted terms, goods and services debits rose $\$ 906 \mathrm{~m}(5 \%)$ to $\$ 19,310 \mathrm{~m}$. Other goods rose $\$ 336 \mathrm{~m}(58 \%)$, consumption goods rose $\$ 240 \mathrm{~m}$ ( $5 \%$ ), capital goods rose $\$ 161 \mathrm{~m}(5 \%)$ and intermediate and other merchandise goods rose $\$ 123 \mathrm{~m}(2 \%)$. Services debits rose $\$ 46 \mathrm{~m}$ (1\%).

## Imports of goods

GOODS DEBITS

## CONSUMPTION GOODS

The trend estimate of imports of consumption goods rose $\$ 23 \mathrm{~m}(1 \%)$ to $\$ 4,506 \mathrm{~m}$.
In seasonally adjusted terms, imports of consumption goods rose $\$ 240 \mathrm{~m}$ (5\%)
to $\$ 4,635 \mathrm{~m}$.

The main components contributing to the rise in the seasonally adjusted estimates were:

- non-industrial transport equipment, up $\$ 133 \mathrm{~m}$ (11\%)
- household electrical items, up \$53m (14\%)
- consumption goods n.e.s., up $\$ 50 \mathrm{~m}(4 \%)$.

In original terms, imports of consumption goods rose $\$ 458 \mathrm{~m}(10 \%)$ to $\$ 5,270 \mathrm{~m}$.

## CAPITAL GOODS

The trend estimate of imports of capital goods rose $\$ 29 \mathrm{~m}(1 \%)$ to $\$ 3,296 \mathrm{~m}$.

In seasonally adjusted terms, imports of capital goods rose $\$ 161 \mathrm{~m}$ (5\%) to $\$ 3,441 \mathrm{~m}$.
The main components contributing to the rise in the seasonally adjusted estimates were:

- machinery and industrial equipment, up $\$ 157 \mathrm{~m}$ (13\%)
- ADP equipment, up $\$ 66 \mathrm{~m}$ (12\%).

Partly offsetting these effects were:

- civil aircraft, down $\$ 42 \mathrm{~m}$
- capital goods n.e.s., down $\$ 20 \mathrm{~m}$ (4\%).

In original terms, imports of capital goods rose $\$ 350 \mathrm{~m}$ (11\%) to $\$ 3,649 \mathrm{~m}$.

## ANALYSIS AND COMMENTS continued

INTERMEDIATE AND OTHER MERCHANDISE GOODS
The trend estimate of imports of intermediate and other merchandise goods fell $\$ 4 \mathrm{~m}$ to $\$ 6,609 \mathrm{~m}$.

In seasonally adjusted terms, imports of intermediate and other merchandise goods rose $\$ 123 \mathrm{~m}$ (2\%) to $\$ 6,669 \mathrm{~m}$.

The main components contributing to the rise in the seasonally adjusted estimates were:

- primary industrial supplies n.e.s., up \$81m (79\%)
- iron and steel, up $\$ 38 \mathrm{~m}$ ( $13 \%$ )
- parts for transport equipment, up $\$ 37 \mathrm{~m}(5 \%)$
- other parts for capital goods, up $\$ 21 \mathrm{~m}(2 \%)$.

Partly offsetting these effects were:

- other merchandise goods, down $\$ 42 \mathrm{~m}(30 \%)$
- paper and paperboard, down $\$ 23 \mathrm{~m}$ (11\%).

In original terms, intermediate and other merchandise goods rose $\$ 246 \mathrm{~m}$ (4\%) to $\$ 6,853 \mathrm{~m}$.

OTHER GOODS
The trend estimate of imports of other goods fell $\$ 6 \mathrm{~m}(1 \%)$ to $\$ 670 \mathrm{~m}$.
In both original and seasonally adjusted terms, other goods imports rose $\$ 336 \mathrm{~m}$ (58\%) to $\$ 916 \mathrm{~m}$.

The main component contributing to the rise in the estimates was non-monetary gold, up $\$ 317 \mathrm{~m}$ ( $74 \%$ ).

Imports of services
SERVICES DEBITS


In trend terms, services debits rose $\$ 16 \mathrm{~m}$ to $\$ 3,631 \mathrm{~m}$
Seasonally adjusted, services debits rose $\$ 46 \mathrm{~m}$ (1\%) to $\$ 3,649 \mathrm{~m}$.
The components contributing to the rise in the seasonally adjusted estimates were:

- transportation services, up $\$ 53 \mathrm{~m}$ (4\%), with freight transportation services up $\$ 56 \mathrm{~m}$ (9\%)
- other services, up $\$ 16 \mathrm{~m}$ (2\%)

Partly offsetting these effects was travel services, down $\$ 23 \mathrm{~m}$ (2\%).

Seasonally adjusted, tourism related services debits fell $\$ 63 \mathrm{~m}$ (3\%) to $\$ 1,857 \mathrm{~m}$.

SEASONAL ADJUSTMENT

TREND ESTIMATES

1 This publication presents preliminary estimates of Australia's international trade in goods and services on a balance of payments basis and merchandise import and export statistics on a recorded trade basis.

2 Merchandise trade statistics on a recorded trade basis are compiled from information submitted by exporters and importers or their agents to the Australian Customs Service (ACS). Adjustments for coverage, timing and valuation are made to recorded trade data to convert them to a balance of payments basis. The main source for services data is the quarterly Survey of International Trade in Services.

3 More comprehensive quarterly estimates of Australia's trade in goods and services, together with comprehensive details of Australia's balance of payments are included in the quarterly publication, Balance of Payments and International Investment Position, Australia (cat. no. 5302.0). Detailed monthly statistics on merchandise trade are available on AusStats or by subscription to tailored services.

4 The conceptual framework used in compiling Australia's merchandise trade statistics can be found in International Merchandise Trade, Australia: Concepts, Sources and Methods, 2001 (cat. no. 5489.0).

5 The conceptual framework used in compiling Australia's balance of payments statistics is based on the Fifth Edition of the International Monetary Fund's Balance of Payments Manual (BPM5,1993). Descriptions of the underlying concepts and structure of the balance of payments and the sources, methods and terms used in compiling the estimates are presented in Balance of Payments and International Investment Position, Australia: Concepts, Sources and Methods, 1998 (cat. no. 5331.0). To bring merchandise trade statistics on a recorded trade basis to a balance of payments basis, timing adjustments are made to ensure that the transaction is recorded in the period in which ownership changed, rather than in the period in which the transaction was recorded by ACS. Adjustments are also made to imports to take account of distortions which arise when significant changes occur in the volume of import entries lodged but not yet processed by ACS in a given month. Chapter 6 of cat. no. 5331.0 provides more detail on the relationship between statistics on international merchandise trade on a recorded trade basis and on a balance of payments basis.

6 Both of the Concepts, Sources and Methods publications are available to download for free from the ABS website. Select Methods, Classifications, Concepts $\&$ Standards, then choose ABS concepts, classifications and statistical standards and then the catalogue numbers as above.

7 Monthly original estimates are volatile, being subject to calendar-related and large irregular influences. Seasonally adjusted estimates are derived by estimating and removing systematic calendar related effects, such as seasonal and trading day influences, from the original series. Trading day effects are removed from the original estimates prior to the seasonal adjustment process. Seasonal adjustment does not aim to remove the irregular or non-seasonal influences which may be present in any particular month. These irregular influences may reflect both random economic events and difficulties of statistical recording. The estimates of international trade in goods and services on a balance of payments basis are seasonally adjusted. The merchandise exports and imports statistics on a recorded trade basis are not.

8 The month-to-month movements of the seasonally adjusted estimates may not be reliable indicators of trend behaviour because they include irregular or non-seasonal movements. Trend estimates are derived by applying a 13-term Henderson moving average to the seasonally adjusted series. The use of a 13 -term Henderson average can result in revisions to the estimates for the most recent six months as additional

observations become available. Revisions can also occur because of changes in the original data and as a result of the annual re-estimation of the seasonal factors.

9 In keeping with balance of payments conventions, where statistics are on a balance of payments basis, credit entries (exports) are shown without sign and debit items (imports) are shown as negative entries. For statistics on a recorded trade basis, both imports and exports are shown without sign. The calculation of percentage changes on balance of payments debit items are made without regard to sign. References to balance of payments debit items in Key Figures, Key Points, and Analysis and Comments are also made without regard to sign.

10 For details of the classification used for goods exports on a balance of payments basis (credits), see table 6.6 in Balance of Payments and International Investment Position, Australia: Concepts, Sources and Methods, 1998 (cat. no. 5331.0).
11 Details of the classification of goods imports on a balance of payments basis (debits) are provided in table 6.7 in cat. no. 5331.0. Goods debits sub groups at a more detailed level than shown in Table 4 are available from the Time series spreadsheets.

12 The recorded trade statistics shown in tables 12 and 13 are classified by the Standard International Trade Classification 2 (SITC). The first section of tables 12 and 13 show the most significant commodities (by value) at the SITC 3 digit level.

13 The quarterly detailed services data published in table 11 are consistent with the monthly aggregates shown in table 9 .

14 Monthly indicators for many of the services components that are only surveyed quarterly are not available. In particular, the Freight and Other transportation components of Total services credits are not available for publication on a monthly basis. The estimates for these items shown in table 9 are therefore derived by dividing the quarterly estimate by three. Where quarterly survey data are not available, freight debits are derived directly from imports data for the reference month as a difference between total merchandise cost, insurance and freight (CIFE) and free on board (FOB), adjusted to reflect timing and processing adjustments. For freight credits and other transportation credits and debits, estimates are derived by extrapolating the last month's data by an average of movements for the same month over the three previous years.

15 The tourism related services memorandum items provide timely indicators of the movements in tourism related activities, not an absolute measure of the level of these activities. These series are not complied on a balance of payments conceptual basis. However, they do provide a reasonable approximation of world tourism related activities.

16 The memorandum items have been derived by re-aggregating relevant components of the international trade in services series of the balance of payments accounts. The tourism related indicator has been derived by combining total travel services (business, education-related and other personal travel), passenger fares, and the air transport component of other transportation services which relates to agency fees and commission receipts

17 Annual services data by state and by partner country are released twice yearly. Calendar year data are released with the March issue of this publication and financial year data are released with the September issue. The data are available from Time series spreadsheets and data cubes.

18 Services credits are classified by the state of provision, while services debits are classified by the state of consumption. The state allocations for transportation, travel and communication services are based on a number of indicators including merchandise trade statistics by state, overseas passenger arrivals and departures by state of clearance

and data provided by the Department of Education, Science and Training. The allocation for other services (about $25 \%$ of all trade in services) is primarily based on the location of the business reporting the information, which serves as a proxy for the state of provision/consumption of that service. The data should be used with care but are considered suitable for analysis over time.

19 A comprehensive explanation of the data sources used and the methodology applied in the compilation of partner country statistics is provided in Chapter 17 of Balance of Payments and International Investment Position, Australia - Concepts, Sources and Methods (cat. no. 5331.0). Approximately $8 \%$ of total services credits and $6 \%$ of total services debits for 2004-05 are either confidential, or unable to be allocated to individual countries.

20 More detailed balance of payments and recorded merchandise trade data, including forward seasons factors are available as time series spreadsheets from the ABS website.
