NOTES

ABOUT THIS PUBLICATION

This publication presents information about the nature of employment arrangements in the Australian workforce. It also presents information about different types of employment which can be cross-classified by characteristics such as hours worked, industry and occupation and demographic characteristics.

The statistics in this publication were compiled from data collected in the Forms of Employment Survey, conducted throughout Australia in November 2006 as a supplement to the Australian Bureau of Statistics (ABS) monthly Labour Force Survey (LFS). Questions were asked about employment arrangements in the main job of all employed people, except those who were contributing family workers in their main job.

NOTES ABOUT THE ESTIMATES

In this publication there is a substantial increase in the number of people who worked on a contract basis. This was due to a change in the number of people being asked "Do you work on a contract?". In 2006, all employed people were asked if they worked on a contract basis. In previous Forms of Employment surveys, employed people who received both paid sick and paid holiday leave were not asked if they worked on a contract basis. This change resulted in an additional 857,900 people who were found to be working on a contract basis. Users need to exercise care when comparing the number of people who worked on a contract basis in this publication with previous releases.

From 2006, occupation data are classified according to the *ANZSCO—Australian and New Zealand Standard Classification of Occupations, First Edition, 2006* (cat. no. 1220.0). The new classification replaces the *ASCO—Australian Standard Classification of Occupations, Second Edition, 1997* (cat. no. 1220.0). Data classified according to the ASCO are available on request.

Also from 2006, industry data are classified according to the *ANZSIC—Australian and New Zealand Standard Industrial Classification*, 2006 (cat. no. 1292.0). This new classification replaces the *ANZSIC—Australian and New Zealand Standard Industrial Classification*, 1993 (cat. no. 1292.0). Data classified according to the ANZSIC 1993 are available on request.

As estimates have been rounded, discrepancies may occur between sums of the component items and totals.

CONCEPTUAL FRAMEWORK


INTRODUCTION

Australia's workforce continues to change. There is an increasing diversity of employment arrangements, more flexible working time patterns, and significant increases in the extent of part-time and casual employment.

The Forms of Employment Survey provides information on some of the key factors relating to the nature of employment arrangements in the Australian labour market. The survey also describes some of the employment and demographic characteristics of people in different employment types.

THE FRAMEWORK

The conceptual framework classifies jobholders to an employment type category on the basis of their main job, that is, the job in which the most hours are usually worked. Under this framework, owner managers of incorporated enterprises (OMIEs) are presented separately from other employees. Employees (excluding OMIEs) are classified according to their paid leave entitlements.

SUMMARY OF FINDINGS

OVERVIEW

In November 2006, there were 10.1 million employed people aged 15 years and over. Of these, 61% (6.2 million) were employees (excluding owner managers of incorporated enterprises (OMIEs)) with paid leave entitlements. Of the remaining employed people:

- 2.1 million were employees (excluding OMIEs) without paid leave entitlements
- 673,700 were OMIEs
- 1.2 million were owner managers of unincorporated enterprises (OMUEs).

EMPLOYMENT TYPE

Employees (excluding OMIEs) with paid leave entitlements

Of the 6.2 million people who were employees (excluding OMIEs) with paid leave entitlements, 54% were men. Sixty-eight percent of employees (excluding OMIEs) actually worked 35 hours or more in their main job in the reference week. The industry with the highest proportion of employees (excluding OMIEs) with paid leave entitlements was Public administration and safety (90%). Twelve percent of employees (excluding OMIEs) with paid leave entitlements were in the Health care and social assistance industry, and a further 12% were in the Manufacturing industry. Just under one quarter (24%) of employees (excluding OMIEs) with paid leave entitlements were Professionals.

Employees (excluding OMIEs) without paid leave entitlements

About 75% of employees (excluding OMIEs) without paid leave entitlements worked less than 35 hours in their main job in the reference week, while 37% worked less than 15 hours. Of employees (excluding OMIEs) without paid leave entitlements, 56% were women, 21% worked in the Retail trade industry, while 23% were Labourers.

Owner managers of incorporated enterprises

Approximately 69% of OMIEs actually worked 35 hours or more in their main job in the reference week, while 40% worked 49 hours or more. This compares with 12% of employees (excluding OMIEs) who worked 49 hours or more. Other characteristics of OMIEs in November 2006 included:

- 71% were men
- 31% were aged 45–54 years
- 18% worked in the Construction industry and 14% worked in the Professional, scientific and technical services industry
- 36% were Managers and 20% were Professionals.

Owner managers of unincorporated enterprises

An estimated 12% of employed people were OMUEs in their main job. Of these, 59% actually worked 35 hours or more in their main job in the reference week, while 31% worked 49 hours or more. Other characteristics of OMUEs in November 2006 included:

- 67% were men
- 21% worked in the Construction industry and 14% worked in the Agriculture, forestry and fishing industry
- 26% were Managers and 25% were Technicians and trades workers.


SUMMARY OF FINDINGS continued

EMPLOYED PEOPLE

Continuous duration with current employer/business

Twenty-four percent of employed people had been with their employer/business for 10 years or more.

EMPLOYED PEOPLE, Continuous duration with current employer/business—By employment type



Owner managers and employees (excluding OMIEs) with paid leave entitlements most commonly reported that they had been with their current employer/business for ten years or more. In contrast, nearly half (46%) of employees (excluding OMIEs) without paid leave entitlements had been with their current employer/business for less than one year.

Expected future duration with current employer/business

Most (90%) employed people in November 2006 expected to be with their current employer or business in 12 months time.

Of employees (excluding OMIEs) without paid leave entitlements, 22% did not expect to be with their current employer in 12 months time. This compares with 7.6% of employees (excluding OMIEs) with paid leave entitlements, 5.7% of OMUEs, and 3.2% of OMIEs.

Hours actually worked in main job

Just under one-quarter (24%) of employed people actually worked 45 hours or more in their main job in the reference week. Of these, 61% were employees (excluding OMIEs) with paid leave entitlements and 33% were owner managers.

SUMMARY OF FINDINGS continued

Worked on a contract basis

There were 1.5 million employed people who worked on a contract basis in November 2006. Of these, 1.1 million were employees (excluding OMIEs), of which 16% worked in the Health care and social assistance industry, 16% worked in Education and training and a further 9.8% worked in the Retail trade industry. Almost one-third (32%) of employees (excluding OMIEs) who said they worked on a contract basis were Professionals, followed by Clerical and administrative workers (14%). Fifty-two percent of employees (excluding OMIEs) who worked on a contract basis were women.

More than one-third (36%) of the 409,800 owner managers who worked on a contract basis worked in the Construction industry and 15% worked in the Professional, scientific and technical services industry. Of owner managers who worked on a contract basis, 34% were Technicians and trades workers and 20% were Professionals. Eighty percent of owner managers who worked on a contract basis were men.

EMPLOYEES (excluding OMIEs)

The majority (89%) of employees (excluding OMIEs) without paid leave entitlements considered their main job to be casual (92% of women and 85% of men).

Full-time workers in main job

An estimated 62% of employees (excluding OMIEs) were full-time workers in their main job. Most employees who were full-time workers in their main job had paid leave entitlements (89%). The industry group in which the highest proportion of them had paid leave entitlements was Financial and insurance services (97%) followed by Education and training (95%). The occupation where they were most likely to have paid leave entitlements was Managers (95%). The industry group in which the highest proportion were without paid leave entitlements was Agriculture, forestry and fishing (36%) followed by Accommodation and food services (27%). The occupation group where the highest proportion were without paid leave entitlements was Labourers (29%).


Part-time workers in main job

Approximately 38% of employees (excluding OMIEs) were part-time workers in their main job. Just over half of employees who were part-time workers in their main job had paid leave entitlements (52%). The industry group in which the highest proportion of them had paid leave entitlements was Electricity, gas, water and waste services (87%) followed by Mining (85%). The occupation group with the highest proportion was Managers (76%). The industry group in which the highest proportion were without paid leave entitlements was Accommodation and food services (83%) followed by Agriculture, forestry and fishing (76%). The occupation group where the highest proportion were without paid leave entitlements was Sales workers (71%).

SUMMARY OF FINDINGS continued

Length of set employment completion date/event from the date of interview There were 526,600 employees (excluding OMIEs) whose employment had a set completion date/event. Of these 72% had paid leave entitlements in their main job.

There were 146,000 employees (excluding OMIEs) who were without paid leave entitlements and their employment had a set completion date/event. Of these, 92% had a set completion date/event of less than one year from the date of interview. There were 380,600 employees (excluding OMIEs) who were with paid leave entitlements and their employment had a set completion date/event. Of these, 36% had a set completion date/event of one year or more from the date of interview.

Worked on a fixed-term contract

There were 287,100 employees (excluding OMIEs) with paid leave entitlements who worked on a fixed-term contract. Of these, 79% expected their contract to be renewed upon completion. In comparison, there were 91,800 employees (excluding OMIEs) without paid leave entitlements who worked on a fixed-term contract. Of these, 60% expected their contract to be renewed upon completion.

EXPLANATORY NOTES

INTRODUCTION

- **1** The statistics in this publication were compiled from data collected in the Forms of Employment Survey, conducted throughout Australia in November 2006 as a supplement to the monthly Labour Force Survey (LFS). Respondents to the LFS who fell within the scope of the supplementary survey were asked further questions.
- **2** The publication *Labour Force, Australia* (cat. no. 6202.0) contains information about survey design, sample redesign, scope, coverage and population benchmarks relevant to the monthly LFS, which also apply to supplementary surveys. It also contains definitions of demographic and labour force characteristics, and information about telephone interviewing which are relevant to both the monthly LFS and supplementary surveys.

CONCEPTS SOURCES AND METHODS

3 The conceptual framework used in Australia's LFS aligns closely with the standards and guidelines set out in Resolutions of the International Conference of Labour Statisticians. Descriptions of the underlying concepts and structure of Australia's labour force statistics, and the sources and methods used in compiling these estimates, are presented in *Labour Statistics: Concepts, Sources and Methods* (cat. no. 6102.0.55.001) which is available on the ABS web site http://www.abs.gov.au (Methods, Classifications, Concepts & Standards).

SCOPE

- **4** The scope of the LFS is restricted to people aged 15 years and over and excludes the following people:
 - members of the permanent defence forces
 - certain diplomatic personnel of overseas governments, customarily excluded from the census and estimated populations
 - overseas residents in Australia
 - members of non-Australian defence forces (and their dependants).
- **5** Students at boarding schools, patients in hospitals, residents of homes (e.g. retirement homes, homes for people with disabilities), and inmates of prisons are excluded from all supplementary surveys.
- **6** This supplementary survey was conducted in both urban and rural areas in all states and territories, but excluded approximately 120,000 people living in very remote parts of Australia who would otherwise have been within the scope of the survey. The exclusion of these people will have only a minor impact on any aggregate estimates produced for individual states and territories, except the Northern Territory where such people account for around 23% of the population.
- **7** This survey was restricted to employed people aged 15 years and over who were not contributing family workers in their main job.
- **8** The estimates in this publication relate to people covered by the survey in November 2006. In the LFS, coverage rules are applied which aim to ensure that each person is associated with only one dwelling and hence has only one chance of selection in the survey. See *Labour Force, Australia* (cat. no. 6202.0) for more details.
- **9** Supplementary surveys are not always conducted on the full LFS sample. Since August 1994 the sample for supplementary surveys has been restricted to no more than seven-eighths of the LFS sample.
- 10 The initial sample for the November 2006 LFS consisted of 41,569 private dwelling households and special dwelling units. Of the 33,823 private dwelling households and special dwelling units that remained in the survey after sample loss (e.g. households selected in the survey which had no residents in scope for the LFS, vacant or derelict dwellings and dwellings under construction), approximately 31,797 or 94% were fully responding to the Forms of Employment survey. obtained from these private dwelling households and special dwelling units (after taking into account scope, coverage and subsampling exclusions) was 33,404.

RELIABILITY OF THE ESTIMATES

- **11** Estimates in this publication are subject to sampling and non-sampling errors:
 - Sampling error is the difference between the published estimate and the value that would have been produced if all dwellings had been included in the survey. For more information see the Technical Note.
 - Non-sampling errors are inaccuracies that occur because of imperfections in reporting by respondents and interviewers and errors made in coding and processing data. These inaccuracies may occur in any enumeration, whether it be a full count or a sample. Every effort is made to reduce the non-sampling error to a minimum by careful design of questionnaires, intensive training and supervision of interviewers and effective processing procedures.

SEASONAL FACTORS

12 The estimates are based on information collected in the survey month, and, due to seasonal factors, may not be representative of other months of the year.

CLASSIFICATIONS USED

- **13** Country of birth data are classified according to the *Standard Australian Classification of Countries (SACC)*, *1998* (cat. no. 1269.0).
- **14** From 2006, occupation data are classified according to the *ANZSCO—Australian* and *New Zealand Standard Classification of Occupations, First Edition, 2006* (cat. no. 1220.0). This new classification replaces the *ASCO—Australian Standard Classification* of *Occupations, Second Edition, 1997* (cat. no. 1220.0). Data classified according to the ASCO are available on request.
- **15** Also from 2006, industry data are classified according to the *ANZSIC—Australian* and *New Zealand Standard Industrial Classification*, 2006 (cat. no. 1292.0). This new classification replaces the *ANZSIC—Australian and New Zealand Standard Industrial Classification*, 1993 (cat. no. 1292.0). Data classified according to the ANZSIC 1993 are available on request.

NOTES ON ESTIMATES

16 People who were away from work during the reference week were included in the 'Less than 1 hour/no hours' category for the data item 'Hours actually worked in main job'.

COMPARABILITY OF TIME SERIES

- 17 Revisions are made to population benchmarks for the LFS after each five-yearly Census of Population and Housing. The last such revision was made in February 2004 to take account of the results of the 2001 Census of Population and Housing. Estimates from supplementary surveys conducted from and including February 2004 are therefore based on revised population benchmarks.
- **18** In previous surveys, people who received both paid sick and paid holiday leave were not asked if they worked on a contract basis. In 2006, all employed people were asked if they worked on a contract basis. This change resulted in an additional 857,900 people who reported that they worked on a contract basis. Users need to exercise care when comparing the number of people who worked on a contract basis in this publication with previous releases.
- 19 The survey was redesigned in 2001 to reflect the changes in the Australian labour market that had occurred. This restricted the scope of the survey to people aged 15–69 years. From 2004 onwards, the scope includes all people aged 15 years and over, which aligns with the 1998 survey. Table 1 and Table 8 provide a time series of people aged 15–69 years. The remaining tables in the publication are based on the age scope of 15 years and over.
- **20** In 1998 and 2001, people working for payment in kind were excluded from the survey. From 2004 onwards this group have been included.

COMPARABILITY WITH
MONTHLY LFS STATISTICS

21 Due to differences in the scope and sample size of this supplementary survey and that of the monthly LFS, the estimation procedure may lead to some small variations between labour force estimates from this survey and those from the LFS.

PREVIOUS SURVEYS

- **22** This survey was first conducted in August 1998 then in November 2001, and November 2004. Results of previous surveys on employment arrangements have been published in:
 - Forms of Employment, Australia (cat.no.6359.0)

NEXT SURVEY

23 The ABS plans to conduct this survey again in November 2007.

TECHNICAL NOTE DATA QUALITY

INTRODUCTION

- 1 Since the estimates in this publication are based on information obtained from occupants of a sample of dwellings, they are subject to sampling variability. That is, they may differ from those estimates that would have been produced if all dwellings had been included in the survey. One measure of the likely difference is given by the standard error (SE), which indicates the extent to which an estimate might have varied by chance because only a sample of dwellings was included. There are about two chances in three (67%) that a sample estimate will differ by less than one SE from the number that would have been obtained if all dwellings had been included, and about 19 chances in 20 (95%) that the difference will be less than two SEs. Another measure of the likely difference is the relative standard error (RSE), which is obtained by expressing the SE as a percentage of the estimate.
- **2** Due to space limitations, it is impractical to print the SE of each estimate in the publication. Instead, a table of SEs is provided to enable readers to determine the SE for an estimate from the size of that estimate (see table T1). The SE table is derived from a mathematical model, referred to as the 'SE model', which is created using data from a number of past Labour Force Surveys. It should be noted that the SE model only gives an approximate value for the SE for any particular estimate, since there is some minor variation between SEs for different estimates of the same size.

CALCULATION OF STANDARD ERRORS

3 An example of the calculation and the use of SEs in relation to estimates of people is as follows. Table 2 shows that the estimated number of people in Australia who were owner managers of incorporated enterprises was 673,700. Since this estimate is between 500,000 and 1,000,000, table T1 shows the SE for Australia will be between 8,100 and 11,600 and can be approximated by interpolation using the following general formula:


SE of estimate

= 9.300 (rounded to the nearest 100)

$$= lower SE + \left(\left(\frac{size \ of \ estimate - lower \ estimate}{upper \ estimate - lower \ estimate} \right) \times (upper \ SE - lower \ SE) \right)$$

$$= 8,100 + \left(\left(\frac{673,700 - 500,000}{1,000,000 - 500,000} \right) \times (11,600 - 8,100) \right)$$

4 Therefore, there are about two chances in three that the value that would have been produced if all dwellings had been included in the survey will fall in the range 664,400 to 683,000, and about 19 chances in 20 that the value will fall within the range 655,100 to 692,300. This example is illustrated in the diagram below.



5 In general, the size of the SE increases as the size of the estimate increases. Conversely, the RSE decreases as the size of the estimate increases. Very small estimates are thus subject to such high RSEs that their value for most practical purposes is unreliable. In the tables in this publication, only estimates with RSEs of 25% or less are considered reliable for most purposes. Estimates with RSEs greater than 25% but less than or equal to 50% are preceded by an asterisk (e.g.*3.4) to indicate they are subject to high SEs and should be used with caution. Estimates with RSEs of greater than 50%, preceded by a double asterisk (e.g.**0.3), are considered too unreliable for general use

and should only be used to aggregate with other estimates to provide derived estimates with RSEs of 25% or less.

6 Proportions and percentages formed from the ratio of two estimates are also subject to sampling errors. The size of the error depends on the accuracy of both the numerator and the denominator. A formula to approximate the RSE of a proportion is given below. This formula is only valid when x is a subset of y.

$$RSE\left(\frac{x}{y}\right) = \sqrt{\left[RSE(x)\right]^2 - \left[RSE(y)\right]^2}$$

7 Considering the example above, of the 673,700 people who were owner managers of incorporated enterprises, 196,000 or 29.1% were women. The SE of 196,000 may be calculated by interpolation as 5,300. To convert this to an RSE we express the SE as a percentage of the estimate, or 5,300/196,000 = 2.7%. The SE for 673,700 was calculated previously as 9,300, which converted to an RSE is 9,300/673,700 = 1.4%. Applying the above formula, the RSE of the proportion is

$$RSE = \sqrt{(2.7)^2 - (1.4)^2} = 2.3\%$$

- **8** Therefore, the SE for the proportion of women who were owner managers of incorporated enterprises, is 0.7 percentage points (=(29.1/100)x2.3). Therefore, there are about two chances in three that the proportion of women who were owner managers of incorporated enterprises is between 28.4% and 29.8% and 19 chances in 20 that the proportion is within the range 27.7% to 30.5%.
- **9** Published estimates may also be used to calculate the difference between two survey estimates (of numbers or percentages). Such an estimate is subject to sampling error. The sampling error of the difference between two estimates depends on their SEs and the relationship (correlation) between them. An approximate SE of the difference between two estimates (x-y) may be calculated by the following formula: $SE(x-y) = \sqrt{[SE(x)]^2 + [SE(y)]^2}$
- **10** While this formula will only be exact for differences between separate and uncorrelated characteristics or subpopulations, it is expected to provide a good approximation for all differences likely to be of interest in this publication.

GLOSSARY

Continuous duration with current employer or business

The length of the current period of employment people had with their employer or in their own business. The length of time includes periods of paid leave, unpaid leave or strike.

Employed

People aged 15 years and over who, during the reference week:

- worked for one hour or more for pay, profit, commission or payment in kind, in a job or business or on a farm (comprising employees, employers and own account workers); or
- worked for one hour or more without pay in a family business or on a farm (i.e. contributing family workers); or
- were employees who had a job but were not at work and were:
 - away from work for less than four weeks up to the end of the reference week; or
 - away from work for more than four weeks up to the end of the reference week and received pay for some or all of the four week period to the end of the reference week; or
 - away from work as a standard work or shift arrangement; or
 - on strike or locked out; or
 - on workers' compensation and expected to return to their job; or
- were employers or own account workers who had a job, business or farm, but were not at work.

Contributing family workers in their main job were excluded from the survey.

Employees

People who:

- worked for a public or private employer; and
- received remuneration in wages, salary, or are paid a retainer fee by their employer and worked on a commission basis, or for tips or piece-rates or payment in kind; or
- operated their own incorporated enterprise with or without hiring employees.

Employers

People who operate their own unincorporated economic enterprise or engage independently in a profession or trade, and hire one or more employees.

Employment type

Classifies employed people according to the following employment type categories on the basis of their main job (that is, the job in which the most hours were usually worked):

- Employees (excluding OMIEs)
 - With paid leave entitlements
 - Without paid leave entitlements
- Owner managers of incorporated enterprises
- Owner managers of unincorporated enterprises.

Contributing family workers in their main job were excluded from the survey.

Fixed-term contract

A type of contract that will be terminated on a particular date/event.

Full-time workers in main job

Employed people who usually worked 35 hours or more a week (in main job) and others who, although usually worked less than 35 hours a week, worked 35 hours or more during the reference week. In this publication, full-time workers refers only to people who were full-time workers in their main job.

Holiday leave

Provision by an employer of paid holiday, vacation or recreation leave.

Hours actually worked

The number of hours actually worked during the reference week.

Hours usually worked

The number of hours usually worked in a week.

Industry of main job

In this publication, industry of main job refers to ANZSIC Division as classified according to the *Australian and New Zealand Standard Industrial Classification (ANZSIC)*, 2006 (cat. no. 1292.0).

Long Service Leave

Provision by an employer or industry body of long service leave.

countries America and New Zealand.

Main job The job in which the most hours were usually worked.

Maternity/paternity leave Provision by an employer of paid maternity/paternity leave.

Edition, 2006 (cat. no. 1220.0).

Own account workers People who operate their own unincorporated economic enterprise or engaged

Owner managers People who worked in their own business, with or without employees, whether or not

the business is of limited liability. Comprises owner managers of incorporated

enterprises and owner managers of unincorporated enterprises.

Owner managers of incorporated enterprises

People who work in their own incorporated enterprise, that is, a business entity which is registered as a separate legal entity to its members or owners (also known as a limited

liability company). These people are classified as employees under 'status in

employment'.

Owner managers of unincorporated enterprises

People who operate their own unincorporated enterprise, that is, a business entity in which the owner and the business are legally inseparable, so that the owner is liable for any business debts that are incurred. Includes those engaged independently in a trade or profession. These people are classified as employers under 'status in employment' if their

business has employees, or own account workers if they do not.

Part-time workers in main job Employed people who usually worked less than 35 hours a week (in main job) and who

did so during the reference week, or were not at work during the reference week. In this publication, part-time workers refers only to people who were part-time workers in their

main job.

Reference week The week preceeding the week in which the interview was conducted.

Self-identified casuals Employees (excluding OMIEs) who identified themselves as casual.

Sick leave Provision by an employer of paid sick leave.

With paid leave entitlements Employees (excluding OMIEs) who were entitled to either paid holiday leave or paid sick

leave or (or both) in their main job. People employed in their own business were not

asked questions about paid leave entitlements.

Without paid leave Employees (excluding OMIEs) who were not entitled to paid holiday leave or paid sick

leave, or did not know whether they were entitled to paid holiday leave or paid sick leave

in their main job.

Worked on a contract basis Employed people who were engaged by an organisation to provide a particular service or

undertake a particular task at an agreed price or rate, and generally for a specified

period.

Worked on a fixed-term

contract

entitlements

Employees (excluding OMIEs) with a contract of employment which specifies that the

employment will be terminated on a particular date/event.
