POPULATION OF ROBINVALE, VICTORIA

Council has for a long time held concerns that the population as reported in the ABS census data under represents the true population of this agricultural centre.

In response to Council's concerns, a study was commissioned and was undertaken by Geografia who looked at a number of other indicators of true population. Geografia have identified that there are between 7000 and 8800 people, estimated to be living in Robinvale, which is significantly more than the figure of 3359 as contained in the 2016 ABS census. Council provided the ABS with a copy of that report on 20 February this year but have not received any response in relation to the ABS's view of this work.

I write to strongly encourage the Australian Bureau of Statistics to review its census methodology for horticultural towns such as Robinvale, and to publish an interim finding in respect of Robinvale, more accurately reflecting the true population of this dynamic horticultural centre. Re: Correspondence 14 October 2020 – Population of Robinvale

Thank you for your letter concerning the population of Robinvale in the Swan Hill Rural City Council.

I apologise that you did not receive a response to the report that you provided in February this year. We are investigating what happened to your correspondence, but please be assured that the lack of response from the ABS was not intentional. We have now reviewed this report and other correspondence with your organisation in 2019.

You have asked that the ABS review its census methodology for horticultural towns such as Robinvale. The basis of your request is that the population that obtains services from Robinvale is substantially greater than the population that is reported, and this has implications for the levels of services that are needed.

As a key purpose of the Census is to collect information for the compilation of official population estimates, it is critical that the Census is conducted in a nationally consistent manner. It is for this reason that the ABS does not use different methodologies in different areas.

You note that Council is concerned that the population count reported in the 2016 census data does not adequately represent the full population that you service in Robinvale. The study commissioned by Geografia looked at a range of indicators of daily population. This report indicates that in areas like Robinvale where there is a high proportion of semi-permanent residents and seasonal workers, there can be a large difference between the service population and the estimated resident population (ERP) produced by the ABS.

The ERP is the official estimate of the Australian population and is based on place of usual residence within Australia, in keeping with international standards. Usual residence refers to that address at which the person has lived or intends to live for six months or more in a given reference year. The concept of usual residence is important so that each person is counted once and only once in Australia's population.

ERP is not intended to measure temporary populations and we have heard from stakeholders such as yourselves that there is also a need for an alternative measure. There are a range of regions around Australia that experience differences between their resident and service populations, including agricultural areas such as Robinvale with a seasonal workforce; fly in fly out workers to mining towns; and tourist areas such as coastal towns that experience higher demand during the warmer months. The ABS is currently undertaking a pilot project that explores aggregated telecommunications data at the Statistical Areas Level 2 (SA2) to estimate temporary populations. The project will provide insights into temporary populations and fluctuations from official population estimates as published in ERP. The ABS will continue to investigate the feasibility of estimating nonresident populations, subject to resources and accessibility to nationally consistent data sources.
