## BALANCE ON GOODS AND SERVICES

- In trend terms, the balance on goods and services was a deficit of $\$ 547 \mathrm{~m}$ in October 2013, a decrease of $\$ 126 \mathrm{~m}$ (19\%) on the deficit in September 2013.
- In seasonally adjusted terms, the balance on goods and services was a deficit of $\$ 529 \mathrm{~m}$ in October 2013, an increase of $\$ 258 \mathrm{~m}$ (95\%) on the deficit in September 2013.


## CREDITS (EXPORTS OF GOODS AND SERVICES)

- In seasonally adjusted terms, goods and services credits fell $\$ 26 \mathrm{~m}$ to $\$ 27,273 \mathrm{~m}$. Rural goods fell $\$ 80 \mathrm{~m}(3 \%)$ and non-rural goods fell $\$ 51 \mathrm{~m}$. Non-monetary gold rose $\$ 146 \mathrm{~m}(12 \%)$ and net exports of goods under merchanting rose $\$ 15 \mathrm{~m}$ (50\%). Services credits fell $\$ 57 \mathrm{~m}$ (1\%).


## DEBITS (IMPORTS OF GOODS AND SERVICES)

- In seasonally adjusted terms, goods and services debits rose $\$ 231 \mathrm{~m}(1 \%)$ to $\$ 27,802 \mathrm{~m}$. Intermediate and other merchandise goods rose $\$ 83 \mathrm{~m}$ (1\%), consumption goods rose $\$ 78 \mathrm{~m}$ (1\%), capital goods rose $\$ 23 \mathrm{~m}$ and non-monetary gold rose $\$ 1 \mathrm{~m}$. Services debits rose $\$ 48 \mathrm{~m}(1 \%)$.

## REVISIONS

REVISIONS
The following goods and services debits components have been revised since the release of the September 2013 issue of International Trade in Goods and Services, Australia (cat. no. 5368.0):

- capital goods n.e.s. component of goods debits series, revised back to July 2013
- legal, accounting, management consulting, public relations and other professional services component of services debits, revised back to July 2013.

Data in this issue aligns with the data in the September quarter 2013 issues of Balance of Payments and International Investment Position, Australia (cat. no. 5302.0) released on 3 December 2013, and Australian National Accounts: National Income, Expenditure and Product (cat. no. 5206.0) released on 4 December 2013.

Table 17 summarises revisions to goods and services on a balance of payments basis, in original current price terms, since the last issue of this publication. In original terms the revisions have increased the deficit on goods and services for the three months to September 2013 by $\$ 114 \mathrm{~m}$.

## CHANGES IN <br> FORTHCOMING ISSUES CHANGES TO EXPORT AND IMPORT STATISTICAL CODES

Information on Australia's major trading partners (top 10 countries) for the financial year 2012-13 has been included in this issue. This coincides with the release of data cubes International Trade in Services by Country, by State and by Detailed Services Category, Financial Year, 2012-13 (cat. no. 5368.0.55.003).

From this issue, the label for Australian port code 416 'Port Giles' which ceased to operate from June 2003 has been amended to 'Formerly Port Giles'. A new Australian port code 418 'Port Giles' became operative from January 2009. During the period July 2003 to December 2008, data for Port Giles were included in Australian port code 498 'Other ports SA'.

This change impacts on imports and export statistics available on request.

Statistical codes in the Australian Harmonized Export Commodity Classification (AHECC) and the Customs Tariff classifications will be revised with new codes coming into effect on 1 January 2014. The changes result from the introduction of new statistical codes separately identifying pharmaceuticals in Chapter 30 and carpet in Chapter 57. There are also statistical code changes in the Customs Tariff only identifying carpet underlay in Chapters 39 and 40 . The changes will not impact directly on the presentation of statistics in this publication but will impact on detailed import and export statistics available on request.

The Australian Harmonized Export Commodity Classification (AHECC) - Electronic Publication, Jan 2012 (cat. no. 1233.0) will be updated on the ABS website on 18 December 2013. Revised pages for the Customs Tariff will be re-issued shortly by the Australian Customs and Border Protection Service. Goods credits

Goods debits

International merchandise trade exports data presented in tables 12-15 of this publication are based on information provided by exporters to the Australian Customs and Border Protection Service (Customs and Border Protection). At the time of initial reporting to Customs and Border Protection, quantity and unit price information might be estimated for commodities such as iron ore and coal. Final quantity and/or unit price information is updated progressively in merchandise trade data as exporters revise the information provided to Customs and Border Protection. When additional information on quantity and/or unit price for these commodities is available, the ABS may adjust the balance of payments series in current price, original terms to reflect actual transaction values.

In most instances, transfer of ownership occurs when goods cross the customs frontier. In certain circumstances the ownership of large value capital expenditure items can occur prior to the items crossing the customs frontier. The ABS may adjust the relevant balance of payments series to record the timing when transfer of ownership was effected.

Iron ore (in original terms)

- a negative $\$ 40 \mathrm{~m}$ adjustment has been applied to the 'metal ores and minerals' component for October 2013. The previous negative $\$ 50 \mathrm{~m}$ adjustment applied to September 2013 remains.

Capital expenditure (in original terms)

- the 'capital goods n.e.s.' component includes an estimate of expenditure on capital goods that have changed ownership but have not yet crossed the customs frontier.

In trend terms, the balance on goods and services was a deficit of $\$ 547 \mathrm{~m}$ in October 2013, a decrease of $\$ 126 \mathrm{~m}(19 \%)$ on the deficit in September 2013.

In seasonally adjusted terms, the balance on goods and services was a deficit of $\$ 529 \mathrm{~m}$ in October 2013, an increase of $\$ 258 \mathrm{~m}$ (95\%) on the deficit in September 2013.

EXPORTS OF GOODS AND Between September and October 2013, the trend estimate of goods and services credits SERVICES

Exports of goods rose $\$ 236 \mathrm{~m}(1 \%)$ to $\$ 27,311 \mathrm{~m}$.

In seasonally adjusted terms, goods and services credits fell $\$ 26 \mathrm{~m}$ to $\$ 27,273 \mathrm{~m}$. Rural goods fell $\$ 80 \mathrm{~m}$ (3\%) and non-rural goods fell $\$ 51 \mathrm{~m}$. Non-monetary gold rose $\$ 146 \mathrm{~m}$ (12\%) and net exports of goods under merchanting rose $\$ 15 \mathrm{~m}(50 \%)$. Services credits fell $\$ 57 \mathrm{~m}$ (1\%).

GOODS CREDITS

RURAL GOODS
In trend terms, exports of rural goods fell $\$ 27 \mathrm{~m}$ (1\%) to $\$ 3,124 \mathrm{~m}$.
In seasonally adjusted terms, exports of rural goods fell $\$ 80 \mathrm{~m}(3 \%)$ to $\$ 3,047 \mathrm{~m}$.
The main component contributing to the fall in seasonally adjusted estimates was cereal grains and cereal preparations, down $\$ 118 \mathrm{~m}$ (17\%).

Partly offsetting this fall was the other rural component, up $\$ 58 \mathrm{~m}$ (4\%).

Exports of services

NON-RURAL GOODS
In trend terms, exports of non-rural goods rose $\$ 214 \mathrm{~m}(1 \%)$ to $\$ 18,334 \mathrm{~m}$.

In seasonally adjusted terms, exports of non-rural goods fell $\$ 51 \mathrm{~m}$ to $\$ 18,254 \mathrm{~m}$.
The main components contributing to the fall in seasonally adjusted estimates were:

- other mineral fuels, down $\$ 249 \mathrm{~m}$ (11\%)
- metal ores and minerals, down $\$ 59 \mathrm{~m}(1 \%)$.

Partly offsetting these falls was the coal, coke and briquettes component, up $\$ 243 \mathrm{~m}$ (7\%).

NET EXPORTS OF GOODS UNDER MERCHANTING
In trend terms, net exports of goods under merchanting rose $\$ 2 \mathrm{~m}(6 \%)$ to $\$ 37 \mathrm{~m}$.
In seasonally adjusted terms, net exports of goods under merchanting rose $\$ 15 \mathrm{~m}(50 \%)$ to $\$ 45 \mathrm{~m}$.

NON-MONETARY GOLD
In trend terms, exports of non-monetary gold rose $\$ 25 \mathrm{~m}(2 \%)$ to $\$ 1,256 \mathrm{~m}$.
In original and seasonally adjusted terms, exports of non-monetary gold rose $\$ 146 \mathrm{~m}$ (12\%) to $\$ 1,395 \mathrm{~m}$.

SERVICES CREDITS


In trend terms, services credits rose $\$ 22 \mathrm{~m}$ to $\$ 4,560 \mathrm{~m}$.

In seasonally adjusted terms, services credits fell $\$ 57 \mathrm{~m}$ (1\%) to $\$ 4,531 \mathrm{~m}$.
The main component contributing to the fall in seasonally adjusted estimates was travel, down $\$ 57 \mathrm{~m}$ (2\%).

In seasonally adjusted terms, tourism related services credits fell $\$ 53 \mathrm{~m}$ (2\%) to $\$ 2,885 \mathrm{~m}$.

IMPORTS OF GOODS AND SERVICES

## Imports of goods

GOODS DEBITS

(a) Trend breaks have been applied to January 2011,

July 2011 and January 2012

CONSUMPTION GOODS
In trend terms, imports of consumption goods rose $\$ 68 \mathrm{~m}(1 \%)$ to $\$ 6,961 \mathrm{~m}$.
In seasonally adjusted terms, imports of consumption goods rose $\$ 78 \mathrm{~m}(1 \%)$ to $\$ 6,888 \mathrm{~m}$.
The main component contributing to the rise in seasonally adjusted estimates was non-industrial transport equipment, up $\$ 128 \mathrm{~m}$ (8\%).

Partly offsetting this rise was the household electrical items component, down $\$ 34 \mathrm{~m}$ (8\%).

## CAPITAL GOODS

In trend terms, imports of capital goods fell $\$ 85 \mathrm{~m}(2 \%)$ to $\$ 5,441 \mathrm{~m}$.
In seasonally adjusted terms, imports of capital goods rose $\$ 23 \mathrm{~m}$ to $\$ 5,425 \mathrm{~m}$.
The main components contributing to the rise in seasonally adjusted estimates were:

- capital goods n.e.s., up $\$ 95 \mathrm{~m}$ (9\%)
- industrial transport equipment n.e.s., up $\$ 67 \mathrm{~m}$ (10\%).

Partly offsetting these rises were:

- machinery and industrial equipment, down $\$ 79 \mathrm{~m}$ (5\%)
- telecommunications equipment, down $\$ 41 \mathrm{~m}$ ( $6 \%$ ).


## ANALYSIS AND COMMENTS continued

In trend terms, imports of intermediate and other merchandise goods rose $\$ 122 \mathrm{~m}(1 \%)$ to $\$ 9,609 \mathrm{~m}$.

In seasonally adjusted terms, imports of intermediate and other merchandise goods rose $\$ 83 \mathrm{~m}$ (1\%) to $\$ 9,641 \mathrm{~m}$.

The main component contributing to the rise in seasonally adjusted estimates was fuels and lubricants, up \$314m (9\%).

Partly offsetting this rise were:

- parts for transport equipment, down $\$ 71 \mathrm{~m}(8 \%)$
- other parts for capital goods, down $\$ 47 \mathrm{~m}$ (4\%)
- processed industrial supplies n.e.s., down \$44m (2\%)
- primary industrial supplies n.e.s., down $\$ 40 \mathrm{~m}$ (31\%).


## NON-MONETARY GOLD

In trend terms, imports of non-monetary gold fell $\$ 11 \mathrm{~m}(3 \%)$ to $\$ 390 \mathrm{~m}$.

In original and seasonally adjusted terms, imports of non-monetary gold rose $\$ 1 \mathrm{~m}$ to $\$ 361 \mathrm{~m}$.

SERVICES DEBITS


In trend terms, services debits rose $\$ 15 \mathrm{~m}$ to $\$ 5,456 \mathrm{~m}$.

In seasonally adjusted terms, services debits rose $\$ 48 \mathrm{~m}(1 \%)$ to $\$ 5,488 \mathrm{~m}$.

The main components contributing to the rise in seasonally adjusted estimates were:

- travel, up $\$ 25 \mathrm{~m}$ (1\%)
- other services, up $\$ 20 \mathrm{~m}$ (1\%)

In seasonally adjusted terms, tourism related services debits rose $\$ 12 \mathrm{~m}$ to $\$ 2,786 \mathrm{~m}$.

Selected commodities
SELECTED COMMODITIES, Quantity and unit value analysis: International merchandise trade basis (a) - Original terms


On an international merchandise trade basis, in original terms (noting the footnote in the above table), between September and October 2013 the largest movements recorded for the following selected commodities were:

Iron ore lump rose $\$ 9 \mathrm{~m}$ (1\%), with quantities up $5 \%$ and unit values down $5 \%$.
Exports to:

- China rose $\$ 165 \mathrm{~m}$ (17\%), with quantities up $21 \%$ and unit values down $4 \%$.

Partly offsetting this rise were exports to:

- Japan, down $\$ 89$ m (22\%), with quantities down $15 \%$ and unit values down $9 \%$
- the Republic of Korea, down $\$ 52 \mathrm{~m}$ (40\%), with quantities down $38 \%$ and unit values down 3\%.


## ANALYSIS AND COMMENTS continued

Selected commodities continued

Iron ore fines fell $\$ 59 \mathrm{~m}(1 \%)$, with quantities up $2 \%$ and unit values down $3 \%$. Exports to:

- the Republic of Korea fell $\$ 212$ m (41\%), with quantities down $37 \%$ and unit values down 7\%
- Japan fell $\$ 76$ m (17\%), with quantities down $11 \%$ and unit values down $8 \%$.

Partly offsetting these falls was exports to China, up $\$ 254 \mathrm{~m}$ (7\%), with quantities up 9\% and unit values down 2\%.

Hard coking coal rose $\$ 80 \mathrm{~m}$ (6\%), with quantities up $7 \%$ and unit values down $1 \%$. Exports to:

- China rose $\$ 79 \mathrm{~m}$ (27\%), with quantities up $25 \%$ and unit values up $2 \%$.

Semi-soft coal rose $\$ 45 \mathrm{~m}$ (7\%), with quantities up $8 \%$ and unit values down $1 \%$.
Exports to:

- Japan rose $\$ 43 \mathrm{~m}(22 \%)$, with quantities up $31 \%$ and unit values down $7 \%$.

Thermal coal rose $\$ 120 \mathrm{~m}$ (9\%), with quantities up $12 \%$ and unit values down $3 \%$. Exports to:

- the Republic of Korea rose $\$ 116 \mathrm{~m}$ (82\%), with quantities up $86 \%$ and unit values down $2 \%$.

COUNTRY BREAKDOWN
The following charts show Australia's major trading partners for the financial year 2012-13. The charts include both trade in goods (on an international merchandise trade basis) and trade in services (on a balance of payments basis). The first chart shows the countries with the largest two-way trade i.e. combined trade in both exports and imports of goods and services. The second chart shows separately total exports and total imports, for the ten countries in the first chart.

EXPORTS AND IMPORTS OF GOODS AND SERVICES, By major countries - 2012-13


Combining trade in goods (on an international merchandise trade basis) and trade in services (on a balance of payments basis) provides a good approximation of total trade. Some components will be excluded (e.g. Merchanting credits and Goods procured in ports by carriers debits) while the Manufacturing services on physical inputs owned by others component, will be double counted. These components are unlikely to impact on the broad analysis.

From June 2013, exports data with the confidentiality restrictions 'no commodity details' or 'no value details' are now being excluded from the individual country and included in 'no country details'. These changes are presented in the detailed breakdown in the time series spreadsheet table 14a. In 2012-13, these restrictions represented $0.24 \%$ of the

total exports value. This figure will vary across individual countries. In table 14 of this publication, the 'no country details' data is included in 'other countries'.

1 This publication presents preliminary estimates of Australia's international trade in goods and services on a balance of payments basis (tables 1-11 and 17) and merchandise import and export statistics on an international merchandise trade basis (tables 12-15). In addition, table 16 Exchange rates and trade-weighted indexes (TWI) are derived by using exchange rates and indexes provided by the Reserve Bank of Australia (RBA). As of December 2011 the RBA has changed the methodology for compiling the TWI to include both merchandise and services trade, rather than merchandise trade only. This takes advantage of country-level services trade data that have been published by the Australian Bureau of Statistics (ABS).

2 Merchandise trade statistics on an international merchandise trade basis are compiled from information submitted by exporters and importers or their agents to the Australian Customs and Border Protection Service (Customs and Border Protection). Adjustments for coverage, timing and valuation are made to international merchandise trade data to convert them to a balance of payments basis. The services data are sourced from the quarterly Survey of International Trade in Services and a range of administrative data and indicator series.

3 More comprehensive quarterly estimates of Australia's trade in goods and services, together with comprehensive details of Australia's balance of payments are included in the quarterly publication, Balance of Payments and International Investment Position, Australia (cat. no. 5302.0). Detailed monthly statistics on merchandise trade are available in Time Series Spreadsheets on the ABS website or by subscription to tailored services. More information on the International Trade in Services by Country, by State and by Detailed Services Category are available on a financial year basis (cat. no. 5368.0.55.003) following the September issue of this publication and calendar year basis (cat. no. 5368.0.55.004) following the March issue of this publication.

4 The conceptual framework used in compiling Australia's merchandise trade statistics can be found in International Merchandise Trade, Australia: Concepts, Sources and Methods, 2001 (cat. no. 5489.0).

5 The conceptual framework used in compiling Australia's balance of payments statistics is based on the International Monetary Fund's Balance of Payments and International Investment Position Manual, Sixth Edition (BPM6). Descriptions of the underlying concepts and structure of the balance of payments and the sources, methods and terms used in compiling estimates are presented in the publication Balance of Payments and International Investment Position, Australia: Concepts, Sources and Methods, 1998 (cat. no. 5331.0). This version reflects the international standards prior to BPM6 and is currently being revised. The first part of the revised document was released on 8 March 2011, featuring only the Goods Account. Other components will be released as they become available. Further information on the key changes introduced with BPM6 can be found in the Information paper: Implementation of new international statistical standards in the ABS National and International Accounts, September 2009 (cat. no. 5310.0.55.002).
6 To bring merchandise trade statistics on an international merchandise trade basis to a balance of payments basis, timing adjustments are made to ensure that the transaction is recorded in the period in which ownership changed, rather than in the period in which the transaction was recorded by Customs and Border Protection or the period in which the goods arrived in/departed from an Australian port. Adjustments are also made to account for the change of ownership of goods not included in merchandise trade statistics. Chapter 6 of cat. no. 5331.0 provides more detail on the relationship between statistics on an international merchandise trade basis and on a balance of payments basis.

ACCURACY, RELIABILITY AND REVISIONS

7 International merchandise trade exports data presented for recent months in tables $12-15$ of this publication are based on information initially reported by exporters to Customs and Border Protection. At the time of initial reporting to Customs and Border Protection the final prices may not be known for some commodities. Therefore, the information recorded for recent months for commodities like iron ore and coal can include a variety of prices including previous or current contract prices and the prevailing spot prices. Newly negotiated contract prices may not be fully reflected in the data first reported to Customs and Border Protection, and to compensate for this, the balance of payments series may reflect adjusted price levels.

8 The Concepts, Sources and Methods publications and information papers are available to download for free from the ABS website. Select Statistics, then select By Catalogue Number, and then the catalogue numbers as above.

9 The merchandise trade data on an international merchandise trade basis are presented using the following commodity classifications:

- the Harmonized System 2012 (available on request)
- the Standard International Trade Classification (SITC Revision 4)
- the Classification by Broad Economic Categories (BEC)
- the industry classification: Australian and New Zealand Standard Industrial Classification, 2006 (ANZSIC 06) from July 2005.

10 The balance of payments 'goods and services' series are presented according to three classifications with the goods classifications derived from SITC Revision 4 and BEC. The classifications are:

- for goods:
- the Balance of Payments Commodities for Exports (BoPCE)
- the Balance of Payments Broad Economic Categories (BoPBEC) for Imports
- for services:
- the Extended Balance of Payments Services Classification (EBOPS).

11 While every effort is made to ensure the accuracy and reliability of estimates, most series are subject to revision as more complete and accurate information becomes available. Care should be exercised in the use and interpretation of estimates in this publication. The transactions occurring in international trade in goods and services are of many different kinds, and therefore the compilation of trade estimates entails the use of a very wide range of statistical data of varying degrees of accuracy and timeliness. For further information on the monthly services series, see paragraph 25 .

12 The revisions are applied differently for merchandise trade and balance of payments series. Each month, merchandise trade data are revised for the previous six months to incorporate latest available data.

13 For the balance of payments 'goods and services' series, in original terms, revisions in the July, October, January or April issues are limited to significant new and revised data from survey sources that have become available since the previous issue. This is to ensure the monthly series align with the comparable series in the most recent issue of the Balance of Payments and International Investment Position, Australia (cat. no. 5302.0). In the September issue revisions can be applied to the four previous financial years. In other issues revisions can be applied to the previous and current financial years to incorporate the latest available survey and administrative data.

14 In seasonally adjusted and trend terms, revisions may occur at any time point but tend to focus on the most recent estimates. Please also refer to paragraphs 17 and 18 (seasonal adjustment), and 19 (trend estimates) below.

SIGN CONVENTION

SEASONALLY ADJUSTED AND TREND ESTIMATES

15 In keeping with BPM6 conventions, balance of payments basis credit entries are shown with an implied positive sign and debit items are shown as negative entries. For statistics on an international merchandise trade basis, both imports and exports are shown without sign. The calculation of percentage changes on balance of payments debit items are made without regard to sign. References to balance of payments debit items in Key Figures, Key Points, and Analysis and Comments are also made without regard to sign.

16 The estimates of international trade in goods and services on a balance of payments basis are seasonally adjusted, however the merchandise exports and imports statistics on an international merchandise trade basis are not. Monthly original estimates are volatile, being subject to calendar-related and large irregular influences. Seasonally adjusted estimates are derived by estimating and removing from the original series systematic calendar related effects, such as seasonal (e.g. Christmas), trading day and moving holiday (e.g. Easter) influences. Seasonal adjustment does not aim to remove the irregular or non-seasonal influences which may be present in any particular month. These irregular influences may reflect both random economic events and difficulties of statistical recording.

17 The seasonally adjusted statistics in this publication use the concurrent seasonal adjustment technique and Autoregressive Integrated Moving Average (ARIMA) modelling to estimate factors for the current and previous months. Under concurrent seasonal adjustment, the estimates of seasonal factors are fine tuned as new or revised original estimates become available each period. The seasonally adjusted estimates are subject to revisions at each reference month as the estimates of seasonal factors are improved.

18 ARIMA modelling relies on the characteristics of the series being analysed to project future period data. ARIMA modelling is used on a case-by-case basis where it results in reduced revisions to seasonally adjusted series when subsequent data becomes available. The projected values are temporary, intermediate values, that are only used internally to improve the estimation of the seasonal factors. The projected data do not affect the original estimates and are discarded at the end of the seasonal adjustment process. The ARIMA model is assessed as part of the annual review and, following the 2013 annual review, the majority of directly seasonally adjusted trade in goods and services time series use an ARIMA model.

19 The month-to-month movements of the seasonally adjusted estimates may not be reliable indicators of underlying behaviour because they include irregular or non-seasonal movements. Trend estimates reduce the effect of these movements as they are derived by applying a 13-term Henderson moving average to the seasonally adjusted series. The 13-term Henderson moving average (like all Henderson averages) is symmetric, but as the end of a time series is approached, asymmetric forms of the average are applied. While the asymmetric weights enable trend estimates for recent months to be produced, it does result in revisions to the estimates for the most recent six months as additional observations become available. Revisions to trend estimates can also occur because of revisions to the original data and as a result of the re-estimation of the seasonal factors. Trend estimates should be used with caution, especially around the time of unusual influences, until these have been appropriately taken into account.

21 In accordance with BPM6 definitions, Australia's economic territory, on a balance of payments basis, is the area under the effective control of the Australian government. It includes the land area, airspace, territorial waters, including jurisdiction over fishing rights and rights to fuels and minerals. Australian economic territory also includes territorial enclaves in the rest of the world. These are clearly demarcated areas of land, located in other countries and which are owned or rented by the Australian government for diplomatic, military, scientific or other purposes. Specifically, the economic territory of Australia consists of:

- Geographic Australia which includes Cocos (Keeling) Islands and Christmas Island;
- Norfolk Island;
- Australian Antarctic Territory;
- Heard Island and McDonald Islands;
- Territory of Ashmore Reef and Cartier Island;
- Coral Sea Islands;
- Australia's territorial enclaves overseas; and
- the Joint Petroleum Development Area (joint territory between Australia and Timor-Leste).

22 Because of administrative complexities and measurement difficulties, Norfolk Island transactions with the rest of the world will not always be captured in all relevant balance of payments statistics. Most of the transactions involving Norfolk Island are not material to Australia's trade performance and not capturing these transactions will not distort these statistics. However, any significant transactions will be identified and included in the relevant statistics.

23 For details of the classifications used to present goods exports (credits) and imports (debits) on a balance of payments basis, see tables 6.6 and 6.7, respectively, in Balance of Payments and International Investment Position, Australia: Concepts, Sources and Methods (cat. no. 5331.0).

24 The international merchandise trade statistics shown in tables 12 and 13 are classified by the Standard International Trade Classification (SITC). Imports and exports of goods at a more detailed level are available from the time series spreadsheets on the ABS website. All data from July 2005 are presented according to SITC Rev 4 and data prior to July 2005 are presented according to SITC Rev 3. For details refer to the 'Classifications and Standards Update' in the July 2008 issue of this publication.

25 Monthly indicators for many of the services components that are only surveyed quarterly are not available. Monthly estimates for the freight and other transportation components of services credits in table 9 are derived by dividing the quarterly estimate by three. Freight debits are derived directly from imports data for the reference month as a difference between total merchandise cost, insurance and freight (CIF) and free on board (FOB), adjusted to reflect timing and processing adjustments. For freight credits and other transportation credits and debits, estimates are derived by extrapolating the last quarter's data by an average of movements for the same quarter over the three previous years, and then dividing the estimate by three. Similarly other services estimates are derived by extrapolating the last quarter's data by an average of movements for the same quarter over the previous three years, and then dividing the estimate by three.

CONFIDENTIALITY OF
MERCHANDISE TRADE
statistics

26 The release of statistics for certain merchandise trade commodities is restricted in order to prevent the identification of the activities of an individual business, where this is requested by the business concerned. These restrictions do not affect the total value of exports and imports, but they can affect statistics at the country, state and commodity levels, and other details only available on request such as Australian Ports. For information on the confidentiality restrictions applied to the merchandise trade statistics in this publication, refer to the current issue of International Merchandise Trade: Confidential Commodities List (CCL) (cat. no. 5372.0.55.001).

27 Exports data that have the confidentiality restrictions 'No commodity details' or 'No value details' are now aggregated into a single confidential commodity code. For data prior to June 2013, these data are added back into the appropriate state total and country total (i.e. these totals show the correct level of trade). From June 2013 these confidential data are not added back. Instead the confidential data are published as 'No country details' in the country totals and 'State of origin not available' or 'State not available for publication' in the state totals. Therefore, country and state totals from June 2013 may not represent the actual amount of trade in each country/state but only the trade in commodities without a 'No commodity details' or 'No value details' restriction.

28 Imports data that have the confidentiality restrictions 'No commodity details' or 'No value details' are aggregated into a single confidential commodity code. For data prior to September 2008, these data are added back into the appropriate state total and country total (i.e. these totals show the correct level of trade). From September 2008 these confidential data are not added back. Instead the confidential data are published as 'No country details' in the country totals and 'State of destination not available' or 'State not available for publication' in the state totals. Therefore, country and state totals from September 2008 may not represent the actual amount of trade in each country/state but only the trade in commodities without a 'No commodity details' or 'No value details' restriction.

29 The tourism related services memorandum items provide timely indicators of the movements in tourism related activities, not an absolute measure of the level of these activities. The tourism related indicator has been derived by combining total travel services (business, education-related and other personal travel) and passenger transportation services (which includes agency fees and commissions for air transport).

30 Annual services data by state, by country and detailed services are released twice yearly. Calendar year data are usually released following the March issue of this publication and financial year data are usually released following the September issue. Refer to time series data under trade in services data cubes for details.

31 Services credits are classified by the state of provision, while services debits are classified by the state of consumption. The state allocations for transportation, travel, postal and courier, and telecommunication services are based on a number of indicators including merchandise trade statistics by state, overseas passenger arrivals and departures by state of clearance and data provided by the Department of Immigration and Citizenship. The allocation for other services (about $25 \%$ of all trade in services) is primarily based on the location of the business reporting the information, which serves as a proxy for the state of provision/consumption of that service. The data should be used with care but are considered suitable for analysis over time.
32 A comprehensive explanation of the data sources used and the methodology applied in the compilation of partner country statistics is provided in Chapter 17 of Balance of Payments and International Investment Position, Australia: Concepts, Sources and Methods (cat. no. 5331.0). Approximately 5\% of total services credits and debits for both 2009-10 and 2010-11 were either confidential, or unable to be allocated to individual countries.
