#### MAIN FEATURES

Note: Survey estimates are subject to sampling variability, as explained in paragraph 12 below.

In September 1981 an estimated 2,750,800 persons aged 15 to 64 years were neither employed nor actively looking for work. Of these:

2,131,700 would not like, or did know whether they would like a full-time or part-time job.

619,000 would or might like a job, of whom;

73,300 were discouraged job seekers (see paragraph 8)

the remaining 545,700 persons had not actively looked for work for the following reasons:

#### EXPLANATORY NOTES

### Introduction

In September 1981 a survey, supplementary to the monthly population survey, was conducted throughout

Australia in order to obtain information about persons aged 15 to 64 years who were not in the labour force; in particular whether they wanted a job and, if they did, the reason they were not looking for work. Results of similar surveys, the first conducted in November 1975, have been published in Persons Not in the Labour Force, Australia (6220.0).

- 2. This publication contains only a summary of the more important results of the survey. More detailed estimates, which will be published as soon as possible, are available on request. The estimates shown are preliminary and are subject to revision.
- survey was based on a area sample of private multi-stage dwellings (about 30,000 houses, flats, etc.) and non-private dwellings (hotels, motels, etc.) and covered two-thirds of one per cent of the population of Australia. The information obtained from the occupants of selected dwellings by carefully chosen and specially trained interviewers, the interviews being conducted during the two weeks beginning on Monday, 7 September 1981.

#### Scope

- 4. The survey includes all persons aged fifteen years and over except:
  - (a) members of the permanent defence forces
  - (b) certain diplomatic personnel of overseas governments, customarily

- excluded from census and estimated populations
- (c) overseas visitors holidaying in Australia, and
- (d) members of non-Australian defence forces (and their dependants) stationed in Australia
- (e) persons not in the labour force aged 65 years and over
- (f) persons who had actively looked for work but were unable to start a job in the survey week for reasons other than their own temporary illness
- (g) boarding school students, persons permanently unable to work, some patients in hospitals and sanatoria and inmates of reformatories, jails, etc.

## Definitions

- 5. The labour force category to which a person is assigned depends on his actual activity (i.e. whether working, looking for work, etc.) during a specified week known as the survey week, which is the week immediately preceding that in which the interview takes place. Definitions of the principal labour force categories appearing in this publication are given in The Labour Force, Australia (6203.0).
- 6. Persons who want a job are those who
  - (a) in the four weeks before the interview week had not looked for work but in the survey answer 'yes' or 'maybe' to the question 'Even though you have not been looking for work would you like a full-time or part-time job now?',
- or (b) although claiming to have looked for work in the four weeks before the interview week, had not taken active steps (as defined below) to find employment.
- 7. Active steps to find work include checking or registering with the

- Commonwealth Employment Service or other employment agencies, writing, telephoning or applying in person to an employer, answering a newspaper advertisement for a job, advertising or tendering for work, contacting friends or relatives and looking on factory or employment service notice boards.
- 8. Discouraged. Comprises persons who want a job but are not actively looking for work because they believe they would not be able to find a job for any of the following reasons: considered by employers to be too young or too old; have language or racial difficulties; lack the necessary training, skills or experience; no jobs in their locality or line of work. This definition has been revised since March 1979. See paragraphs 10 and 11 for the effect of the change.
- 9. Highest ranked reason. Reasons for not actively looking for work have been ranked in the order of priority shown in Table 2; where more than one reason was given, only the higher or highest ranked has been included in the estimates in Table 2.

#### Discontinuities in the series

- 10. Estimates for March 1979 and earlier periods are not strictly comparable with those obtained from later surveys because the definition of persons who want a job has been widened to include those persons referred to in paragraph 6(h), i.e. persons who, although claiming to have looked for work in the four weeks before the interview week, had not taken active steps (as defined above) to find employment. Estimates of the numbers of such persons for earlier surveys, including those defined as discouraged, are shown in previous issues of Persons Not in the Labour Force, Australia (6220.0)
- 11. The September 1980 survey also excluded 24,900 persons who had a job but had been away from work without pay for four weeks or more up to the end of survey week. For all other surveys of Persons Not in the Labour Force (before and after September 1980), such persons have been included in the survey.

## Reliability of the estimates

12. Since the estimates in this publication are based on information obtained from occupants of a sample of dwellings they are subject to sampling variability; that is they may differ from the figures that would have been produced if all dwellings had included in the survey. One measure of the likely difference is given by the standard error. There are about two chances in three that a sample estimate will differ by less than one standard error from the figure that would have been obtained if all dwellings had been included, and about nineteen chances in twenty that the difference will be less than two standard errors. A table of estimated standard errors for this survey is shown below. Estimates with a standard error of more than about 27 per cent have not been shown in this publication, as the degree of sampling variability would seriously detract from their value for most reasonable uses. Although figures for these components can, in some cases, derived by subtraction they should not regarded reliable.
