NOTES

The aim of this publication is to provide users with a range of the latest statistics available at the end of each month of issue. Consequently the dates and periods shown are not always the same for each table but are in each case the latest figures available at that time.

As a general rule footnotes do not appear in this publication.

Seasonal adjustment

Seasonal adjustment is a means of removing the estimated effects of normal seasonal variations from economic time series so the effects of other influences are obvious. Seasonal variations are the systematic (though not necessarily regular) intra-year movements of economic time series. These are often the result of non-economic phenomena, such as climatic changes, and regular religious festivals e.g. Christmas and Easter.

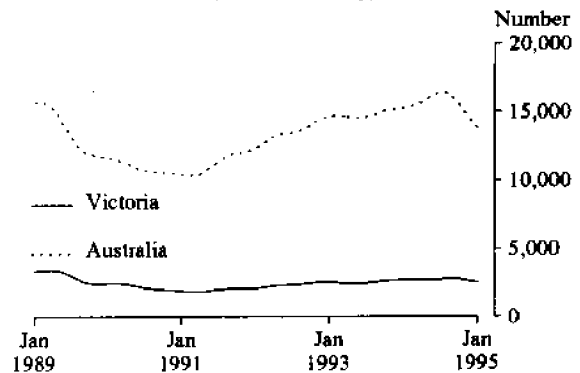
New Dwelling Units Approved

The trend estimate of new dwelling units approved in Victoria decreased by 3.6 per cent from December 1994 to January 1995.

The trend estimate of dwelling units approved in January 1995 decreased by 7.2 per cent when compared with the level of approvals in January 1994.

For Australia, the trend estimate of dwelling units approved decreased by 9.5 per cent when compared with January 1994 and decreased by 3.6 per cent when compared with December 1994.

New Motor Vehicle Registrations

The trend estimate of new motor vehicles registered in Victoria increased by 1.5 per cent from December 1994 to January 1995.

For Australia the trend estimate of new motor vehicles registered increased by 0.9 per cent from December 1994 to January 1995.

(Trend, monthly)

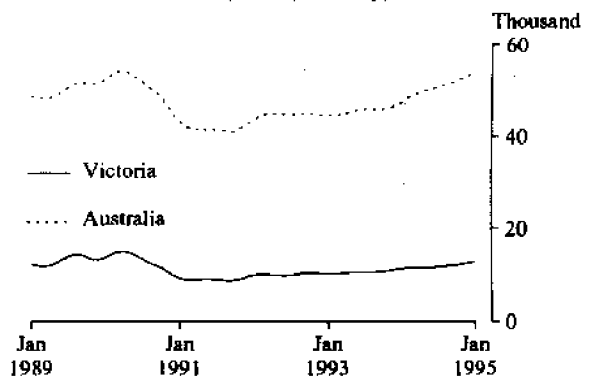
