ANALYSIS OF TABLE 1.1

The estimated resident population of Western Australia at 31 March 1997 was 1,791,200 an increase of 8,500 in the March quarter and 32,700 in the twelve months from 31 March 1996. The growth rate during the quarter was equivalent to an annual rate of 1.91%.

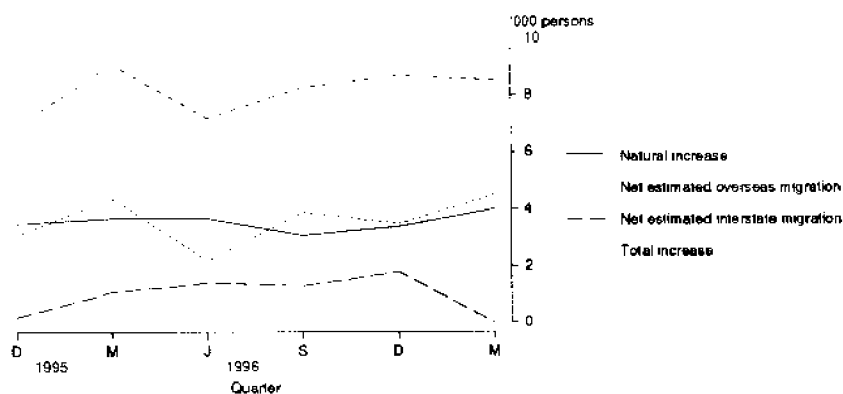

ANALYSIS OF TABLE 1.2

In the March quarter 1997 the population increased by 8,500 compared with an increase of 8,700 in the previous quarter. Both the natural increase and net estimated overseas migration were higher than in the December quarter 1996. However, there was no net estimated interstate migration, a fall of 1,800 from the December quarter.

For the twelve months ended 31 March 1997 the increase of 32,700 was 1.6% higher than the increase in the previous twelve months.

ANALYSIS OF TABLE 1.3

The number of marriages fell by 544 or 15.8% in March quarter 1997 from the previous quarter. The total of 2,904 marriages in March quarter 1997 was a fall of 1.2% on March quarter 1996.

The total number of deaths dropped by 356 from December quarter 1996, a fall of 13.2%. The number of live births rose by 3.9% and divorces fell by 3.0% from December quarter 1996. Compared to March quarter 1996, the number of deaths decreased by 245 or 9.5% and births increased by 63 or 1.0%. The number of divorces increased by only 2.

Preliminary data for 1996 shows a drop of 356 live births or 1.4% from calendar year 1995. The number of divorces fell slightly by 81 and marriages, with a revised figure, dropped by 110 or 1.1%. Total deaths rose by 650 or 6.3% and infant deaths increased by 28 or 21.9%.

ANALYSIS OF TABLE 1.4

Reflecting the fall in the number of infant deaths from a year ago, the rate for infant deaths in March quarter 1997 was 3.9 infant deaths per 1,000 live births lower than March quarter 1996.

Compared to March quarter 1996, rates declined by 0.7 for total deaths and by 0.2 for marriages.

The rates for deaths, infant deaths, marriages and divorces in March quarter 1997 all fell from the previous quarter. Only the rate for live births increased, by 0.5.

Preliminary rates for 1996 calendar year show falls for live births, marriages and divorces compared to calendar year 1995 but rises for infant deaths and total deaths.

Total arrivals in August 1997 were 13% lower than in the previous month but were 5% higher than in August 1996.

The number of Western Australian residents returning from short-term visits overseas fell by 9% from the previous month to 33,362 persons. However, this was a 17% increase over August 1996. The number of overseas visitors arriving in Western Australia for short-term visits also decreased by 13% from July 1997 and by 7% since August 1996.

The number of residents returning to Western Australia in August 1997 after a long-term stay overseas decreased by 11% from the previous month but increased slightly by 3% over the August 1996 report. After the July 97 increase in arrivals of long-term overseas visitors, their numbers decreased by 67% although there was a 38% increase over the same time the previous year.

Total departures in August 1997 fell by 7% from the previous month and were 10% higher than in August 1996.

The number of short-term departures of Western Australian residents fell by 17% on July 1997, although there was a 20% increase on August 1996 figures. Short-term departures of overseas visitors rose by 10% from July 1997. The number of long-term departures of overseas visitors almost halved since the previous month although the long-term departures of Western Australians fell by only 2% over the same time.

Total short-term overseas visitor arrivals dropped by 13% since July 1997. The total of 26,779 arrivals in August 1997 was also 7% lower than in August 1996.

The number of visitors from the United Kingdom and Ireland in August 1997 increased by 43 or 1% on July 1997 although there was a 10 percentage point decrease since August 1996. Short-term arrivals from Japan more than doubled (58%) since July 1997, with a comparatively small 9% increase over the previous years figures.

ANALYSIS OF TABLE 2.3

The number of short-term overseas visitor arrivals for holidays in Western Australia in August 1997, fell by 2% on July 1997. There was a total of 15,041 visitors compared to 17,310 in August 1996.

For August 1997, there was a decrease from the previous month of 897 holidaymakers or 49% from Singapore. Holidaymakers from New Zealand and Malaysia increased, by 45% and 62% respectively. While there was 65% decrease in holidaymakers from Indonesia a 36% drop in short term visitors from Thailand.

Compared to August 1996, holidaymakers from United Kingdom and Ireland increased by 17%, by 47% for New Zealand. Over the same period the number of holidaymakers from Singapore decreased by 25%, by 5% from Malaysia, by 62% from Thailand and by 34% from Indonesia.

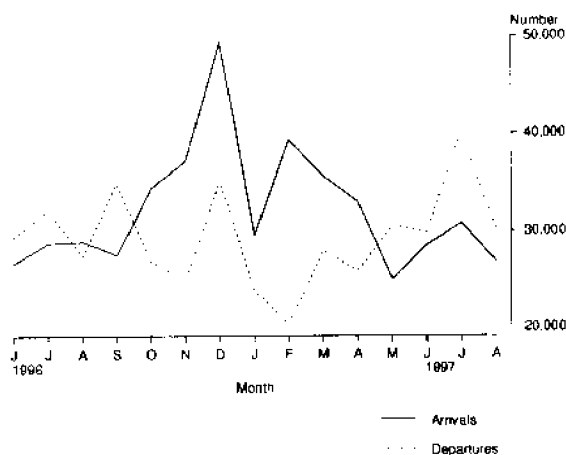

ANALYSIS OF TABLE 2.4

For August 1997, short term departures of residents from Western Australia decreased by 7,008 persons (18%). The total of 33,011 persons was 5,591 or 20% higher than recorded for August 1996.

Compared to July 1997, short-term departures of residents to Indonesia fell slightly by 3%. Departures to New Zealand dropped by 22%, to United Kingdom and Ireland by 33% and increased to Singapore by 24%.

ANALYSIS OF TABLE 2.5

There were 19,589 short-term departures of Western Australian residents for holidays abroad in August 1997. This was 5,517 residents or 22% less than departed in July 1997 and 3,509 residents more than in August 1996.

For August 1997, only one country, Singapore, recorded an increase in the number of Western Australian short-term holidaymakers. Of the other popular holiday destinations for Western Australians, Malaysia reported the greatest decrease (57%) in the proportion of holidaymakers visiting since July 1997.

Singapore, closely followed by the United Kingdom and Ireland were the favoured short-term holiday destinations for Western Australian residents. Of the total of 19,589 departures for August 1997, 2,271 persons (12%) chose Singapore and 2,235 people (11%) chose the United Kingdom and Ireland as their holiday destination.

Compared to August 1996, departures of holidaymakers increased by 22% overall, with only Thailand recording a 31% decrease in the number of short term visitors from Western Australian.

The seasonally adjusted number of persons unemployed decreased by 5,500 to 59,800 however, the number of persons employed also decreased by 5,100 to 865,700.

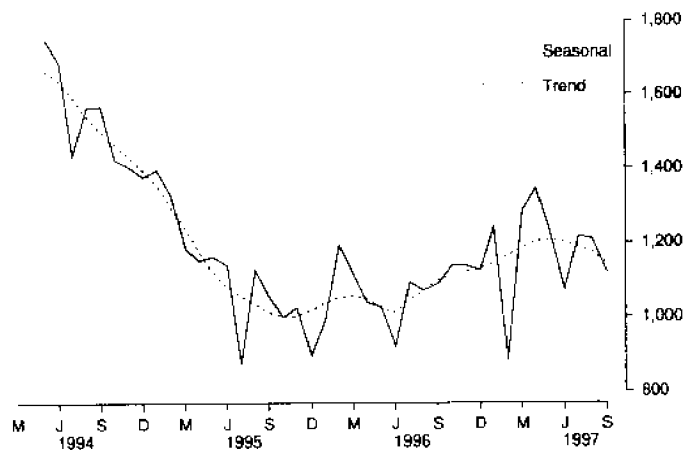

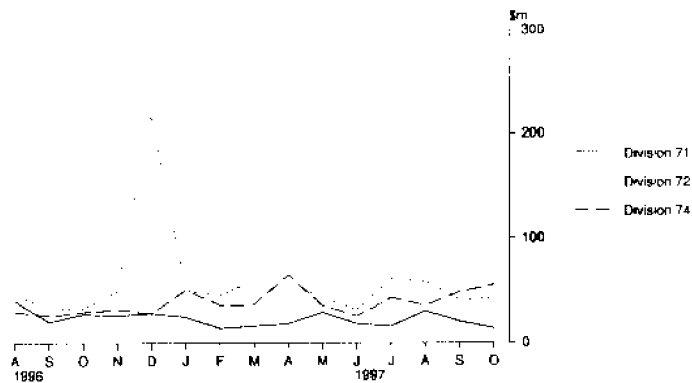

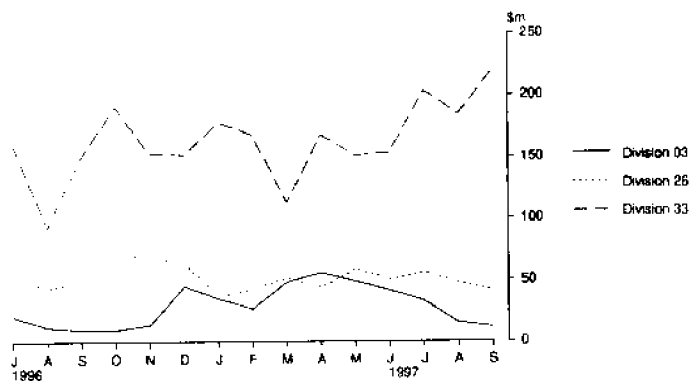
