NOTES ON THE ESTIMATES

MAIN FEATURES

NOTE: Changes in individual quarters are necessarily subject to the uncertainties discussed in the Explanatory notes under interpretation of quarterly estimates, and furthermore some may be substantially revised as firmer data come to hand. This applies particularly to the estimates for the two most recent years for gross operating surplus, the income of companies and non-farm unincorporated enterprises, depreciation, and therefore to the estimated magnitude of change in gross non-farm product.

In current price seasonally adjusted terms, wages, salaries and supplements rose by 0.6 per cent in March quarter 1984, following a rise of 5.6 per cent in the previous quarter, while gross operating surplus of trading enterprise companies rose by 17.4 per cent after rising by 4.2 per cent in the December quarter 1983.

The following notes are provided to aid analysis of the estimates for recent quarters.

Medicare

The introduction of the Medicare system of payment for hospital and medical expenses from 1 February 1984 has a direct impact on a number of aggregates in the accounts. As a result of the new health care financing arrangements, income taxes paid by individuals, government final consumption expenditure and personal benefit payments made to households will all be higher, while private final consumption expenditure on health will be marginally lower than would otherwise have been the case. The changes in these aggregates are respectively:

- the medicare levy;
- public hospital expenses previously charged to individuals that are now met directly by governments;
- amounts paid by Medicare for individual hospital and medical services; and
- the payments previously made by individuals to public hospitals.

Movements in the implicit price deflator (IPD) of private final consumption expenditure are generally fairly similar to movements in the consumer price index (CPI). However, in March quarter 1984 the IPD rose by 1.4 per cent while the 'All groups' CPI fell by 0.4 per cent.

The major reason for this divergence is that private final consumption expenditure includes all charges for individual hospital and medical services, whether or not they are paid directly by households, whereas the CPI measures net prices actually paid by households for hospital and medical services.

Wages, salaries and supplements

The seasonally adjusted movements in this aggregate for recent quarters should be interpreted cautiously in the light of the following discussion.

Until September quarter 1981 estimates of wages, salaries and supplements were mainly based on payroll tax data. From December quarter 1981 the estimates have been based on sample surveys of employers. A small interim survey was introduced from December quarter 1981 until a full-scale Survey of Employment and Earnings (SEE) could be established. That survey (SEE) has operated since September quarter 1983 and has been taken into account in the earnings estimates in this publication. The employment coverage of both sets of survey estimates has been adjusted to reflect movements in the number of wage and salary earners shown in the monthly Labour Force Survey.

As estimates from both the interim survey and SEE are based on information obtained from samples of employers, they are subject to sampling variability; that is, they may differ from the figures that would have been produced if data had been collected from all employers.

A small survey of pay periodicity was conducted in respect of September quarter 1981 in order to assist in estimating the effects of changes in the seasonal pattern between the payroll tax data underlying the series prior to December quarter 1981 and the interim survey data underlying the series from December quarter 1981. Because of the limited nature of the data that was obtained in that survey, extra caution is required in interpreting the seasonally adjusted estimates since December quarter 1981. These seasonally adjusted estimates may be revised in the light of more comprehensive data which is planned to be collected in a pay periodicity survey to be conducted in respect of September quarter 1984. See also **Revisions** on page 3 of this issue.

Gross farm product

The large increase of 45 per cent in seasonally adjusted farm product at constant prices in September quarter 1983 is the consequence of two major factors. First, and most significantly, the impact of the record wheat and other grain harvests in 1983-84 shows up in seasonally adjusted terms in the September quarter. (See paragraph 11 of the Explanatory notes for an explanation of the methods used to seasonally adjust the production series for these commodities.) Second, the increase in production of wool in September quarter 1983 was unusually large because of the impact of a shearers' strike in New South Wales on production in the preceding quarter.

Government final consumption expenditure

In current price terms the quarterly estimates for this aggregate are based on data from public authority accounts which are on a cash basis rather than an accruals basis. It is not always possible to identify the full impact of pre-payment of salaries for holiday periods and back pay associated with award changes when compiling the deflators used to derive constant price estimates. Therefore quarter-to-quarter movements in both current and constant price estimates should be treated with caution.

The major areas of growth in the seasonally adjusted estimates for this aggregate in the March quarter were in education and health.

Gross fixed capital expenditure—Sales of public sector assets

Quarterly movements from June quarter 1979 for both public and private gross fixed capital expenditure have frequently been affected by sales of existing assets by the public sector to the private sector (generally these assets have been leased back by the public authorities concerned). For this reason, the movements in private gross fixed capital expenditure on non-dwelling construction and on equipment for particular quarters can differ significantly from the private sector expenditure on new assets published in *New Fixed Capital Expenditure by Private Enterprises in Selected Industries, Australia* (5625.0). For further discussion see paragraph 3 of the Explanatory notes.

Private gross fixed capital expenditure—equipment

The implicit price deflator of this aggregate fell by 1.2 per cent in March quarter 1984, mainly as a result of a sharp increase in the imported equipment share of total equipment. The effect of this compositional shift was to lower the level of the deflator for equipment, with the reduction being reinforced by downward pressure on import prices associated with an appreciating \$A.

Stocks

In seasonally adjusted, constant price terms, private non-farm stocks registered their first increase since September quarter 1982, with significant turnarounds being recorded in most industries. However, the constant price private non-farm stocks to sales(a) ratio remains at an historically low level despite the increase in stockholdings recorded in March quarter 1984. The private non-farm stocks to sales ratio in recent quarters is as follows:

(a) Constant price sales are defined as gross non-farm product plus imports of goods and services (excluding petroleum, civil aircraft and government imports) less changes in private non-farm stocks. (All these variables are at average 1979-80 prices.)

Stock valuation adjustment

The size of the stock valuation adjustment (SVA) in March quarter 1984 is the lowest for several years. The reason for this is that there has been a deceleration in the rate of price increase of most commodities during the past few quarters. However, it is possible that the size of the SVA could be understated in March quarter because of the assumptions that necessarily have to be used in compiling estimates of the SVA. The major assumptions used are that:

- (a) book value levels reported by businesses are based on accounting valuations at historical cost assigned by the FIFO (first in, first out) method;
- (b) within most sectors, sales prices can be used to adjust stock levels valued at cost, that is, the selling price of finished goods is established as a fixed mark-up on the costs incurred in the current period;
- (c) the commodities in stock have a fixed turnover period, that is, the ratios 'stock level of materials/value of purchases' and 'stock level of finished goods/value of sales' remain constant;
- (d) the commodity composition of each estimation cell remains fixed; and
- (e) within each estimation cell, the RATE of physical increase (or decrease) in stocks is constant throughout each quarter.

In times of rapid price change and/or marked changes in the rate of price increase, inconsistencies between these assumptions and actual business practice can lead to significant errors in the SVA. The extent of the decline shown in the SVA over the last three quarters may have been overestimated. If this were so, the level of gross domestic product in March quarter would be too high. However, because the SVA is deducted from both sides of the domestic production account, errors in its measurement have no impact on the size of the statistical discrepancy.

Statistical discrepancy

The statistical discrepancy represents the difference between the sum of the estimates of gross domestic product (GDP) and imports of goods and services on the one hand and the sum of the estimates of components of gross national expenditure and exports of goods and services on the other hand. Conceptually these two totals are the same. The inclusion of the statistical discrepancy on the expenditure side of the domestic production account is a convention and does not necessarily imply that the sum of the income components more accurately measures GDP than the sum of the expenditure components.

The aspect of the statistical discrepancy which is of most concern in the quarterly context is the magnitude of change from one quarter to the next. In some quarters there are quite significant movements in the seasonally adjusted constant price statistical discrepancy. A useful way of examining the significance of the statistical discrepancy is to compare the change in gross non-farm product as published with the result which would be obtained using the expenditure aggregates excluding the statistical discrepancy. The following table shows such a comparison for the last 6 quarters.

The rise in the statistical discrepancy in the last four quarters, which is reflected in the difference between the figures in this table, means that the income-based estimates are indicating a stronger recovery than the expenditure-based estimates.

Household saving ratio

Present estimates indicate that, on a seasonally adjusted basis, the proportion of household disposable income devoted to consumption in the March quarter was 85.4 per cent while household saving, which is derived as a balancing item, represented 14.6 per cent. Both of these ratios are affected by any deficiencies or inconsistencies in the estimation and seasonal adjustment of household income and expenditure.

The household saving ratio in recent quarters is as follows:

Revisions

Further investigations into the methods used to calculate pay periodicity factors, which are used in the seasonal analysis of wages, salaries and supplements and gross non-farm product at constant prices, have resulted in some minor changes to these factors over recent quarters. Consequently these two series have been seasonally reanalysed.

The estimates for farm and public authority stocks and gross farm product in the December quarter 1983 have been revised as a consequence of later information from marketing authorities.

EXPLANATORY NOTES

Introduction

This publication provides estimates of the components of gross domestic product and national expenditure and supporting tables for the March quarter 1984, together with comparative estimates for the eight previous quarters and the four years 1979-80 to 1982-83. In addition, seasonally adjusted estimates of the major aggregates and some selected series are provided for the March quarter 1984, together with comparative estimates for the twelve previous quarters. Tables 32-42 provide time series, in both original and seasonally adjusted terms, for the period from September quarter 1969 for the aggregates contained in the domestic production account (at both current and average 1979-80 prices), some selected income aggregates and implicit price deflators.

Concepts, definitions, sources and methods

2. A basic guide to the Australian national accounts entitled *Australian National Accounts, Concepts, Sources and Methods* (5216.0) is available. It outlines major concepts and definitions, describes sources of data and methods used to derive annual and quarterly estimates for major aggregates at current and constant prices and discusses the accuracy and reliability of the national accounts. The concepts, definitions, sources and methods applicable to the estimates contained in this publication are as described in 5216.0 but with the changes outlined in Appendix A, *Australian National Accounts, National Income and Expenditure, 1981-82* (5204.0).

Gross fixed capital expenditure

3. The internationally recommended basis for measuring gross fixed capital expenditure (GFCE) in national accounts is purchases less sales. However, because of inadequate data sources, public gross fixed capital expenditure had previously been estimated from data on outlays on new fixed capital assets (except for the deduction of the cost of previously rented dwellings sold and the value of fixed assets sold to non-residents). Following a redesign of the public finance statistical system which is now in progress, public GFCE will be measured on the internationally recommended basis. In the meantime, all major sales of fixed capital assets by the public sector to the private sector are being recorded as a deduction from public GFCE and an addition to private GFCE. This treatment has been applied since the March quarter 1982 issue of this publication.

Interpretation of quarterly estimates

4. Estimating for a period of less than one year presents special problems in that it is often difficult to adhere strictly to definitions and concepts used in annual estimates. The measurement of income for a quarterly period is particularly difficult since it is not always possible to match the value of production for a quarter with the cost incurred in that production. This problem occurs, for example, in estimating the income of farm unincorporated enterprises in each quarter, and results in considerable variation of the estimates for this series, and for gross farm product, from quarter to quarter. Difficulties are also experienced in obtaining detailed data for short periods and in preparing consistent estimates from various sources where different accounting procedures and periods are used.

5. These problems inevitably affect the consistency and reliability of the current price estimates, and similarly affect the constant price estimates based on the current price estimates. Accordingly, these factors as well as the approximations and assumptions necessarily made in the revaluation of flows to constant prices should be borne in mind when interpreting or using the estimates for example, in attempting to draw precise quantitative inferences relating to quarter-to-quarter changes in gross domestic product or its components, or in productivity.

6. Analysis of trends requires allowance for these uncertainties in estimation. The effects are in some measure indicated by the change in the statistical discrepancy for corresponding periods. Uncertainty in trends arises also from the likelihood of revisions as more information becomes available and from the irregularity of short-term movements. The inclusion of the statistical discrepancy on the expenditure side of the accounts is a convention and does not necessarily imply that the sum of the income components more accurately measures GDP than the sum of the expenditure components (plus exports less imports). As household and other saving are estimated as balancing items in their respective accounts, care should be exercised in their interpretation.

7. Estimates of national income and expenditure are necessarily prepared from a wide range of statistical information, some of which is available quickly and some only with a delay of several years. For this reason most figures should be regarded as subject to revision as more complete and more accurate information becomes available. The revisions will be of two main types—those made to the most recent quarters as firmer quarterly or monthly data come to hand and those which are a consequence of revisions to annual totals and are distributed to the quarters approximately in accordance with existing quarterly patterns.

8. No simple measure is available of the accuracy of the major summary national accounting aggregates. However the following example illustrates the sensitivity of quarter to quarter growth to the timing of recording a transaction. If, in the latest year, the timing of recording a transaction were delayed by one quarter and if the transaction had an impact on constant price gross domestic product of +\$30 million then the measure of the rate of growth would be affected in three adjoining quarters (centred on the quarter in which the transaction was recorded) by -0.1, +0.2, and -0.1 percentage points respectively. Of course the percentage impact of such a timing delay on relevant sub-aggregates would be greater.

9. The quarterly implicit price deflators (IPDs) shown in Tables 9 and 42 are derived by dividing seasonally adjusted current price estimates by the corresponding seasonally adjusted constant price estimates. Movements in the levels of individual implicit price deflators can be greatly affected by changes in the physical composition of the aggregates and their components. Generally, it is considered that IPDs derived from seasonally adjusted data are more reliable than those obtained by using original (i.e. unadjusted) series, because the former are less likely to be affected by compositional change than are the latter. However the seasonal adjustment process is itself a source of possible distortion, especially to the extent that it is not possible to identify, in a fully

consistent way, the seasonality of the current price estimates and of the constant price estimates. A discussion of the limitations involved in using IPDs as measures of pure price change is contained in Appendix B of *Australian National Accounts, Concepts, Sources and Methods* (5216.0).

Seasonal adjustment

10. As most series are affected to some extent by seasonal factors, allowance should be made for normal seasonal variation. In Tables 6, 8, 9, 13, 17, 19, 22, 23, 33, 35 and 37 to 42, *seasonally adjusted* values are presented for selected series. Series which show substantial irregularities in the original or adjusted series should be treated with some reserve. As different methods of seasonal adjustment tend to produce different results, it is necessary to bear in mind the methods by which they have been derived and the limitations to which those methods are subject. It should also be noted that the methods of seasonal adjustment used by the ABS do not force the sum of the seasonally adjusted estimates for each quarter of a financial year to equal the original annual total.

11. The general methods used in the ABS for making seasonal adjustments are described in *Seasonally Adjusted Indicators, Australia, 1983* (1308.0). However, special methods have been used to adjust some of the components of gross farm product which were not amenable to seasonal adjustment by the usual methods. To obtain the seasonally adjusted estimates, the estimated values of production of wheat, other grain and sugar cane, for any financial year, are distributed equally over the four quarters of the year ended June. One effect of these methods is that changes in the annual production of these commodities first enter into the seasonally adjusted figures in the September quarter.

12. Where there is no apparent seasonality in their implicit price deflators, constant price estimates are seasonally adjusted using the same factors as are used for adjusting the corresponding current price estimates. As far as possible the remaining constant price estimates have been adjusted using methods similar to those for the corresponding current price estimates.

Analysis of contributions to growth table

13. Table 3 represents an analysis of the contribution provided by each major aggregate to the percentage

change in seasonally adjusted gross domestic product at constant prices. The formula used to calculate the contribution by each aggregate to the growth in GDP is:

$$\frac{A(t)-A(t-1)}{\text{GDP } (t-1)} \times 100.0$$

where $A(t)$ = value of aggregate A in quarter under consideration

$A(t-1)$ = value of aggregate A in preceding quarter

$\text{GDP } (t-1)$ = value of GDP in preceding quarter

All these values are seasonally adjusted constant price estimates. It should be noted that the figures in this table are additive within each quarter unlike the percentage change tables shown elsewhere in this publication.

Rounding of figures

14. Although percentage changes are given to one decimal place in this publication, this does not imply that they can be regarded as accurate to the last digit shown. The figures after the decimal point are given to avoid distortions which may occur in rounding off the figures to the nearest half or whole number.

15. The procedures used in preparing this publication may occasionally result in rounding differences between figures in this publication and corresponding figures in other publications.

16. Where figures have been rounded, discrepancies may occur between sums of the component items and totals.
