



#### SUMMARY OF FINDINGS

**OVERVIEW** 

Some 95 per cent of the civilian population aged 15 and over are represented by the data in this publication (Table 1). For information about the recording of relationship and family type in the Labour Force Survey, see the Explanatory Notes, paragraphs 7 and 8. Of the 13,572,600 persons aged 15 years and over who were usual residents of private dwellings in Australia in June 1996 and for whom family status could be determined, 83 per cent were members of families (Tables 1 and 2).

These persons were members of 4,834,000 families and some 84 per cent of families were *couple families* – of which 48 per cent had dependants present (Chart 1).

85 per cent of the 672,000 one parent families had a female parent (Table 3).

There were 82,500 other families, amounting to 1.7 per cent of all families.


An estimated 23 per cent of *all families* had no family member employed; 28 per cent had one family member employed; 49 per cent had two or more family members employed (Table 3).

Of the 2,350,500 persons who were not members of a family, 62 per cent lived alone (Chart 8).

COUPLE FAMILIES


In June 1996, 52 per cent of *couple families* had both partners in the labour force and 27 per cent had only one partner in the labour force. For 48 per cent of *couple families* both partners were employed. For 21 per cent of *couple families* neither partner was in the labour force (Table 12).

COUPLE FAMILIES WITH DEPENDANTS PRESENT For couple families with dependants present, 61 per cent had both partners in the labour force and 35 per cent had one partner only in the labour force. In 94 per cent of this second group, the partner in the labour force was the husband.

One or both partners were employed in 91 per cent of all couple families with dependants present (Table 12).

The husband was employed full time in 84 per cent of couple families with dependants present. In comparison, the wife was employed full time in only 25 per cent of these families (Table 12). Where the wife was employed full time, the percentage increased as the age of the youngest dependant present increased (Chart 4).

There were 79,400 couple families with dependants where the husband was unemployed and the wife was either unemployed or not in the labour force (Table 12). In 36 per cent of these families, the husband had been unemployed for 52 weeks or more (Table 17).

CHART 3: EMPLOYMENT STATUS OF PARTNER IN COUPLE FAMILIES, JUNE 1996





The proportion of couple families with dependants with one or both parents unemployed peaked at 10.7 per cent in 1993 before declining to 8.3 per cent in 1995, then increasing to 8.5 per cent in June 1996 (Chart 5).

COUPLE FAMILIES WITHOUT DEPENDANTS PRESENT

Forty four per cent of couple families without dependants present had both partners in the labour force (Chart 2). A further 20 per cent had only one partner in the labour force, with that partner being the husband in 79 per cent of cases (Table 12).

One or both partners were employed in 62 per cent of families without dependants present. The husband was employed full time in 52 per cent of families without dependants present, and the wife was employed full time in 30 per cent of these families (Table 12). The proportion of these families where both partners were unemployed rose from 4.1 per cent in June 1995 to 4.5 per cent in June 1996 (Chart 5).


CHART 5: COUPLE FAMILIES: PROPORTION WITH ONE OR BOTH PARTNERS UNEMPLOYED



ONE PARENT FAMILIES

In June 1996, there were 672,000 one parent families, making up 14 per cent of all families. For 85 per cent of these families the parent was female. Some 467,200 one parent families had one or more dependants of which 406,600 (87 per cent) had a female parent (Chart 1).

In 47 per cent of *one parent families* with dependants, the parent was employed. Some 22 per cent of female parents with dependants were employed full time and 21 per cent were employed part time. Of male parents with dependants 62 per cent were employed full time and 8 per cent were employed part time. The percentage of *one parent families* with the parent employed increased as the age of youngest dependant increased (Chart 6).


For 50 per cent of *one parent families*, the parent was not in the labour force. Of these families 38 per cent had no dependants present.

In 7 per cent (48,200) of *one parent families*, the parent was unemployed. Of these families:


- 16,500 (34 per cent) parents had been unemployed for 52 weeks or more; and
- the average duration of unemployment of the parent was 53.9 weeks (Table 24).

The proportion of *one parent families* with dependants where the parent was unemployed was 8.7 per cent in June 1996, a fall of 0.1 percentage points since June 1995, and still below the 9.5 per cent peak of 1993 (Chart 7).

In June 1996, an estimated 386,200 dependent children aged 0 to 14 years were in *one parent families* where the parent was either unemployed or not in the labour force (Table 7).

### PERSONS WHO WERE NOT MEMBERS OF A FAMILY

Lone persons comprised 11 per cent of the population where relationship was determined (Table 1). Selected characteristics of these persons in June 1996.

- Some 55 per cent were females, 52 per cent of whom were aged 65 years and over. Of the males living alone 39 per cent were aged 25 to 44 years, and 24 per cent were aged 65 years and over (Table 26);
- An estimated 43 per cent were employed. Some 55 per cent of males living alone were employed and of females living alone, 32 per cent were employed (Table 25).

Selected characteristics of persons who were not members of a family and were *not living alone* in June 1996:

- Some 57 per cent were males, of whom 69 per cent were aged between 20 and 34 years. Similarly, 65 per cent of women were aged 20 to 34 years (Table 26);
- An estimated 74 per cent were employed, with the proportion being slightly lower for females than for males. The vast majority of both employed males (87 per cent) and employed females (74 per cent) were working full time (Table 25).

#### **EXPLANATORY NOTES**

#### INTRODUCTION

- 1 In June 1996, details of the labour force status of family members and family composition were derived from the Labour Force Survey component of the Monthly Population Survey.
- 2 Tables 1 and 2 summarise the *relationship in household of persons* aged 15 and over. Tables 3 to 24 show information about *couple, one-parent* and *other families* for example, number of dependants present, labour force status of husband, wife or family head while tables 25 to 29 contain more detailed estimates of the *status of persons* aged 15 and over classified by age, weekly hours worked and other variables.

#### THE POPULATION SURVEY

3 The population survey is based on a multi-stage area sample of private dwellings (currently about 30,000 houses, flats, etc.) and a list sample of non-private dwellings (hotels, motels, etc.) and covers about one-half of one per cent of the population of Australia. The information is obtained from the occupants of selected dwellings by specially trained interviewers. The interviews for this survey were conducted during the two weeks beginning on Monday 10 June 1996. The information obtained relates to the week before the interview (i.e. the reference week).

#### SCOPE

- 4 The Labour Force Survey includes all persons aged 15 and over except:
- members of the permanent defence forces;
- certain diplomatic personnel of overseas governments, customarily excluded from census and estimated populations
- overseas residents in Australia; and
- members of non-Australian defence forces (and their dependants) stationed in Australia.

#### COVERAGE

- 5 In the Labour Force Survey, coverage rules are applied which aim to ensure that each person is associated with only one dwelling, and hence has only one chance of selection. Nevertheless, the chance of a person being enumerated at two separate dwellings in the one survey is considered to be negligible.
- 6 Persons who are away from their usual residence for six weeks or less at the time of interview are enumerated at their usual residence (relevant information may be obtained from other usual residents present at the time of the survey).
- 7 Because of the coverage rules, persons who usually live with other members of their family may, at the time of the survey, be enumerated as not living with all the usual members of their family. This situation is more likely for persons who are enumerated as visitors to other private dwellings or as persons staying in non-private dwellings (hotels, caravan parks, hospitals, etc.). The determination of family structure and family characteristics in such cases is most difficult. Thus for the family survey, scope was further restricted to usual residents of private dwellings and the following persons were excluded:
- all persons enumerated in non-private dwellings (including hotels, motels, hospitals and other institutions); and
- persons enumerated as visitors to (rather than usual residents of) private dwellings.

8 In addition, in those households where it was not possible to obtain information relating to all the usual residents, no family information was recorded. Thus persons living in households which include a member of the permanent defence forces, who is outside the scope of the population survey, are excluded from the family survey because family information could not be obtained from each usual resident. Similarly households which, at the time of the survey, have one or more of their usual residents away for more than six weeks, are excluded from the family survey. This also applies to households from which an incomplete or inadequate questionnaire was obtained for any usual resident in on scope and coverage. Table 1 summarises those persons for whom family information was obtained as well as those usual residents of private dwellings for whom complete family information could not be obtained, and those persons specifically excluded from the scope of the family survey.

POPULATION BENCHMARKS

9 Labour Force Survey estimates of persons employed, unemployed and not in the labour force are calculated in such a way as to add up to the independently estimated distribution of the usually resident population aged 15 and over by age and sex. This procedure compensates for under-enumeration in the survey, and leads to more reliable estimates. Persons who, at the time of interview, are overseas for more than six weeks but for less than 12 months are included in the independent population statistics (benchmarks) and are thus provided for in the calculation of the estimates. The benchmarks are the latest available estimates at the time the Labour Force Survey is conducted, but they usually differ from the official population estimates subsequently published in *Australian Demographic Statistics* (3101.0) because they are derived from incomplete information about population changes.

REVISION OF POPULATION BENCHMARKS

- 10 Survey estimates are not revised for the usually small amendments of population benchmarks arising from new data on deaths and overseas and internal migration. Revsions are made, however, after each Census of Population and Housing, and when population estimation bases are reviewed. These revisions affect original, seasonally adjusted and trend estimates. The last such revision was made in February 1994 to take account of the results of the 1991 Census of Population and Housing, which affected all the monthly estimates from January 1989 to January 1994.
- 11 Population benchmarks used in the estimation of Labour Force Survey data are compiled according to place of usual residence. For an explanation of the conceptual basis of population estimates, see *Information Paper:* Population Estimates: An Outline of The New Conceptual Basis of ABS Population Estimates (3216.0). Prior to October 1982, labour force estimates were based on a combination of place of enumeration and place of usual residence.

CHANGES IN FAMILIES CLASSIFICATION

- 12 Relationship in bousehold and Family type classifications were introduced in the March 1994 issue of The Labour Force, Australia (6203.0) to align with ABS standards. Most categories in the two classifications remain comparable with categories in the previous classifications. The cases in which there are breaks in comparability are discussed in the following paragraphs.
- 13 Relationship in household. This classification was previously referred to as Family status.
- Lone parents (previously referred to as Sole parents) now includes parents with non-dependent children (provided those children are without a spouse or children of their own). These Lone parents without dependants are shown separately in Table 1 and there were 205,800 such persons in March 1994.

- Dependent students (previously Full-time students aged 15-24) now comprise sons or daughters (of a couple or a lone parent) aged 15 to 19 attending school or aged 15 to 24 attending a tertiary educational institution full time. Other related full-time students, who were also previously classified as Full-time students aged 15-24 are now included in Other family persons. There were 24,200 such persons in March 1994.
- Other family persons now comprises the previous groups Other family head, excluding those now counted as Lone parents (79,200 persons in March 1994, the other related full-time students classified as Full-time students aged 15-24 (see above; 24,200 in March 1994) and Other relative of married couple or family head (218,100 in March 1994).
- **14** Family type. This classification was previously referred to as Type of family. There are three types of families in the new classification, as follows:
- Couple families is the term used to describe families previously referred to as Married-couple families. Apart from the name change, the new category is otherwise exactly comparable with the old category.
- One-parent families now includes those families in which there is a lone parent with only non-dependent children present. Such families were previously included in Other families. There were 208,400 of these families in March 1994.
- Other families now excludes those families in which there is a lone parent with only non-dependent children present (see above).

#### COMPARABILITY OF SERIES

- **15** Estimates for the June 1996 survey are based on population estimates derived from the results of the 1991 Census of Population and Housing (adjusted for underenumeration). Estimates for surveys conducted in June from 1989 to 1993 were based on 1986 census results.
- 16 Commencing with the June 1989 issue, the category other families was split into one-parent families and other families. Therefore these estimates are not strictly comparable with estimates in issues prior to June 1989. However, in June 1988, 98 per cent of other families with dependants were one-parent families. For definitions of these terms refer to the Glossary.
- 17 Estimates of the number of husbands and wives with dependants in June 1988, as published in selected tables in the June 1989 issue of this publication, are slightly higher than those published in the June 1988 issue. The estimates of the number of husbands and wives without dependants are correspondingly lower. This is due to a small error made at the computer processing stage of the production of family status estimates in the June 1988 issue of this publication.
- 18 For the July 1982 and previous surveys office imputation was undertaken to determine the family status of those persons enumerated in private dwellings where family information could not be obtained for all usual residents, and for those persons enumerated in non-private dwellings or as visitors to private dwellings where family information could not be obtained for each member of the family. Due to the increased demand for family data on a consistent and more regular basis, it was decided to change the processing methodology to eliminate office imputation and rely solely on the reported information. Consequently the scope of the July 1983 and subsequent surveys was narrowed to exclude those three groups of respondents for whom it is known that complete family information is difficult to collect (see paragraphs 7 and 8).
- **19** Surveys from July 1983 onwards are thus not strictly comparable with previous surveys since the persons excluded may have differing family and labour force characteristics to those persons included in the survey. Because

of these exclusions the total number of persons with particular family characteristics will also differ between surveys conducted prior to July 1983 and those conducted from July 1983 onwards. Table 1 shows the number of persons excluded from the survey.

- **20** In the July 1985 and previous surveys, dependants (then described as dependent children) comprised all family members under 15 years of age and all family members aged 15 to 20 who were full-time students, except those classified as husbands, wives or other family heads. The current definition is given in the Glossary. Tables 24, 25 and 31 of the June 1986 issue of this publication provide an indication of the differences between the student component of the old and new definitions.
- 21 Since the July 1985 survey was conducted, the definition of employed persons has been extended to include persons who worked without pay between 1 and 14 hours per week in a family business or on a farm (i.e. contributing family workers). This new definition aligns the Australian labour force concepts with a set of changed international definitions adopted by the International Labour Organisation at the 13th Conference of Labour Statisticians (ICLS) in October 1982.
- 22 Previously, such persons who worked 1 to 14 hours or who had such a job but were not at work were defined as either unemployed or not in the labour force, depending on whether they were actively looking for work. The changes in definition resulted in original (unadjusted) estimates of employment for March 1986 increasing by 34,900 and unemployment decreasing by 5,800.
- 23 Estimates of the number of families in June 1986 and subsequent years have been calculated differently to those for earlier years. This is due to the adoption of a new weighting procedure where the family weight is determined using an average of all family members responding to the Labour Force Survey. Previously, the family weight used to publish estimates of the number of families was determined by nomination of a proxy 'head of household' as representative of the family.
- 24 For these reasons, estimates for the June 1986 and subsequent surveys are not strictly comparable with those for earlier surveys. Although comparisons may generally be made, users should be aware of the above differences.
- 25 Since the estimates in this publication are based on information obtained from occupants of a sample of dwellings, they may differ from the figures that would have been produced if the information had been obtained from

occupants of all dwellings. More information is given in the Technical Notes.

#### **TECHNICAL NOTES**

ESTIMATION PROCEDURE

A new sample for the LFS was phased in over the period September to December 1992. For information about the sample design see *Information Paper: Labour Force Survey Sample Design* (6269.0).

Estimates of families and persons are derived from the population survey by use of a ratio estimation procedure, which ensures that estimates of persons conform to an independently estimated distribution of the population by age and sex, rather than to the age and sex distribution within the sample itself.

RELIABILITY OF THE ESTIMATES

Two types of error are possible in an estimate based on a sample survey: sampling error and non-sampling error. The sampling error is a measure of the variability that occurs by chance because a sample, rather than the entire population, is surveyed. Since the estimates in this publication are based on information obtained from occupants of a sample of dwellings, they, and the movements derived from them, are subject to sampling variability; that is, they may differ from the estimates that would have been produced if all dwellings had been included in the survey. One measure of the likely difference is given by the standard error, which indicates the extent to which an estimate might have varied by chance because only a sample of dwellings was included in the survey. There are about two chances in three that a sample estimate will differ by less than one standard error from the estimate that would have been obtained if all dwellings had been included in the survey, and about nineteen chances in twenty that the difference will be less than two standard errors. Another measure of sampling variability is the relative standard error which is obtained by expressing the standard error as a percentage of the estimate to which it refers. The relative standard error is a useful measure in that it provides an immediate indication of the percentage errors likely to have occurred due to sampling, and thus avoids the need to refer also to the size of the estimate.

Space does not allow for the separate presentation of the standard errors of all estimates in this publication. Standard errors of estimates should be determined by using Table A, if necessary in conjunction with the factors given on page 34 below.

The size of the standard error increases with the level of the estimate, so that the larger the estimate the larger is the standard error. However, it should be noted that the larger the sample estimate the smaller will be the standard error in percentage terms. Thus, larger sample estimates will be relatively more reliable than smaller estimates.


As the standard errors in Table A show, the smaller the estimate the higher is the relative standard error. Very small estimates are thus subject to such high relative standard errors (relative to the size of the estimate) as to detract seriously from their value for most reasonable uses. In the tables in this publication, only estimates with relative standard errors of 25 per cent or less, and percentages based on such estimates, are considered sufficiently reliable for most purposes. However, estimates and percentages with larger relative standard errors have been included and are preceded by an asterisk (e.g. \*3.4) to indicate they are subject to high standard errors and should be used with caution. See page 34 concerning the derivation of relative standard errors for some estimates.

The annual movement in the level of an estimate is also subject to sampling variability. The standard error of the movement depends on the levels of the estimates from which the movement is obtained rather than the size of the movement. Standard errors of all annual movements can be obtained by multiplying the figures in Table A by 1.3. When using Table A to calculate

standard errors of annual movements, refer to the larger of the two estimates from which the movement is derived.

An example of the calculation and use of standard errors is given below:

• From Table A it will be seen that the estimate of 570,600 one parent families with a female parent in June 1996 has a standard error of about 9,500. Therefore, there are about two chances in three that the number that would have been obtained if all dwellings had been included in the survey would have been within the range 561,100 to 580,100 and about nineteen chances in twenty that it would have been within the range 551,600 to 589,600.



The relative standard errors of estimates of average family size, average bours worked, average duration of unemployment and median duration of unemployment are obtained by first finding the relative standard error of the estimate of the total number of persons or families contributing to the estimate (see Table A) and then multiplying the figure so obtained by the following relevant factors:

- Average family size: 0.3
- Average hours worked: 0.7
- Average duration of unemployment: 1.3; and
- Median duration of unemployment: 2.0

The levels at which these and other labour force estimates have a relative standard error of 25 per cent are shown in Table B.

An example of the calculation of standard errors by the use of these factors is as follows:

In June 1996 the estimate of median duration of unemployment for husbands of couple families was 27 weeks and the number of families with the husband unemployed was estimated as 169,700. From Table A it can be calculated that this estimate has a standard error of about 5,800 and therefore a relative standard error of about 3.4 per cent. The relative standard error of the estimate of median duration of unemployment is calculated by multiplying this figure by the appropriate factor shown in the previous paragraph (in this case 2.0): 3.4 x 2.0 = 6.8 per cent. The standard error of this estimate of median duration of unemployment is therefore 6.8 per cent of 27, i.e. about 1.8. Therefore there are about two chances in three that the median duration of unemployment for unemployed husbands that would have been obtained if all dwellings had been included in the survey would have been within the range 25.2 to 28.8 weeks and about nineteen chances in twenty that it would have been within the range 23.4 to 30.6 weeks.

Proportions and percentages (for example, participation rates) formed from the ratio of two estimates are also subject to sampling error. The size of the error depends on the accuracy of both the numerator and denominator. The formula for the relative standard error (RSE) of a proportion or percentage is given below:

RSE 
$$(x/y) = \sqrt{[RSE (x)]^2 - [RSE (y)]^2}$$

Standard errors contained in Table A are designed to provide an average standard error applicable for all monthly Labour Force Survey estimates. Analysis of the standard errors applicable to particular survey estimates has shown that the standard errors of estimates of employment are generally equivalent to those shown in Table A, while standard errors of estimates of unemployment and not in the labour force are approximately 3 per cent and 11 per cent higher respectively. Standard errors of estimates of numbers of families are approximately the same as those for numbers of persons. Standard errors of estimates of persons born in Australia are approximately the same as those shown in Table A. For aggregate estimates of persons born outside Australia the standard errors are about 14 per cent higher. The standard errors vary for individual countries of birth, but are on average about 7 per cent higher.

The imprecision due to sampling variability, which is measured by the standard error, should not be confused with inaccuracies that may occur because of imperfections in reporting by respondents, errors made in collection such as in recording and coding data, and errors made in processing the data. Inaccuracies of this kind are referred to as the non-sampling error, and they may occur in any enumeration, whether it be a full count or a sample. Every effort is made to reduce the non-sampling error to a minimum by careful design of questionnaires, intensive training and supervision of interviewers and efficient operating procedures.

#### **GLOSSARY**

#### **Actively looking for work**

Includes writing, telephoning or applying in person to an employer for work; answering a newspaper advertisement for a job; checking factory or Commonwealth Employment Service noticeboards; being registered with the Commonwealth Employment Service; checking or registering with any other employment agency; advertising or tendering for work; and contacting friends or relatives.

#### Aggregate hours worked

The total number of hours a group of employed persons has actually worked during the reference week, not necessarily hours paid for.

#### Average hours worked

Aggregate hours worked by a group divided by the number of persons in that group.

#### Average duration of unemployment

For any group of unemployed persons, the aggregate duration of unemployment divided by the number of persons in the group.

#### Average family size

For any group of families, the total number of family members divided by the number of families in the group.

#### Couple families

Families in which there are two married persons and these persons are husband and wife. See *Marital status*.

#### Dependants

All family members under 15 years of age; family members aged 15 to 19 attending school or aged 15 to 24 attending a tertiary educational institution full time (except those classified as husbands, wives or lone parents).

#### Dependent student

In couple or one parent families, sons or daughters aged 15 to 19 attending school or aged 15 to 24 attending a tertiary educational institution full time (except those classified as husbands, wives or lone parents).

#### Duration of unemployment

The period from the time a person began looking for work or was stood down, to the end of the reference week. Thus the survey measures current (and continuing) periods of unemployment rather than completed spells. For persons who may have begun looking for work while still employed, the duration of unemployment is defined as the period from the time the person last worked full time for two weeks or more to the end of the reference week.

#### **Employed**

Persons aged 15 and over who, during the reference week:

- worked for one hour or more for pay, profit, commission or payment in kind in a job or business, or on a farm (comprising employees, employers and self-employed persons); or
- worked for one hour or more without pay in a family business or on a farm (i.e. contributing family workers); or
- were employees who had a job but were not at work and were: on paid leave; on leave without pay for less than four weeks up to the end of the reference week; stood down without pay because of bad weather or plant breakdown at their place of employment for less than four weeks up to the end of the reference week; on strike or locked out; on workers' compensation and expected to be returning to their job; or receiving wages or salary while undertaking full-time study; or
- were employers, self-employed persons or unpaid family helpers who had a
  job, business or farm, but were not at work.

#### Family

Two or more related persons (*relationship* includes relationships by blood, marriage or adoption) usually resident in the same household at the time of the survey. A family comprises a married couple or a family head as defined, together with any persons having any of the following relationships to them:

- sons or daughters of any age, if not married and with no children of their own present;
- other relatives if not accompanied by a spouse, sons or daughters, or parents of their own; or
- any children under 15 years of age who do not have a parent present.

#### Family head

Any person without a spouse present:

- with a son or daughter aged under 15 present; or
- persons without a spouse present, without a son or daughter aged under 15 present, but with a son or daughter aged 15 or over present (provided that the son or daughter has no spouse, son or daughter of his/her own present); or
- where a family has no person falling into either of these categories, the family head is generally defined to be the eldest person in the family.

No family head is determined for a couple family.

#### **Full-time workers**

Employed persons who usually worked 35 hours or more a week (in all jobs) and others who, although usually working less than 35 hours a week, worked 35 hours or more during the reference week.

#### Household

A group of one or more persons in a private dwelling who consider themselves to be separate from other persons (if any) in the dwelling, and who make regular provision to take meals separately from other persons, i.e. at different times or in different rooms. Lodgers who receive accommodation but not meals are treated as separate households. Boarders who receive both accommodation and meals are not treated as separate households. A household may consist of any number of families and non-family members.

#### Labour force

For any group, persons who were employed or unemployed, as defined.

#### Labour force status

A classification of the civilian population aged 15 and over into employed, unemployed or not in the labour force, as defined. The definitions conform closely to the international standard definitions adopted by the International Conferences of Labour Statisticians.

#### Lone parent

The head of a one parent family.

#### Lone person

A person who is the sole member of a household.

#### Main English-speaking countries

The United Kingdom, Ireland, Canada, the United States of America, New Zealand and South Africa.

#### Marital status

Persons are classified as married (husband and wife) if they are reported as being married (including de facto) and their spouse was a usual resident of the household at the time of the survey. The not-married category comprises persons who have never married, or are separated, widowed or divorced, as well as those who, although reported as being married, did not have a spouse who usually lived in the household.

#### Median duration of unemployment

The duration which divides unemployed persons into two equal groups, one comprising persons whose duration of unemployment is above the median and the other, persons whose duration is below it.

#### Non-dependent child

In couple or one parent families, sons or daughters aged 15 and over not attending school or a tertiary institution full time (except those classified as husbands, wives or lone parents).

#### Non-family member

A person who is not related to any other member of the household in which they are living.

#### Not in the labour force

Persons who were not in the categories employed or unemployed, as defined. They include persons who were keeping house (unpaid), retired, voluntarily inactive, permanently unable to work, persons in institutions (hospitals, gaols, sanatoriums, etc.), trainee teachers, members of contemplative religious orders, and persons whose only activity during the reference week was jury service or unpaid voluntary work for a charitable organisation.

#### One parent families

Families in which there is a family head together with at least one son or daughter of his/her own.

#### Other countries

All countries outside Australia other than the main English-speaking countries defined previously.

#### Other families

Families which are not couple families or one parent families, as defined. They include families in which there is no parent, for example a family head living with a brother or sister.

#### **Participation rate**

For any group, the labour force expressed as a percentage of the civilian population aged 15 and over in the same group.

#### Part-time workers

Employed persons who usually worked less than 35 hours a week and who did so during the reference week.

#### Unemployed

Persons aged 15 and over who were not employed during the reference week, and:


- had actively looked for full-time or part-time work at any time in the four weeks up to the end of the reference week and:
- were available for work in the reference week, or would have been available
  except for temporary illness (i.e. lasting for less than four weeks to the end of
  the reference week); or
- were waiting to start a new job within four weeks from the end of the reference week and would have started in the reference week if the job had been available then; or
- were waiting to be called back to a full-time or part-time job from which they
  had been stood down without pay for less than four weeks up to the end of
  the reference week (including the whole of the reference week) for reasons
  other than bad weather or plant breakdown.

## Unemployed looking for full-time work

Unemployed persons who actively looked for full-time work or were to resume a full-time job, from which they had been stood down.

#### **Unemployment rate**

For any group, the number of unemployed persons expressed as a percentage of the labour force in the same group.
