Motor Vehicle Registrations Western Australia April 1994

MAIN FEATURES

New motor vehicle registrations (excluding motor cycles) for April 1994 totalled 4,427, a decrease of 24.8 per cent compared with March 1994 (5,887). In seasonally adjusted terms, registrations fell by 6.4 per cent during this period. The trend estimate has declined by 1.9 per cent since January 1994.


Compared with April 1993 seasonally adjusted and trend estimate registrations have risen by 1.6 per cent and 4.7 per cent respectively, although registrations fell slightly by 0.9 per cent in original terms.


Passenger vehicle and light commercial vehicle registrations both fell in original terms by 25.8 per cent compared with March 1994. Of the other vehicle types, only articulated trucks showed an increase over this period.

Ford was the leading make in passenger vehicles in April 1994 with 750 registrations (22.6 per cent), followed by Holden with 694 registrations (20.9 per cent) and Toyota with 502 registrations (15.1 per cent).

Toyota dominated the light commercial market with 252 registrations (32.6 per cent) with Ford in second place with 174 registrations (22.5 per cent) followed by Holden with 127 registrations (16.4 per cent).

The Ford Falcon/Fairmont was the leading passenger vehicle model with 14.4 per cent of the market, followed closely by the Holden Commodore/Calais with 14.0 per cent. Next were the Mitsubishi Magna (6.5 per cent), the Hyundai Excel (4.8 per cent) and the Toyota Camry (4.5 per cent).

EXPLANATORY NOTES

Introduction

This publication contains detailed information regarding registrations of new motor vehicles, motor cycles, plant and equipment, caravans and trailers. Details of the number of motor vehicles on register are also included.

- The statistics in this publication are based, from July 1991 onwards, on new processing procedures using the new Vehicle Identification Number (VIN) introduced by motor vehicle registration authorities from July 1990. The VIN system allows more accurate identification and classification of newly registered vehicles. As a result, data processed on this system are not strictly comparable with those processed on the old system.
- Both the old and new series have been compiled for the period between December 1990 and July 1991. Detailed statistics on both bases are available on request.

Scope and coverage

- Vehicle licensing in Western Australia is the responsibility of the Police Department and a number of local government authorities performing licensing functions or acting as collection agents on behalf of the Department.
- The statistics in this bulletin have been prepared from data made available by licensing authorities and reflect information as recorded in registration documents. Delays in the receipt of some registrations data have meant that new motor vehicle registration statistics for a particular month include vehicles registered prior to that month.
- Registrations of new motor vehicles relate to factory-new vehicles registered for the first time.
- The statistics include vehicles with diplomatic and consular plates and State and Commonwealth Government owned vehicles other than those belonging to the defence services.
- The statistics exclude any vehicles which will not be used on public roads such as tractors (particularly the agricultural type), plant and equipment and motor vehicles used solely on farms, in mines or in National Parks, etc. as well as recreational vehicles such as trail bikes or sand dune buggies.

Vehicle Identification Number (VIN)
9. The Vehicle Identification Number (VIN) uniquely identifies each vehicle. Embedded within this number are details of make and model together with other relevant information concerning the vehicle. The VIN is now collected by the Police Department at the time each new vehicle is registered. The VIN is passed on to the Australian Bureau of Statistics (ABS) as part of the New Motor Vehicles Registrations record.

Vehicle classification

10. The decoding of the VIN has resulted in better identification of each vehicle's body type and consequently classification of vehicles to particular categories.

11. Small passenger carrying vans such as microbuses are now consistently classified as passenger vehicles. Under the old system, these could have been classified as cars, station wagons or buses. Cab-chassis vehicles, which were previously classified to small trucks, are now consistently classified to light commercial vehicles. In addition, tractors are no longer classified separately. They are now included in the plant and equipment category.

Vehicle type definitions

- 12. Passenger Vehicles. Vehicles constructed primarily for the carriage of less than 10 passengers (including the driver). Included are cars, station wagons, 4WD passenger vehicles and forward control passenger vehicles.
- 13. Light Commercial Vehicles. Vehicles constructed primarily for the carriage of goods and do not exceed 3.5 tonnes gross vehicle mass (GVM). Included are utilities, panel vans, cab-chassis and forward control vehicles (whether 4WD or not).
- 14. Rigid Trucks. Vehicles constructed primarily for load carrying with a gross vehicle mass (GVM) exceeding 3.5 tonnes. Included are normal rigid trucks with a tow bar, draw bar or other non-articulated coupling on the rear for use with a trailer or dolly.
- 15. Articulated Trucks. Vehicles constructed primarily for load carrying consisting of a prime mover having no significant load carrying area but with a turn table device which can be linked to a trailer. With or without a trailer the gross combination mass (GCM) will exceed 3.5 tonnes.
- 16. Non-freight Carrying Trucks. Includes specialist vehicles such as ambulances or mobile cranes or vehicles fitted with special purpose equipment and having no goods carrying capacity.
- 17. Omnibuses. Includes all passenger vehicles having more than nine seats, including the driver.

Seasonal adjustment and trend estimation

- 18. Original, seasonally adjusted and trend estimate series for registrations of new motor vehicles are shown in Table 2. The two component series 'Passenger vehicles' and 'Other vehicles' are each adjusted separately and then summed to derive total seasonally adjusted and trend registrations. In the seasonally adjusted series, account has been taken of normal seasonal factors and 'trading day' effects (arising from the varying numbers of Sundays, Mondays, Tuesdays, etc. in the month) and the effect of movement in the date of Easter which may, in successive years, affect figures for different months.
- 19. Seasonally adjusted statistics should not be regarded as in any way definitive. In interpreting particular seasonally adjusted statistics it is important to bear in mind the methods by which they have been derived and the limitations to which the methods used are subject.
- 20. Seasonal adjustment is a means of removing the estimated effects of normal seasonal variation from the series so that the effects of other influences on the series may be more clearly recognised. Seasonal adjustment procedures do not aim to remove the irregular or

non-seasonal influences which may be present in any particular months, such as the effect of introducing new models or of industrial disputes. Irregular influences that are highly volatile can make it difficult to interpret the movement of the series even after adjustment for seasonal variation.

- 21. The seasonally adjusted series can, however, be smoothed to reduce the impact of the irregular component in the adjusted series. This smoothed seasonally adjusted series is called a trend estimate. The trend estimates of motor vehicle registration statistics are shown in Table 2 and have been derived by applying a 13-term Henderson-weighted moving average to the seasonally adjusted series.
- 22. While the technique enables trend estimates for the latest period to be produced, it does result in revisions to the trend estimate for the most recent months as additional observations become available. There may also be revisions as a result of changes in the original data, and as a result of the re-estimation of the seasonal factors.
- 23. Users may wish to refer to the ABS Information Papers, A Guide to Interpreting Time Series - Monitoring 'Trends' - An Overview (1348.0), A Guide to Smoothing Time Series - Estimates of 'Trend' (1316.0) and Time Series Decomposition - An Overview (1317.0) for more detailed information on smoothing of seasonally adjusted time series data.

Vehicles on register

24. The number of vehicles on register at a given date are those for which fees were paid up for a period which includes the reference date.

Unpublished data and related publications

- 25. The ABS may also make available on request certain unpublished motor vehicle registrations data. This data includes make and small area breakdowns of vehicles on register figures. A charge may be made for providing unpublished information.
