INTRODUCTION

This publication presents Australia's merchandise imports for 1 digit sections of the United Nations Standard International Trade Classification. The data are compiled from information submitted by importers or their agents to the Australian Customs Service.

MAY IMPORTS

The total value of imports includes about \$1.3 billion of imports that arrived in Australia in April. This is a higher than normal level of delayed lodgements, which have averaged about \$0.7 billion over the past year. This is mainly due to the combined influences of Easter, ANZAC Day and school holidays late in April.
