CHANGES TO SCOPE AND COVERAGE

There were no changes to scope and coverage this issue.

CHANGES THIS ISSUE

Revisions

As a result of the review process, data entry errors were identified in a number of the daily currency series. Some of these errors have been corrected and as a consequence there have been changes to the monthly average exchange rates series. The remaining errors will be corrected over the next month as the back series data becomes available and there will be further revisions to the exchange rates from 1994 to 1999 as a result.

Revisions to current dataset

China: There were a large number of periods which were recorded as having an exchange rate of 0.0000 instead of NA. These have been corrected

Papua New Guinea: Selling rate: There were a number of days where no exchange rate was recorded where in fact there should have been a value. These exchange rates have been input and the selling rate average recalculated.

Austria: Buying and Selling rates for May 2000 and October 2000

Canada: Buying/Selling rate for August 2000

Denmark: Buying and Selling rates for August 2000, Selling rate for September 2000

Fiji: Selling rate for January 2000 and September 2000

Finland: Selling rate for November 1999

Hong Kong: Buying and Selling rates for August 2000

India: Buying/Selling rate for September 2000

Indonesia: Selling rate for September 2000

Malta: Buying and Selling rate for August 2000

New Caledonia: Buying/Selling rate for August 2000

Singapore: Buying rate for March 2000, April 2000 and September 2000

Spain: Buying rate for June 2000, Selling rate for July 2000

South Africa: Buying/Selling rate for September 2000

UK: Selling rate for August 2000

DATA AVAILABILITY

From July 1998 time series data has been delivered to clients from the ABSDB via AUSSTATS and Time Series Deliver, previously these files were delivered from INFOS. The change in source has resulted in changes to the available date range for some series.

Time series are available back to January 1966 for some exchange rates. We can produce on request calender and financial year average exchange rate reports.
