MAIN FEATURES

Note: Survey estimates are subject to sampling variability, as explained in paragraph 8 below.

In May 1980 there were an estimated 2,559,500 non-institutionalised civilians aged 50 to 69 years. Of these:

1,371,000 (53.6 per cent) had permanently ceased full-time work.

950,600 intended to retire from full-time work at some time in the future. Of these, 493,600 (51.9 per cent) expected their main source of income to be a government pension and 182,600 (19.2 per cent) expected superannuation to be the main source.

78,200 claimed that they intended never to retire from full-time work.

159,800 had never worked in a full-time job.

EXPLANATORY NOTES

Introduction

In May 1980 a survey, based on the monthly population survey, was conducted throughout Australia in order to obtain information about persons aged 50 to 69 years who had permanently ceased full-time work and about the retirement intentions of other persons in this age group. Data collected included the age, or expected age, at retirement; superannuation or life insurance coverage and payments derived from these sources; housing arrangements; and main source of income after retirement.

- 2. This publication contains only a summary of the more important results of the survey. More detailed estimates, which will be published as soon as possible, are available on request. The estimates shown are preliminary and are subject to revision.
- 3. The survey was based on a multi-stage area sample of private dwellings (about 30,000 houses, flats, etc.) and non-private dwellings (hotels, motels, etc.) and covered about two-thirds of one per cent of the population of Australia. The information was obtained

from the occupants of selected dwellings by carefully chosen and specially trained interviewers; the interviews being conducted during the two weeks beginning on Monday, 12 May 1980.

Scope

- 4. The survey included all persons aged 50 to 69 years except:
 - (a) members of the permanent defence forces
 - (b) certain diplomatic personnel of overseas governments, customarily excluded from census and estimated populations
 - (c) overseas visitors holidaying in Australia
 - (d) members of non-Australian defence forces (and their dependants) stationed in Australia
 - (e) some patients in hospitals and sanatoria, inmates of gaols, reformatories, etc. and persons reported as permanently unable to work.

Definitions

5. The labour force category to which a person is assigned depends on his actual activity (i.e. whether working, looking for work, etc.) during a specified week known as the survey week, which is the week immediately preceding that in which the interview takes place. Definitions of the principal labour force categories appearing in this publication are given in The Labour Force, Australia (6203.0).

Interpretation of results

- 6. Because of the limited age range of respondents for whom information was obtained, care should be taken when interpreting data relating to persons who had permanently ceased full-time work (see Table 2).
- 7. To avoid problems of recall, information relating to circumstances at the time of ceasing full-time work was obtained only in respect of persons aged 50-69 years who had ceased full-time work in the previous 20 years.

Reliability of the estimates

8. Since the estimates in this publication are based on information obtained from occupants of a sample of

dwellings they are subject to sampling variability; that is they may differ from the figures that would have been produced if all dwellings had been included in the survey. One measure of the likely difference is given by the standard error. There are about two chances in three that a sample estimate will differ by less than one standard error from the figure that would have been obtained if all dwellings had been included, and about nineteen chances in twenty that the difference will be less than two standard errors. A table of estimated standard errors for this survey is shown below. Estimates with a standard error of more than about 22 per cent have not been shown in this publication, as the degree of sampling variability would seriously detract from their value for most reasonable uses. Although figures for these small components can, in some cases, be derived by subtraction they should not be regarded as reliable.
