

INTERNAL MIGRATION, 1972-73 (PRELIMINARY STATEMENT)

EXPLANATORY NOTES

In May 1973 a survey was conducted in conjunction with the quarterly population survey in order to obtain information about the movement of persons within Australia during the period 1 May 1972 to 30 April 1973. A similar survey was conducted in May 1972. Persons were classified as having moved if the address of their usual place of residence on 30 April 1973 was different from that on 1 May 1972 and both places were in Australia. No information was obtained about the number of different changes made between these dates. Persons who were usually resident at the same address on both dates, but who had moved away and had returned during this period were regarded, for the purposes of the survey, as not having moved.

2. The estimates in this bulletin are based on 1971 population census results. Estimates in the 1971-72 statement were based on 1966 population census results.

3. The sample used in the survey covered the six States, the Northern Territory and the Australian Capital Territory. About 27,000 households were enumerated, the information being obtained by personal interviews during a four-week period.

The estimates relate to all persons aged 15 years and over, except members of the permanent armed forces, national servicemen enlisted in the Regular Army Supplement and certain diplomatic personnel customarily excluded from censuses and population estimates. Patients in hospitals and sanatoria, and inmates of gaols, reformatories, etc., for whom, for the purposes of the survey, the institution was regarded as their dwelling, were excluded from the survey.

5. Since the estimates in this statement are based on a sample, they may differ from the figures that would have been obtained from a complete census using the same questionnaires and procedures. One measure of the likely difference is given by the standard error, which indicates the extent to which an estimate might have varied by chance because only a sample, and not the whole population, was enumerated. Estimates less than 4,000 have not been shown as they would be subject to such high standard errors (relative to the size of the estimate) as to detract seriously from their value for most reasonable uses. Although in some cases figures for these small components can be derived by subtraction, they should not be regarded as reliable. More information on this topic, together with a table of standard errors, is given in the May 1973 issue of the mimeographed bulletin *The Labour Force* (Reference No. 6.20).

6. This statement contains only a summary of the more important results of the survey. More detailed estimates will be published in a bulletin to be issued as soon as possible. The estimates shown are preliminary and are subject to revision.

SUMMARY OF RESULTS

7. The survey indicated that there were 9,063,600 persons aged 15 years and over in Australia at 30 April 1973 who had been resident in Australia at 1 May 1972. For more than one in every six (17.5 per cent) of these persons their usual residence was at a different address at the two dates, the number of persons who moved being 1,584,200. (This was an increase of 13.7 per cent since the previous year, when 1,393,100 persons, or 15.6 per cent of the population aged 15 years and over, moved.) For males the proportion of persons who moved was 17.8 per cent and for females 17.2 per cent. The great majority of the moves (89.2 per cent: 1,413,900 persons) were within the same State or Territory, and more than half (51.5 per cent: 815,300 persons) were moves within a capital city area.

8. In the six State capital city areas, 17.1 per cent of persons covered by the survey had changed their usual residence in the previous twelve months; the corresponding percentage for persons outside the State capitals was 18.1.

Movement into capital city areas, estimated at 176,800, came from other areas of the same State (81,300), from capital city areas of other States (58,000) and from other areas of other States or from the Territories (37,500). Movement out of capital city areas, estimated at 186,800, consisted of 93,200 to other areas of the same State, 58,000 to capital city areas of other States, and 35,600 to other areas of other States or to the Territories. Net movement away from the six State capital city areas was therefore estimated at 10,000.

10. Interstate movements were estimated to be: to New South Wales 38,000, to Victoria 39,600, to Queensland 38,600, to South Australia 14,400, to Western Australia 14,700, and to Tasmania 5,800; and from New South Wales 55,500, from Victoria 32,800, from Queensland 28,200, from South Australia 17,300, from Western Australia 16,000, and from Tasmania 4,700. The result of these movements were significant net inward movements to Victoria (6,900) and to Queensland (10,400) and a significant net outward movement from New South Wales (17,500). Other net State gains or losses were small and in view of the sampling variability to be expected in them they have not been separately estimated.

NOTE. Any discrepancies between totals and sums of components in tables are due to rounding.
