



AUSTRALIAN MARRIAGE LAW POSTAL SURVEY INFORMATION FOR ABORIGINAL AND TORRES STRAIT ISLANDER PEOPLES

The Australian Bureau of Statistics (ABS) is surveying Australians on the Commonwealth Electoral Roll who are eligible to vote as at 24 August 2017, to get their views about whether the law should be changed to allow same-sex couples to marry.

This is a voluntary survey. However the ABS would like every eligible Australian to have an opportunity to participate and have their say. While it is expected that most people in Australia will be able to participate using the postal service, the ABS will implement a number of additional strategies to ensure that Aboriginal and Torres Strait Islander peoples have the opportunity to participate in the survey. These options are described further below.

1. Completing the form

Survey forms will be delivered to Australian nominated addresses by 25 September. The package containing the survey form will include a reply paid envelope and instructions on how to complete the form. Completed forms need to be received by the ABS by the 7 November deadline, allowing a reasonable period for completing and posting back the paper form.

2. Authorising a trusted person to respond on their behalf

If a person cannot complete their survey form independently, they can authorise another person they trust to assist them with their survey, or to complete the survey form on their behalf.

Where someone completes a survey on someone else's behalf, the ABS expects that the eligible Australian would:

- Specifically authorise that trusted person to open their postal survey envelope; and
- Communicate their survey response to that trusted person so this can be accurately marked on the survey form.

The trusted person would then seal the form in the reply paid envelope and post it back to the ABS.

A person cannot self-declare themselves to be a trusted person for someone else. It is illegal to open someone else's mail without their permission, and there are potential penalties for providing false or misleading information to the ABS.

3. Paperless response

In limited circumstances, a person will be able to respond to the survey through a paperless method, for example by using the telephone.

From 25 September to 20 October, Australians overseas will be able to obtain a secure access code via the Australian Marriage Law Postal Survey online enquiry form on the ABS website

(www.abs.gov.au) or by calling the Information Line - +61 2 6252 5262. A letter including the secure access code will be sent to the person, which is then used to provide an anonymous survey response through an automated telephony service, a secure online form or via a call centre.

4. Lost or spoilt forms

Lost or spoilt survey forms can be replaced. Requests must be made by the eligible Australian themselves or a legally authorised person (i.e. a person with power of attorney, authorised carer for person with severe disability etc.).

All responses to the survey are kept completely confidential, by law. The ABS will destroy all information collected after the survey.

People who choose not to complete the form are encouraged to destroy it by tearing it into two or more parts.

5. Remote communities

For people living in remote areas:

- Forms will be dispatched by priority post with priority return mail envelopes, and where household delivery is not possible the mail will be held at the closest mail agent where it can be collected;
- Forms will be available for pick up from a number of regional and remote locations during the collection period where people can both collect and return a form;
- From locations with phone or internet connectivity, people can provide a survey response without a paper form from 25 September to 20 October 2017.

Further information of the pick up locations will be published on the ABS website and communicated to local communities.

Pick up locations will be staffed with ABS officers with experience in supporting collection of information in remote communities.

More information

All responses to the survey are kept completely confidential, by law. The ABS will destroy all information collected after the survey.

The results of the survey will be published on the ABS website by 15 November.
