Following on from our conversation today regarding the receiving of registered mail of Marriage Law Survey responses.

I have confirmed from Australia Post (verbally) that any mail that someone attempts to send

back to the Data Capture centre in their state will be undeliverable. Australia Post have confirmed that over the counter sales wont accept a registered mail envelope that has a return address to a locked bag. i.e all our BRE reply paid addresses. So they should not be able to send them to us.

If they happen to have registered mail envelope at home that they want to use (i.e dont go into a post office to post) and these do get through, they will be sent back to the sender as their is none there to sign for a registered mail at each of the data processing centres.

I will make sure this one is listed on the decision register.

While it is possible to send registered mail to a reply paid address, it is not possible to get a confirmation of delivery with this volume of mail. If it was a one off delivery to a reply paid address it may result in a confirmation receipt being returned.

The Australia Post office selling the registered mail service should have clearly advised the customer they would not get a confirmation receipt given the volumes of mail.

You are correct - there is no method of confirming a survey form is received due to the anonymous nature of the processing.
