Hi Vanessa

As discussed on the telephone our total data on Autism for age 0 to 6 has an Relative Standard Error of 36.1 and is of limited value with the Australian Bureau of Statistics recommending that estimates with an RSE of 25% or greater should be used with caution.

Administrative data is data collected by organisations about their clients in there day to day business. These organisations include government departments such as Centrelink, hospitals, welfare service providers (aged care, disability services, family services), and schools. Vanessa, Graeme Thompson forwarded your query about data on autism to me.

Some self-report data on autism is collected in our National Health Survey (NHS) and Survey of Disability, Ageing & Carers (SDAC). However, administrative data are a better source of information about such conditions than sample surveys.

Autism cannot be identified separately within the NHS output categories, and the number of respondents in the group of conditions where autism is classified is very small (with an associated

high level of sampling error making the data not suitable for use in any case).

The SDAC collects whether persons identified as having a disability have specific health conditions. The long term health conditions include 'Autism and related disorders' (including Rett's syndrome and Aspergers syndrome). The sample size for this category is very small, but it does appear that an estimate of the number of children aged 0-14 years with a disability and this condition is likely to be useable. However, it would be unlikely to be possible to cross classify this information any further to explore the characteristics of these children.

I am not aware of any data mapping done which specifically relates to this condition.
